Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of DIRECTV Retirement Savings Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

General—The following description of the DIRECTV Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

The Plan was established on August 1, 2021 and is a defined contribution plan covering substantially all employees of DIRECTV, LLC and DIRECTV Customer Services LLC, the participating employer subsidiaries of DIRECTV Entertainment Holdings LLC (collectively, the “Company”).

The investments of the Plan and the DIRECTV Retirement Savings Plan – Puerto Rico are maintained in the DIRECTV Savings Plan Master Trust (the “Master Trust”). The Plan’s trustee is Bank of New York Mellon (“BNY Mellon”) and the recordkeeper is Fidelity Workplace Services LLC (“Fidelity”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions—Contributions to the Plan include (i) salary reduction contributions authorized by participants, (ii) matching contributions made by the Company, (iii) discretionary contributions made by the Company; and (iv) participant rollovers from another qualified plan. Participants have the option to make Roth elective salary reduction contributions to the Plan.

Participants may contribute to the Plan through a reduction in salary on a pretax or after-tax basis, or Roth deferrals from 1% to 50% of total eligible compensation. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Effective the first day of the pay period following 60 days after they first become a participant, automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions; these additional contributions are ineligible for a Company matching contribution.

The Company makes a matching contribution to eligible participant accounts. The matching contribution for management employees is equal to 133 1/3% of the first 3% of the employee’s compensation the employee elected to defer as a basic contribution (“Deferral”), plus 100% of the next 3% of their Deferrals, not to exceed 7% of compensation. The matching contribution for participants of CWA District 3 is 100% of the first 6% of their Deferrals, and all other collectively bargained employees receive 80% of the first 6% of their Deferrals. The Company may also, at its sole discretion, contribute an additional non-elective contribution. There were no non-elective contributions during 2024 or 2023.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Participant Accounts—Individual accounts are maintained for each participant of the Plan. Each participant’s account is credited with the participant’s contribution and related non-elective and

matching Company contributions and Plan earnings. Participant accounts are also charged with withdrawals and an allocation of Plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments—Participants direct the investment of their contributions and any Company contributions into the various funds offered by the Plan. The Plan offers a mutual fund and common collective trust funds through the Master Trust. Participants may also direct their investments through a trustee sponsored brokerage account (SDB), which offers the option to invest in a variety of certificates of deposit, a money market fund, common and preferred stocks, exchange-traded funds, mutual funds, warrants, and government bonds.

Vesting—Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service. For vesting purposes, participants who entered employment under one of two transactions with AT&T retained their service hours: 1) those who transferred as part of the spin-off on August 1, 2021 and 2) those who transferred as part of a second transaction on April 1, 2022.

Notes Receivable from Participants—Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of one-half of the vested account balance or \$50,000. The loans are secured by an assignment of a participant's vested interest in the Plan, and bear interest as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. Loan terms range from 1 to 5 years; however, terms may exceed 5 years for the purchase of a primary residence. As of December 31, 2024 and 2023, participant loans have maturities through 2034 at interest rates ranging from 4.25% to 9.50%.

Payment of Benefits—On termination of service with the Company (including termination of service due to death, disability, or retirement), a participant may generally elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or installments over a fixed time period.

Participants may also be eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships.

Forfeited Accounts—When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. The plan document permits the use of forfeitures to either reduce future Company contributions or pay plan administrative expenses for the plan year. However, if a participant is re-employed and fulfills certain requirements, as defined in the plan document, the account will be reinstated. At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$158,000 and \$19,000, respectively. During 2024 approximately \$61,000 was used to pay administrative expenses and approximately \$832,000 was used to reduce Company matching contributions from forfeited nonvested accounts.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates—The preparation of the financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities,

and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Risks and Uncertainties—The Plan provides various investment options to participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the value of the participants' account balances, and the amounts reported in the financial statements.

Investment Valuation and Income Recognition—Investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a description of the fair value methodology by investment type.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the plan document.

Contributions – Employee contributions and Company non-elective and matching contributions are recorded when withheld and when earned, respectively.

Administrative Expenses—Administrative expenses of the Plan are paid by the Plan or the Company, as provided in the plan document. Participants pay administrative costs for loans, distributions and qualified domestic relation orders.

All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, investment management fees and operating expenses are reflected as a reduction of investment return for such investments.

The Plan receives float interest income on short-term investment accounts temporarily held before they are invested and/or paid out. Float interest income can be used to pay Plan administrative expenses. As of December 31, 2024 and 2023, the Plan held float interest income of approximately \$67,000 and \$28,000, respectively.

Payments of Benefits—Benefit payments to participants are recorded upon distribution. There were no participants, who have elected to withdraw from the Plan, but have not yet been paid as of December 31, 2024 or 2023.

Subsequent Events—Subsequent events were evaluated through October 6, 2025, the date the financial statements were available to be issued. During 2025, the Plan implemented certain provisions of the Securing a Strong Retirement Act of 2022 ("SECURE 2.0"). These changes were made immediately without formally amending the plan document. The Plan will be formally amended as required under SECURE 2.0. In addition, effective May 7, 2025, the Plan changed its trustee from BNY

Mellon to Fidelity Management Trust Company. No other events occurred that require additional disclosure or adjustments to the Plan's financial statements.

3. INTEREST IN MASTER TRUST

Certain of the Plan's investment assets are held in the Master Trust administered and maintained by BNY Mellon as established by the Company. The Plan maintains a divided beneficial interest in each of the investment accounts held by the Master Trust. Use of the Master Trust permits the commingling of the trust assets of the Plan and the DIRECTV Retirement Savings Plan—Puerto Rico for investment and administrative purposes.

Each participating plan's interest in the investment fund options of the Master Trust is based on account balances of the participants and their elected investment fund options. The Master Trust assets are allocated among the participating plans by assigning to each plan those transactions (primarily contributions, benefit payments, and expenses) that can be specifically identified, and by allocating investment income and administrative expenses related to the Master Trust on a daily basis based on each participant's account balance within each investment fund option.

5. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurement and Disclosures*, provides a framework for measuring fair value. In accordance with ASC 820, the Plan classifies its investments into Level 1, which refers to securities valued using quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Investments are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Asset Valuation Techniques—Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds—Valued at the daily closing price as reported by the fund. The mutual funds held by the Master Trust are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan or Master Trust are deemed to be actively traded.

Common Collective Trust Funds—Valued at the NAV of units of a collective trust. The NAV as provided by the trustee is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

Self-Directed Brokerage Accounts—includes a variety of certificates of deposit, a money market fund, common and preferred stocks, exchange traded funds, government bonds, warrants, and mutual funds. Certificates of deposit are held primarily in short-term money market commingled funds and are valued at amortized cost plus accrued interest. The money market fund, common and preferred stocks, exchange-traded funds, and warrants are valued at the closing price reported on the active market on which the individual securities are traded. Government bonds are valued using pricing models maximizing the use of observable inputs for similar securities.

6. RELATED-PARTY TRANSACTIONS AND EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Fidelity is the recordkeeper, Fidelity Management Trust Company is the custodian of the SDB and notes receivable from participants, and BNY Mellon is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid for investment management services were included as a reduction of the return earned on each fund. The Plan also issues loans to participants, which are secured by the vested balances in the participants' accounts. As of December 31, 2024 and 2023, through the SDB feature, the Plan held Fidelity investments totaling approximately \$3,200,000 and \$1,900,000, respectively.

7. FEDERAL INCOME TAX STATUS

By a letter dated May 9, 2024, the Internal Revenue Service (IRS) determined and informed the Company that the Plan and related trust and Master Trust were designed in accordance with the applicable regulations of the IRC. The Plan has been amended since receiving the determination letter. However, Plan management believes that the Plan and related trust and Master Trust are designed and administered in accordance with the applicable regulations of the IRC, and therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. NONEXEMPT TRANSACTION

The Company determined that payments of \$3,283 were made by the Plan during 2023 that did not meet the definition of an eligible Plan expense as stated in the plan document. During 2024, the Company reimbursed the Plan for these amounts plus lost earnings. The Company filed Form 5330 with the IRS and paid the required excise tax on the transactions.

9. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated by the Company, participant accounts would become fully vested. The assets of the Plan would be distributed to the participants based on their account balances. In addition, any previously forfeited amounts that had not been applied to reduce Company contributions or pay administrative expenses, would be credited ratably to the accounts of the participants remaining in the Plan at the time of such termination.
