## Independent Auditors' Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Johanna Foods, Inc., Lacto Division Savings and Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits - Modified Cash Basis as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Benefits - Modified Cash Basis for the year ended December 31, 2024, and the related Notes to the Financial Statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Johanna Foods, Inc., Lacto Division Savings and Investment Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Johanna Foods, Inc., Lacto Division Savings and Investment Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. ### Basis of Accounting

Our opinion is not modified with respect to this matter.

### Responsibilities of Management for the Financial Statements

The Plan is a defined contribution plan covering all employees of Johanna Foods, Inc. (the Company) whose employment is governed by a collective bargaining agreement between Local 152 of the United Food and Commercial Workers and the Lacto Division of Johanna Foods, Inc. Employees are eligible to participate in the Plan on the first entry date, January 1<sup>st</sup> or July 1<sup>st</sup>, following one year of employment. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Company makes quarterly contributions to the Plan. The contribution is based on the actual hours worked by the employee.

Under the Collective Bargaining Agreement for the term February 26, 2017 through February 26, 2023, for employees hired before February 25, 2011, the maximum quarterly contribution is \$350.

For employees hired after February 25, 2011, but before February 25, 2017, effective February 26, 2018, the maximum quarterly contribution is also \$350, and without a need for the employee to contribute to the Plan.

For employees hired after May 23, 2017, effective February 26, 2018, the employer will match up to \$300 per quarter after one year of service, with a need for the employee to contribute. The employer will contribute up to \$350 per quarter after 5 years of service, without a need for the employee to contribute to the Plan.

Under the Collective Bargaining Agreement for the term February 26, 2023 through February 25, 2029, effective February 26, 2024, employees with one to five years of service and who have been employed at least twelve months, will receive an employer contribution of \$450 per calendar quarter without a need for the employee to contribute to the Plan.

For employees with more than five years of service, the employer will contribute \$750 per employee per calendar quarter without a need for the employee to contribute to the Plan.

The quarterly employer contribution will be prorated based on the basis of 520 hours of straight time per quarter.

Contributions (continued)

In the event of termination for reasons other than death, disability or normal retirement, balances in participant accounts are payable in a lump-sum.

Participant accounts

Each participant's account is self-directed and credited with the participant's and Company's contributions and earnings on investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant loans

Participants may borrow from their accounts within limits prescribed by the Plan and the Internal Revenue Service.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants are credited with a year of service if they complete 1,000 hours of service in any Plan year.

A participant is vested as follows:

A participant is 100% vested upon attaining normal retirement age.

Investment options

Upon enrollment in the Plan, a participant may direct the investment of their contributions in a variety of investments. Participants may change their investments daily.

Forfeited accounts

Forfeited non-vested accounts will be used to reduce future employer contributions. As of December 31, 2024 and 2023, the forfeited accounts totaled \$14,832 and \$14,859, respectively.

Note 2 - Summary of significant accounting policies

Basis of accounting

The financial statements and supplemental schedule of the Plan are presented on the modified cash basis of accounting. Under this method, contributions, interest and dividend income are recorded when received. Benefits and expenses are recorded when paid. The Plan's investments are stated at fair value, contract value, or net asset value. Purchases and sales of securities are recorded on a trade-date basis.

Use of estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

The Plan's mutual funds are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the cash basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Mutual fund fees

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. The 12b-1 fees, which are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940, are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity and thus not separately identifiable as an expense.

Unit Investment Trusts

The Plan is invested in Unit Investment Trusts. These assets may be redeemed on demand and there may be additional fees associated with the redemption. These assets are measured at net asset value (NAV). This is a valuation determined by the Trust Administrator. The risk exists that units of these trusts could be sold at a value different than the NAV.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Fees for the administration and maintenance of a participant account balances are included in administrative expenses and charged directly to the participant's account. Investment related expenses are included in net appreciation of fair value of investments.

Note 4 - Fair value

Financial Accounting Standards Board (FASB) in its Accountant's Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 inputs must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Investment contract held with insurance company

The Plan entered into an annuity investment contract with Principal Life Insurance Company (Principal Life). Principal Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contract meets the fully benefit-responsive investment criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value. The Plan Administrator believes the occurrence of such events that would also limit the Plan's ability to transact at contract value for the general account with the Plan participants, is not probable.

The contract value of the investment contract at December 31, 2024 and 2023 were \$2,574,682 and \$2,649,404, respectively. On December 31, 2024 and 2023, the average yield and crediting interest rate for the annuity contract was approximately 4.75% and 4.65%, respectively. The crediting interest rate is based on the earnings of the underlying assets compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly.

Note 6 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7 - Risks and uncertainties

The Plan provides for various investment options in registered investment companies. Investment securities are exposed to various risks, such as interest rate, market and credit.

Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near-term would materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

Note 8 - Party-in-interest and related party transactions

Certain Plan investments are shares of Mutual funds and Pooled Common/Collective funds managed by Principal Trust Company, the Trustee, and therefore, these transactions qualify as party-in-interest transactions. Investment advisor fees are deducted from fund earnings prior to the allocation of investment returns. Administrative fees paid during the year ended December 31, 2024 were \$22,756.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Company pays for the annual audit fee. These transactions are considered to be related party transactions exempt from the ERISA prohibited transactions.

Note 9 - Tax status

The Internal Revenue Service has determined and informed the Company by a letter dated April 21, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC as of the financial statement date.
