## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Lift Solutions, Inc. 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

#### NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Lift Solutions, Inc. 401(k) Profit Sharing Plan and Trust (Plan) provides only general information. Participants should refer to the Plan Agreement for a complete description of the Plan's provisions.

#### General

The Plan was originally adopted in 1993. The Plan is a defined contribution plan covering all full-time employees, 21 years of age or older, who have three consecutive months of service as defined in the Plan document. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Participants may contribute up to 100% of their eligible compensation on a pretax basis (i.e., salary reduction) or Roth elective deferrals to the Plan up to a maximum of \$23,000 for 2024 and \$22,500 for 2023. Participants age 50 and older may contribute an additional catch-up contribution of \$7,500 for 2024 and for 2023. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may match a percentage of the salary reduction authorized by the participants. Additional amounts may be contributed at the option of the Company's board of directors, but only to the extent of amounts allowable by IRS regulations. The plan also allows rollover contributions.

#### Participant Accounts

Each participant's account is credited with the participant's salary-reduction contribution and allocations of the Company's contribution, the Plan's investment earnings, and charged with an allocation of administration costs. Allocations are based on participant earnings or account balances, as defined. A participant is entitled to the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service. Unvested portions of participants' account balances who leave employment revert to the Company and will be used to reduce Company matching contributions.

#### Participant Loans

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are comparable with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are repaid ratably through weekly payroll deductions. The Plan had \$134,387 and \$130,899 in participant loans outstanding at December 31, 2024 and 2023, respectively. Loans are not foreclosed on until a distributable event occurs (see Payment of Benefits below).

### NOTE 1 – DESCRIPTION OF THE PLAN, Continued

#### Payment of Benefits

Benefits may be paid to a participant or beneficiary upon the following events: death, disability, termination of employment, or attaining age 65 as defined in the Plan. In addition, a participant may qualify for a hardship distribution as defined in the Plan.

Benefit payments to participants are recorded upon distribution. As of December 31, 2024 and 2023, there were no amounts due to participants who had requested a distribution from the Plan prior to year-end, but did not receive the distribution until after year end.

#### Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,646 and \$5,978, respectively. These accounts are used to reduce future employer contributions. Also, in 2024, \$43,840 was forfeited from nonvested accounts.

### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for details.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed excess contributions for 2024 and 2023 of \$55,689 and \$52,947, respectively, to the applicable participants prior to March 15 of the following year.

### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, Continued

#### Administrative Expenses

All reasonable Plan administration expenses, including those involved in retaining necessary professional assistance, may be paid from the assets of the Plan to the extent permitted by the participant's individual agreements. These expenses may be allocated to all Plan participants, or for expenses directly related to one participant, charged against that participant's account balance. Investment related expenses and some plan administration expenses (loan initiation and tracking fees) were charged to the individual participant accounts by the investment custodians. The Plan Sponsor and its related employers may, at its discretion, pay a portion or all of these expenses. For the year ended December 31, 2024 and 2023, the Plan Sponsor and its related employers paid expenses related to plan administration, annual audit fees, third-party administration fees, and insurance and bonding.

#### Payment of Benefits

Benefits are recorded when paid.

#### Date of Management's Review

Subsequent events were evaluated through September 25, 2025, which is the date the financial statements were available to be issued.

### NOTE 3 – PLAN INVESTMENTS

All Plan assets are invested in various pooled separate accounts available under a contract issued by John Hancock USA. Upon enrollment in the Plan, a participant may direct employee contributions into the various investment options. All contributions are held and managed by John Hancock USA which invests cash received and sends distributions to the Plan's participants.

### NOTE 4 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions. See the Plan's trust document for additional details.

### NOTE 5 – RELATED PARTY TRANSACTIONS

Certain Plan investments are units of pooled separate accounts managed by John Hancock USA. John Hancock USA is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest.

Fees paid by the Plan for consulting services for the Plan amounted to \$90,367 and \$86,864 for the years ended December 31, 2024 and 2023, respectively.

### NOTE 6 – FAIR VALUE MEASUREMENTS

The framework for measuring fair values provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

---

Level 2            Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

---

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts:* The Plan invests all of its funds in Pooled Separate Accounts at John Hancock. The underlying investments in the Pooled Separate Accounts are Mutual Funds and Common/Collective Trusts. The Pooled Separate Accounts are valued at the net asset value (NAV) per share held by the Plan based on the underlying securities which have observable level 1 or 2 pricing inputs. The funds do not have a finite life, unfunded commitments relating to these types of investments, or significant restrictions on redemptions.

### NOTE 7 – TAX STATUS

The Internal Revenue Service has determined and informed the Plan that its Defined Contribution Master Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (the Code). The Plan has been amended since receiving the determination letter. However, the Plan's trustee and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

The Plan has adopted guidance on accounting for uncertainty in income taxes issued by the Financial Accounting Standards Board. Management of the Plan believes that the plan has taken no uncertain tax positions that require adjustment to the financial statements in order to comply with the provisions of this guidance. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### NOTE 9 – INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN - UNAUDITED

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by John Hancock, the custodian of the Plan.
