Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of WoodmenLife 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified

investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of Form 500, Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

AS OF AND FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the WoodmenLife 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General—The Plan is a defined contribution plan sponsored by Woodmen of the World Life Insurance Society (the Sponsor or WoodmenLife) covering substantially all employees (other than Medical Director) and representatives of the Sponsor. To be eligible for the Plan, representatives must have nine months of service and home office employees must have at least one month of service. The Plan was amended effective January 1, 2007, to provide for WoodmenLife matching contributions and profit sharing (service-related) contributions to employees or representatives employed after October 1, 2006, and to WoodmenLife employees and representatives who opted out of the Retirement Plan for Employees and Representatives of WoodmenLife (defined benefit plan). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions—Eligible employees who choose to participate in the Plan may elect to contribute a percentage of their annual pretax compensation, not to exceed \$23,000 in 2024 and \$22,500 in 2023, as defined by IRS limits. Participants age 50 and older may elect catch-up contributions not to exceed \$7,500 in 2024 and \$7,500 in 2023. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective January 1, 2009, the Plan was amended to automatically enroll eligible participants at 3% of the participant's compensation unless they affirmatively decline to participate. The Plan was further amended effective December 1, 2014 to provide that all participants with an automatic deferral or elective deferral amount between 0% and 9% will be subject to an automatic increase of 1% annually, unless or until his or her deferral amount reaches 10%. This increase will not apply to any participant who elected not to be subject to automatic deferral or automatic increase by opting out or submitting their own elections.

For participants eligible to receive a matching contribution, participant contributions are matched each pay period. Effective December 1, 2014, the plan was amended to allow true-up contributions. This ensures if a participant deferred up to 5% of their eligible compensation, participant contributions are matched up to 5% of their eligible compensation. An example would be if a participant elected to defer a large percentage and reaches the maximum limit for the year, the participant would miss out on any further company match dollars. The true-up allows for the maximum matching amount for those that defer at least 5% of their compensation. Eligible participants also begin receiving service-related contributions following one year of service. This contribution is also made each pay period. The applicable percentages for the service-related contributions are: 0% for any Participant with less than 1 year of service; 1.5% for any participant with at least 1, but no more than 6 years of service; 3.0% for any participant with at least 6, but no more than 14 years of service, and 6% for any participant with 15 or more years of service. Effective January 1, 2019 the match is dollar for dollar on the first 5% contributed.

Participant Accounts—Each participant’s account is credited with the participant’s contribution and allocations of investment earnings as well as employer contributions for those who are eligible to receive employer contributions. Allocations are based on account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

Vesting—Participants are immediately vested in their contributions plus actual earnings thereon. Participants eligible for a matching and service-related contribution vest 25% for each year of service and become fully vested after four years.

Payment of Benefits—Upon termination of service, death, disability, reaching age 59 1/2, or retirement, a participant (beneficiary) may elect to receive an amount equal to the value of the vested interest in his or her account.

Participant Loans—The Plan provides for loans to participants under certain circumstances. Loans made are limited to the lesser of \$50,000 or 50% of the vested account balance of the participant and bear an interest rate equal to the national prime rate plus 1% at the time the loan is initiated. Loan transactions are treated as transfers between the investment funds and the loan fund. Loan payments are to be made over a period not to exceed five years unless the loan qualifies as a home loan. The loan must provide for monthly or other periodic payments under a level amortization schedule under the Sponsor’s payroll deduction plan. Interest rates range from 4.25% to 9.5%, and maturity dates on the loans range from 2025 to 2039.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Presentation—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates—The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits. The Plan’s exposure to a concentration of credit risk is limited by the opportunity to diversify investments across multiple participant-directed investment elections. As of December 31, 2024, the following investment represents more than 10% of the fair value of the Plan’s total investments.

Plan Administration—The Sponsor’s Retirement Committee serves as the plan administrator. The Plan has a trust agreement with Empower Trust Company, LLC (the Trustee). Under the terms of the trust agreement between the Trustee and the Plan, the Trustee administers trust funds on behalf of the Plan. The Trustee has authority to execute purchases and sales of investments on behalf of the participants as directed by the plan administrator.

Investment Valuation and Income Recognition—Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 7 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Forfeited Accounts—When certain terminations of participation in the Plan occur, the nonvested portion of the participant’s account, as defined by the Plan, represents a forfeiture. The plan document permits the use of forfeitures to either reduce future employer contributions or pay plan administrative expenses for the plan year. However, if a participant is reemployed and fulfills certain requirements, as defined in the plan document, the account will be reinstated. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$72,138 and \$26,438, respectively. Employer contributions were reduced by \$102,060 and \$65,284, respectively, for the years ended December 31, 2024 and 2023.

Payment of Benefits—On termination of service with the Company (including termination of service due to death, disability, or retirement), a participant will receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account.

Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships. Following a hardship withdrawal, participants are not allowed to contribute to the Plan for a period of six months.

Plan Expenses—Expenses of the Plan are paid by the Sponsor, including auditor, consultant and attorney fees. Expenses of the Plan paid by the participants include plan administration, loan origination, maintenance and distribution fees.

All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, investment management fees and operating expenses are reflected as a reduction of investment return for such investments.

The Plan has a revenue-sharing agreement whereby certain investment managers return a portion of the investment fees to the recordkeeper to offset the Plan’s administrative expenses.

Notes Receivable from Participants—Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Subsequent Events—Management evaluated subsequent events for the Plan through October 7, 2025 the date the financial statements were available to be issued.

3. CERTIFIED INVESTMENT INFORMATION

The following is a summary of the certified investment information regarding the Plan as of and for the years ended December 31, 2024 and 2023, included in the Plan's financial statements and supplemental schedule that was prepared by or derived from information prepared by Empower Trust Company, LLC, the trustee of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the trustee that such information is complete and accurate.

4. RELATED-PARTY TRANSACTIONS

Empower Trust Company, LLC provides recordkeeping services to the Plan and receives fees, which are paid by Plan investments. These transactions are exempt from the prohibited transaction rules of ERISA. The Plan also issues loans to participants, which are secured by the vested balances in the participants' accounts.

5. PLAN TERMINATION

Although it has not expressed an intent to do so, the Sponsor has the right under the Plan to terminate the Plan at any time, subject to the provisions set forth in ERISA. Upon termination of the Plan, the principal and income of the Plan remains for the exclusive benefit of the plan participants or their beneficiaries.

6. FEDERAL INCOME TAX STATUS

The Plan uses a prototype plan document sponsored by Empower Trust Company, LLC. Empower Trust Company, LLC has received an opinion letter from the Internal Revenue Service (IRS), dated November 14, 2022 which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

7. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Asset Valuation Techniques—Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds—Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Fund—A collective trust fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the bank collective trust. The net asset value, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to confirm that securities liquidations will be carried out in an orderly business manner. There are no other restrictions on redemptions or unfunded commitments as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
