**Opinion**

#### **NOTE 1 - Description of Plan**

The following brief description of Chestnut Dental Associates, P.C. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of Chestnut Dental Associates, P.C. (the Company) who have completed three months of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Participant Contributions**

Each year, participants may contribute up to 100% of annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds and a common collective trust as investment options for participants. Participant and Company contributions are subject to certain limitations. Substantially all investments are participant directed.

#### **Employer Safe Harbor Contributions**

The Company makes safe harbor matching contributions to the Plan. The Company will contribute an amount equal to the sum of 100% of the amount of the participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the amount of the participant's elective deferrals that exceed 3% of the participant's compensation up to 5% of the participant's compensation, as defined in the Plan.

#### **Employer Non-Elective Profit Sharing Contributions**

The Company may elect to contribute a profit sharing contribution subject to the limitations imposed by federal law. Contributions are made to eligible employees as defined by the Plan. A participant is eligible for a profit sharing contribution if they have been credited with a minimum of 1,000 hours of service during the plan year. The Company did not make a profit sharing contribution during the year ended December 31, 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### NOTE 1 - Description of Plan (continued)

##### **Vesting**

Participants are vested immediately in their contributions and employer safe harbor matching contributions plus actual earnings thereon. Participants vest in employer non-elective contributions in accordance with the following schedule:

Completed years of service	Percent vested
1 year	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years and thereafter	100%

##### **Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the vested balance or \$50,000. A participant may only have a maximum of two loans outstanding at any given time. The loans are secured by the balance in the participant's account. Loans shall bear an interest rate equal to prime plus 100 basis points. The repayment period for principal residence loans may not exceed fifteen years; all other loans must be repaid within five years.

##### **Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In-service withdrawals from a participant's vested account are permitted upon reaching age 59 1/2. If a participant's vested account at severance from employment is less than \$7,000 and the participant had made no election, the Plan has the ability to automatically rollover the balance to an Individual Retirement Account on behalf of the participant.

##### **Hardship Withdrawals**

Hardship withdrawals are not permitted by the Plan.

##### **Forfeited Accounts**

At December 31, 2024 and 2023, there were no forfeited nonvested accounts balances. These amounts would be included as part of investments, at fair value, in these financial statements. These amounts can be used to pay plan expenses, or reduce future employer contributions.

#### NOTE 2 - Summary of Accounting Policies

##### **Basis of Accounting**

The accompanying financial statements are prepared under the accrual method of accounting.

#### NOTE 2 - Summary of Accounting Policies (continued)

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Unit Values**

Individual participant accounts for the common/collective trusts are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds, but do have an interest therein represented by units which are valued daily. The funds earn dividends and interest, which are automatically reinvested in additional units. Generally, contributions to and withdrawals from each fund are converted to units by dividing the amounts of such transactions by the unit values as last determined. Participants' accounts are charged or credited with the number of units attributable to each participant.

##### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Plan Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

##### Subsequent Events

The Plan has evaluated subsequent events through October 1, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.

#### NOTE 3 - Investments

Plan investments include shares of mutual funds and units of common/collective trusts. The Plan offers investment choices to allow participants to create a diversified portfolio of assets based on the participant's risk tolerance. Participants may direct their contributions as well as Employer contributions to any of several investment options.

#### NOTE 4 - Fair Value Measurements

The Fair Value Measurements and Disclosures Topic of the FASB Accounting Standards Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under this topic are described below:

##### Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

##### Level 2

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

##### Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023, respectively.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Units in Common/Collective Trust Funds: Valued at the NAV of the units of a common/collective trust. The NAV, as provided by the custodian, is used as a practical expedient for estimating fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The Plan's policy is to recognize transfers between levels 1 and 2 and into and out of level 3 as of the date of the event or change in circumstances that caused the transfer. There were no such events for the year ended December 31, 2024.

(a) In accordance with Accounting Standards Codification (ASC) Subtopic 820-10, Fair Value Measurements, certain investments that are measured at fair value using the NAV per share (or its equivalent) practical expedient have not been classified within the fair value hierarchy. The fair value amounts presented in these tables are intended to permit reconciliation of the fair value amounts to amounts presented in the statements of net assets available for benefits.

Redemptions in the common collective trust are allowed daily for participants. There were no unfunded commitments at December 31, 2024.

#### **NOTE 5 - Related Party Transactions and Party-in-Interest Transactions**

Fidelity Management Trust Company is the custodian of the Plan which qualifies as a party-in-interest. Sentinel Benefits and Financial Group (Sentinel) is the third-party administrator of the Plan, which also qualifies as a related party. These transactions are exempt from the prohibited transaction rules, as defined by ERISA. Fees paid to Sentinel and other Plan service providers totaled approximately \$71,000 for the year ended December 31, 2024. Notes receivable from Participants also qualify as exempt party-in-interest transactions.

#### **NOTE 6 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### **NOTE 7 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### NOTE 8 - Tax Status

Effective December 1, 2021, the Company adopted a restated pre-approved plan document of Sentinel Benefits Group, Inc., and the Internal Revenue Service (IRS) has determined and informed the sponsor of the pre-approved plan document by a letter dated November 30, 2020 that the preapproved plan document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax years in progress.
