

**NOTE 1 – DESCRIPTION OF PLAN**

The Claridge Products and Equipment, LLC Employee 401(k) Plan (the Plan) is a defined contribution plan sponsored and administered by Claridge Products and Equipment, LLC (the Company) for the benefit of its employees who have at least six months of service and are not covered by a collective bargaining agreement. The Company is responsible for oversight of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. John Hancock Trust Company LLC (John Hancock) serves as the trustee and record keeper of the Plan.

The summary of significant provisions of the Plan presented below provides general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Contributions: The Plan allows for eligible employees to make contributions to the Plan through a salary deferral election of up to 50% of eligible compensation. Salary deferrals consist of pre-tax and/or Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Employee rollover contributions are also permitted.

The Company may make discretionary matching and profit-sharing contributions to the Plan. During 2024, the Company elected to make discretionary matching contributions equal to 100% of the first 3% and 50% of the next 2% of participants' contributions per pay period. For 2024, the Company made discretionary matching contributions of \$318,685 to the Plan. During 2024, the Company elected not to make any profit sharing contributions to the Plan.

Participant Accounts: Each participant's account is credited with the participant's contribution, the Company's contributions and Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options: Participants direct the investment of their entire interest in the Plan into various investment options offered by the Plan. The Plan currently offers mutual funds, collective trust funds, and a pooled separate account as investment options.

Vesting: Participants are immediately vested in their contributions and any discretionary matching contributions plus earnings thereon. Vesting in the Company's profit-sharing contribution portion of their accounts plus earnings thereon is based on years of service. A participant is fully vested after six years of service. The non-vested balance is forfeited upon termination of service.

Forfeitures: Forfeitures are used to reduce the company's matching contribution for the year in which the forfeitures occur or are used to pay expenses incurred to maintain the Plan. During 2024, there were no forfeitures.

Payment of Benefits: Upon termination of service due to death, disability, or normal retirement, each participant will be entitled to the vested percentage of your account balance. If a participant's vested account balance is \$5,000 or less, the account will be distributed directly to the participant in a cash lump-sum. For vested account balances exceeding \$5,000, participants must consent to distribute their account.

Participants may receive an in-service withdrawal from certain other accounts prior to termination of employment with the Company if they have attained 59 ½ or incurred a financial hardship.

Notes Receivable: The Plan document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum loan amount allowable is \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance.

All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholding unless the participant is paying the loan in full. Interest on the loans is fixed at the Prime Rate as published in the Wall Street Journal on the day the loan is initiated plus 1%. Each participant is permissible to have two loans outstanding at one time.

Plan Termination: Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of a plan termination, participants will become 100% vested in their accounts.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Reclassifications: Some items in the prior year footnote disclosures were reclassified to conform to the current presentation. Reclassifications had no effect on prior year net assets available for benefits or the prior year net increase in net assets available for benefits.

Subsequent Events: The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued and determined that there were no events that occurred subsequent to the balance sheet date that would require adjustment to, or disclosure in, the financial statements.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America require the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. The Company determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Excess Participant Contributions Payable: Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit, and global event risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 3 – CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in the fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Trust Company LLC.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

- *Level 1* – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- *Level 2* – Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- *Level 3* – Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: The fair values of mutual fund investments are determine by obtaining quoted prices on nationally recognized securities exchanges (Level 1).

Pooled Separate Accounts: The fair values of participation units held in pooled separate account are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements, and has redemption prices that are determined by the fund’s net asset value per unit.

Collective Trust Funds: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund manager. The collective trusts provide for daily redemptions by the Plan are reported net assets values per share, with no advance notice requirement.

\*The Plan uses the net asset value (NAV) as a practical expedient to estimate the fair value of investments in certain collective trust funds and pooled separate accounts. These investments are not classified within the fair value hierarchy.

The collective trust funds invest primarily in a diversified portfolio of mid-cap value equity securities and are designed to track the performance of their benchmark indices. The pooled separate account invests primarily in a diversified mix of fixed-income securities and stable value strategies intended to preserve capital and provide steady returns. These investments do not have unfunded commitments, and there are no redemption restrictions or lock-up provisions associated with these funds. The Plan may redeem its investment in the collective trust funds and pooled separate account on a daily basis at NAV without advance notice. As of December 31, 2024, the Plan has no plans to liquidate these investments. If a decision to liquidate were made, management believes the investments could be fully redeemed at NAV within a normal settlement period.

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under the Department of Labor (DOL) regulations as any fiduciary of the Plan, and any party rendering service to the Plan, the Company, and certain other. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Certain Plan investments managed by the trustee and notes receivable from participants also reflect party-in-interest transactions.

**NOTE 6 – TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original non-standardized pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for year prior to 2021.
