The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE A - PLAN DESCRIPTION

The following description of the Room & Board, Inc. (the “Plan Sponsor”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan. The Plan was established on May 1, 1987. It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan was restated effective January 1, 2017.

Eligibility

All employees of the Employer, except employees covered under a collective bargaining agreement, non-resident aliens, and leased employees are eligible to participate in the Plan upon employment.

Contributions

Participants may contribute 1% to 80% of their annual compensation, as defined by the Plan, to the Plan through participant elective deferral contributions, subject to limits established by law. Participants’ contributions are pre-tax contributions unless participants designate all or a portion as Roth contributions. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Plan includes an automatic annual 2% increase in deferral election up to 10%, unless the participant makes a contrary election. Participants may also make rollover contributions and participants age 50 and over may make catch-up contributions to the Plan. All contributions are subject to certain limitations contained in the Plan and as defined by law.

Employer matching contributions are provided for under the Plan and are discretionary based on profitability, with a maximum contribution of 50% of the first 8% of a participant’s contribution. For the Plan year ended December 31, 2024, the Plan Sponsor provided an employer matching contribution rate of 50% of the participants’ elective deferral contributions up to a maximum of 8% of the participants’ eligible compensation, subject to limits established by law.

Additionally, participants may be eligible for an additional discretionary matching contribution from the Company. No discretionary non-elective contributions were made in fiscal year 2024.

Participants’ Accounts

Participants’ accounts are credited with participants’ elective deferrals, rollover contributions, catch-up contributions, employer’s contributions, and an allocation of the Plan earnings, if applicable. Allocations of employer contributions are based on participants’ eligible compensation, as specified in the Plan.

Participants’ accounts are also charged with benefit payments, if applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants’ accounts are valued daily.

Vesting

Effective January 1, 2022, Plan benefits attributable to employer contributions are 25% vested after one year of service, 50% vested after two years of service and 100% vested after 3 years of service, with a provision for 100% vesting at the normal retirement date, early retirement with at least three years of vesting service, or death or permanent disability, as defined in the Plan. Participants' salary reduction contributions, catch-up contributions, and rollover contributions are immediately vested plus earnings (losses) thereon.

Forfeitures

Forfeitures within the Plan year may be used to pay Plan expenses or offset employer contributions. In 2024, forfeitures of \$157,019 were used to reduce employer matching contributions. As of December 31, 2024, and 2023, forfeiture balances of \$160,546 and \$148,108, respectively, are held in the Plan's forfeiture account as part of plan assets.

Investment Options

Participants may direct the investment of their account balances into various funds as defined in the Plan. The Plan allows participants to transfer assets in their accounts between the funds daily.

Payment of Benefits

Under the terms of the Plan, participants may receive distributions in the form of an annuity, a direct rollover, or a lump-sum upon retirement. Upon separation of employment due to termination, participants may withdraw their benefits as a lump-sum payment. If a terminated participant's account balance exceeds \$1,000 but is not more than \$7,000 and the participant has not elected a form of distribution, the balance will be automatically rolled over to an individual retirement account ("IRA") with the Trustee. If the account balance is \$1,000 or less, and the participant has not made an election, a lump-sum distribution will be made. Participants are permitted withdrawals from their Plan accounts for financial hardships and early retirements, after age 59½. There were no benefit payments requested and unpaid as of December 31, 2024 and 2023.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$500 up to a maximum of the lesser of \$50,000 or 50% of their account balance, as defined in the Plan. The loans are secured by the participant's vested account balance. Notes must be repaid within five years or within fifteen years if used for the purchase of a primary residence. Such notes bear interest at a rate commensurate with local prevailing rates, one percent above the prime interest rate. Principal and interest are repaid ratably through payroll deductions for active participants. A participant may have no more than one outstanding loan at one time. There were no loans in default as of December 31, 2024 and 2023.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

Basis of Accounting

The financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment in the collective trust fund and pooled separate accounts are valued at net asset value ("NAV") as a practical expedient to fair value. Please see Note C for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Net Appreciation in Fair Value of Investments

Net appreciation in the fair value of investments represents the net realized gains and losses and net unrealized appreciation or depreciation on investments. Realized gains or losses on investments are the differences between the proceeds received and either the cost of the investment sold, determined on an average-cost basis, or the fair value at the end of the previous year, whichever is applicable. Net unrealized appreciation and depreciation is the change in the difference between fair value and the cost of investments or the fair value at the end of the previous valuation date, whichever is applicable.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor.

Benefits Paid to Participants

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Risks and Uncertainties

The Plan provides for investments in a variety of investment funds. The investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and charges therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events

The Plan evaluated its December 31, 2024 financial statements for subsequent events through October 3, 2025, the date the financial statements were available to be issued, for events requiring recording or disclosure in the Plan's financial statements. On January 1, 2025, the Plan was updated to allow for the

increased catch-up contributions for eligible participants. Plan management is not aware of any other subsequent events that would require recognition or disclosure in the financial statements.

NOTE C - FAIR VALUE MEASUREMENTS

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during Plan years 2024 and 2023.

Mutual funds: Value is quoted daily from publicly traded closing prices.

Collective trust fund: Valued using the NAV. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities and is used as a practical expedient to estimate fair value.

Pooled separate accounts: Valued using the NAV. The NAV is determined by each fund’s trustee using the fair value of the underlying securities within the fund at year end and is used as a practical expedient to estimate fair value.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or

- Net investment income and interest income on notes receivable from participants, as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4(i) - schedule of assets (held at end of year) as of December 31, 2024.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor retains the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participants' accounts and distributed in such a manner as the Plan Sponsor may determine.

NOTE F - INCOME TAX STATUS

The Plan obtained its latest determination letter on May 22, 2018, in which the IRS stated that the Plan was designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - RELATED PARTIES AND PARTIES-IN-INTEREST

Certain Plan investments are managed by the trustee of the Plan and therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers of the Company. No such officer or employee receives compensation from the Plan.
