Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Telephone Electronics Corporation & Associated Companies 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. DESCRIPTION OF PLAN

The following brief description of the Telephone Electronics Corporation and Associated Companies 401(k) Plan (the TEC Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the TEC Plan's provisions.

General

Telephone Electronics Corporation and its subsidiaries (collectively the Company or TEC) established the TEC Plan in a prior year. The TEC Plan is a defined contribution plan covering all full-time employees of the Company who have completed three months of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Plan Administration

The Company is the administrator of the TEC Plan. Plan administration is accomplished through an employee benefit plan committee (the Plan Committee) consisting of two or three persons who are appointed by the TEC Board of Directors and do not receive compensation from the TEC Plan for their services.

Fidelity Management Trust Company (Fidelity) is the TEC Plan trustee. Regions Trust (Regions) is the TEC Plan's investment advisor.

The Company may remove Fidelity and appoint a successor trustee. The Company and Fidelity have entered into a Trust Agreement which provides for the establishment of a Trust for the purpose of holding and investing contributions and making required distributions pursuant to the provisions of the TEC Plan.

The Plan Committee meets at least annually, along with representatives of Regions, to discuss the performance and other relevant information regarding the investment options available under the TEC Plan. Regions provides recommendations to the Plan Committee as to whether any changes should be made to the TEC Plan's investment options.

Plan Amendment

Effective January 1, 2023, the TEC Plan was amended to cover all full-time employees of the Company who have completed three months of service and are age twenty-one or older. Further, the TEC Plan was amended to allow participants to contribute on a designated Roth basis (after-tax contributions).

Contributions

Participating employees may contribute a portion of their pretax or post-tax annual compensation to the TEC Plan up to the maximum allowed by the Internal Revenue Code (the Code), and the Company at its discretion, makes matching contributions based on the employee's contribution. Currently, the Company makes safe harbor matching contributions of 100 percent of the first 3 percent of employee compensation contributed to the TEC Plan and 50 percent of the next 2 percent of employee compensation contributed to the TEC Plan. Participants who have attained age 50 before the end of the TEC Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions, as well as the Company's safe harbor matching contributions, into various investment options offered by the TEC Plan. The TEC Plan currently offers twenty-six mutual funds and one collective investment fund as investment options for participants. A participant may instruct that all contributions be allocated among the various fund options. Additionally, a participant may change his or her contribution allocation instructions at any time and contribution percentages on a quarterly basis in accordance with the provisions of the TEC Plan. Participants may generally change their investment portfolio allocations at any time. However, in an effort to protect the interests of the long-term shareholders, some funds may prohibit frequent trading and/or impose redemption fees.

Participant and Company contributions are recorded in the period during which the Company makes payroll deductions from the TEC Plan's participants' earnings.

Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contributions and the Company's safe harbor matching contributions together with their earnings, and charged with any applicable administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All participants are furnished with quarterly statements which set forth the status of their accounts in the TEC Plan. In addition, participants have access to an automated voice response system and an internet website to obtain up to date information regarding account balances, contributions, investment options, fund performance and other TEC Plan data.

Vesting

Participants are fully vested immediately in their contributions and their rollover contributions, plus any earnings they generate. Participants are also fully vested immediately in the safe harbor matching contributions made by the Company plus actual earnings thereon. Any other additional employer contributions to the TEC Plan made at the Company's discretion, plus any earnings they generate, are fully vested immediately as well.

Notes Receivable from Participants

The TEC Plan has a provision whereby participants may borrow from their fund accounts. The minimum loan amount is \$1,000 and the maximum loan amount is the lesser of \$50,000 or 50 percent of their account balance at the date of the loan request. Loan disbursements are made on a prorated basis from each of the participant's current investment options and contribution sources as of the date of the approved loan request. The loans are secured by the balance in the participant's account. Interest on the underlying loan is based on the prime rate reported by Thomson Reuters on the first business day of each month, plus 1 percent, and such rate is fixed for the life of the loan. Loans are repaid through bi-weekly payroll deductions over terms not less than one year and not to exceed five years. Principal and interest payments are reinvested in the participant's account in accordance with the investment elections in effect at the time such payments are received. A participant may only have one loan outstanding at any time.

Payment of Benefits

On termination of service for any reason, a participant (or his or her designated beneficiary or legal representative) may elect to receive the value of the participant's vested interest in his or her account as a lump sum distribution. If the participant dies without designating a beneficiary, his or her beneficiary shall be, in the order listed, (i) spouse, (ii) children, or (iii) estate. If the value of the participant's account balance is greater than \$1,000, no distribution will be made without the participant's consent. If the value of the participant's account is \$1,000 or less, the participant will receive a distribution of their account balance unless the participant elects to have the distribution paid directly to another eligible retirement plan.

Withdrawals

A participant who is an employee and over age 59½ may make withdrawals from his vested accounts prior to meeting normal distribution requirements. Additionally, a participant may make withdrawals from the rollover portion of their account at any time. Certain qualifying hardship withdrawals may be made from the elective deferral portion of their account and vested discretionary contributions in accordance with the provisions of the TEC Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the TEC Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The TEC Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included within dividend income. Net appreciation includes the TEC Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the loan is deemed to be in default, the participant loan balance is reduced and a benefit payment is recorded. Also, unpaid loans of terminated participants are treated as distributions to the participant.

Expenses and Participant Transaction Fees

Certain administrative expenses for maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The remaining administrative expenses for maintaining the plan are paid by plan participants and included in these financial statements. These expenses are allocated to participant accounts based upon participant account balances. Expenses relating to

specific participant transactions (i.e., loan fees, distribution fees, etc.) are deducted directly from the participant's account. Certain investment related expenses are included in net appreciation (depreciation) of fair value of investments. The Company may utilize credits received under its service agreement with the Plan's trustee to pay certain administrative expenses.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The TEC Plan evaluated subsequent events through October 9, 2025, which is the date the financial statements were issued.

During 2024, the TEC Plan's mutual fund investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$1,630,588.

4. FAIR VALUE MEASUREMENTS

ASC 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Input to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of the input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. However, the inputs or methodology used for valuing investments are not an indication of the risk associated with such investments.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the TEC Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the TEC Plan are deemed to be actively traded.

Collective investment fund: The collective investment fund, which is composed primarily of fully benefit-responsive investment contracts, is valued at the net asset value of shares held by the TEC Plan at year-end. The net asset value as provided by Fidelity is used as a practical expedient to estimate fair value and as a result is included within investments measured at net asset value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the TEC Plan initiates a full redemption of the collective investment fund, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future value. Furthermore, while the TEC Plan believes its valuation methods are appropriate and consistent with other market participants, the use of

different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PARTY-IN-INTEREST

Transactions between the Plan and Fidelity, the TEC Plan trustee, meet the definition of party-in-interest transactions under the provisions of ERISA (Party-in-interest transactions).

The TEC Plan maintains three Fidelity mutual funds as investment options. Total investments in these mutual funds amounted to \$2,763,606 at December 31, 2024.

Outstanding Notes receivable from participants, and the related interest income on Notes receivable from participants, for the year ended December 31, 2024, are presented on the Statement of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits, respectively.

6. TAX STATUS

The TEC Plan is a Prototype 401(k) Plan. As such, TEC may rely on an Opinion Letter issued by the Internal Revenue Service (IRS) as evidence that the TEC Plan is qualified under Section 401 of the Code. Therefore, the TEC Plan administrator and the TEC Plan's tax counsel believe that the TEC Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

GAAP requires the plan administrator to evaluate tax positions taken by the TEC Plan and recognize a tax liability (or asset) if the TEC Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS and the Department of Labor (DOL). The TEC Plan is subject to audits by the IRS and DOL; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to examinations for years prior to 2021.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company reserves the right under the TEC Plan to discontinue its contributions at any time and to change, suspend or terminate the TEC Plan at any time, subject to provisions of ERISA and the TEC Plan.

8. RISKS AND UNCERTAINTIES

The TEC Plan provides for various investment options in any combination of twenty-six mutual funds and one collective investment fund. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investments will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

Additionally, some investments held by the TEC Plan are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices and possible adverse

political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

The ultimate ability of the Company to respond with positive results to the changing telecommunications environment will determine to what extent the Company will have the ability to fund future safe harbor matching contributions and to continue the TEC Plan.
