INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
the Nilssen's Supervalu 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Nilssen's Supervalu 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Nilssen's Supervalu 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Note 1. Plan Description

T & W Supermarket, Inc. (the Company) established the Nilssen's Supervalu 401(k) Plan (the Plan), a defined contribution plan adopted under section 401(k) of the Internal Revenue Code, to provide retirement income and other benefits to qualified employees. The following is not a comprehensive description of the Plan, and therefore, does not include all situations and limitations covered by the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Plan Operations

The Company is the sponsor and administrator of the Plan, LT Trust Company (the Custodian) is responsible for holding the assets of the Plan, executing investment transactions, and making disbursements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees who have reached the age of 21 become eligible to participate in the Plan after completing one year (1000 hours) of service and can enter the Plan on the first day of January, April, July, or October coincident with or following the satisfaction of the eligibility requirements.

Contributions

Each year, eligible employees can contribute, either pre-tax or Roth, an amount up to 100 percent of compensation as defined in the Plan, limited by requirements of the Internal Revenue Code (the IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company makes safe-harbor matching contributions equal to 100 percent of employee contributions up to the first 3 percent of compensation that a participant contributes to the Plan and 50 percent of employee contributions in excess of 3 percent and up to 5 percent of compensation. Additional matching or profit-sharing amounts may be contributed at the Company's option. The Company did not make additional matching or profit sharing contributions to the Plan for the 2021 Plan year. Contributions are subject to certain limitations.

Participants may direct the investment of the contributions into various investment options under the Plan. Participants may change their investment options at any time.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching and non-elective contributions and, (b) Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and safe-harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary non-safe harbor or profit sharing contributions portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant's account vests at the rate of 20% per year after one year of credited service and is 100% vested after five years of credited service.

Distribution of Benefits

Upon termination of service, death, disability or retirement, a participant (or the participant's beneficiary in the case of death) will receive the vested portion of his or her account as a lump-sum payment. Hardship distributions during employment are available to participants for medical expenses described in Section 213(d) of the IRC, the purchase of a principal residence, or the payment of tuition and related educational fees for the next 12 months of postsecondary education.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to a variety of registered investment company accounts (mutual funds). The investments range from low-risk income funds to high-risk international growth funds.

Forfeitures

If an employee is not 100 percent vested when employment terminates, the portion of any account that is not vested will be transferred to a forfeiture account. A terminated employee's rights to the forfeiture account depend upon when and if the employee is rehired and when the vested benefit payment is made to the employee. During the plan year ended December 31, 2024, no forfeitures were used to reduce employer contributions. As of December 31, 2024, the balance in the forfeitures account was \$0.

Notes Receivable from Participants

Participants may borrow up to 50% the vested portion of their account not to exceed \$50,000, if approved by the Plan administrator. Loans bear an interest rate of prime plus 1.0%, currently between 4.25% and 9.50%, and must be repaid within 5 years unless used to acquire a personal residence.

Administrative Expenses

The Company pays certain administrative expenses, including consulting, audit and administrative fees, on behalf of the Plan.

Note 2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting. The Plan follows the guidance in the guide *Audits of Employee Benefit Plans*.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expense during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net gain from investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Benefit Payments

Benefits are recorded upon distribution.

Risks and Uncertainties

The Plan provides for various investment options in various combinations of investment securities. Investment securities are exposed to various risk factors including, but not limited to, interest rates, market conditions and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the Statements of Assets Available for Benefits in future periods.

Subsequent Events

The Plan has evaluated all subsequent events through **September 29, 2025**, which is the date the financial statements were available to be issued.

Note 3. Information Certified by the Custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by **LT Trust Company and American Trust Company**, the custodians of the Plan.

Note 4. Plan Tax Status

The Internal Revenue Service issued a favorable determination letter, stating that the Plan is designed in compliance with the IRC and is exempt from federal income taxes. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 5. Termination of Plan

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

Note 6. Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

Registered Investment Companies (Mutual Funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7. Related Party Transactions and Party-In-Interest Transactions

The custodian manages the investments held in the pooled separate account. Transactions related to the trust thereby qualify as party-in-interest transactions; however, the Department of Labor has issued prohibited transaction exemptions indicating that these types of transactions are to be considered exempt party-in-interest transactions.

The notes receivable from participants also qualify as exempt party-in-interest transactions.

Note 8. Late Contributions

The Plan Sponsor made a late contribution to the Plan for a single participant. The contribution was for payroll processed on December 30, 2024, but was not deposited until February 8, 2025. The contributions included participant contributions of \$18,643 and employer contributions of \$746. The plan is currently calculating the lost earnings to be deposited to the participant as a QNEC contribution.

Participants may direct the investment of the contributions into various investment options under the Plan. Participants may change their investment options at any time.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching and non-elective contributions and, (b) Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and safe-harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary non-safe harbor or profit sharing contributions portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant's account vests at the rate of 20% per year after one year of credited service and is 100% vested after five years of credited service.

Distribution of Benefits

Upon termination of service, death, disability or retirement, a participant (or the participant's beneficiary in the case of death) will receive the vested portion of his or her account as a lump-sum payment. Hardship distributions during employment are available to participants for medical expenses described in Section 213(d) of the IRC, the purchase of a principal residence, or the payment of tuition and related educational fees for the next 12 months of postsecondary education.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to a variety of registered investment company accounts (mutual funds). The investments range from low-risk income funds to high-risk international growth funds.

Forfeitures

If an employee is not 100 percent vested when employment terminates, the portion of any account that is not vested will be transferred to a forfeiture account. A terminated employee's rights to the forfeiture account depend upon when and if the employee is rehired and when the vested benefit payment is made to the employee. During the plan year ended December 31, 2024, no forfeitures were used to reduce employer contributions. As of December 31, 2024, the balance in the forfeitures account was \$0.

Notes Receivable from Participants

Participants may borrow up to 50% the vested portion of their account not to exceed \$50,000, if approved by the Plan administrator. Loans bear an interest rate of prime plus 1.0%, currently between 4.25% and 9.50%, and must be repaid within 5 years unless used to acquire a personal residence.

Administrative Expenses

The Company pays certain administrative expenses, including consulting, audit and administrative fees, on behalf of the Plan.

Note 2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting. The Plan follows the guidance in the guide *Audits of Employee Benefit Plans*.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expense during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net gain from investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Benefit Payments

Benefits are recorded upon distribution.

Risks and Uncertainties

The Plan provides for various investment options in various combinations of investment securities. Investment securities are exposed to various risk factors including, but not limited to, interest rates, market conditions and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the Statements of Assets Available for Benefits in future periods.

Subsequent Events

The Plan has evaluated all subsequent events through **September 29, 2025**, which is the date the financial statements were available to be issued.

Note 3. Information Certified by the Custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by **LT Trust Company and American Trust Company**, the custodians of the Plan.

Note 4. Plan Tax Status

The Internal Revenue Service issued a favorable determination letter, stating that the Plan is designed in compliance with the IRC and is exempt from federal income taxes. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 5. Termination of Plan

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

Note 6. Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

Registered Investment Companies (Mutual Funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7. Related Party Transactions and Party-In-Interest Transactions

The custodian manages the investments held in the pooled separate account. Transactions related to the trust thereby qualify as party-in-interest transactions; however, the Department of Labor has issued prohibited transaction exemptions indicating that these types of transactions are to be considered exempt party-in-interest transactions.

The notes receivable from participants also qualify as exempt party-in-interest transactions.

Note 8. Late Contributions

The Plan Sponsor made a late contribution to the Plan for a single participant. The contribution was for payroll processed on December 30, 2024, but was not deposited until February 8, 2025. The contributions included participant contributions of \$18,643 and employer contributions of \$746. The plan is currently calculating the lost earnings to be deposited to the participant as a QNEC contribution.
