- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a significant likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

Supplemental Schedule Required by ERISA

The supplemental Schedule H, Part IV, Line 4(i), Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 – Description of Plan

The following description of the UMass Memorial Health Care 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document and any amendments thereto for more complete information.

General

The Plan is a defined contribution Plan covering all regularly scheduled full-time and part-time employees of UMass Memorial Health Care, Inc. (the Company, the Plan Sponsor or the Employer, as used herein). All regularly scheduled full-time and part-time employees are eligible to join the Plan immediately. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, investment managers and trustee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants may contribute up to 50% of their annual eligible compensation on a pre-tax or a Roth after-tax basis, or a combination of both, as defined by the Plan. Participant contributions cannot exceed the annual limits specified under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions in accordance with the IRC. Participants may also contribute amounts representing distributions from other qualified retirement Plans and Individual Retirement Accounts.

The Plan offers two types of Employer contributions: matching Employer contributions and non-elective Employer contributions for profit sharing eligible participants.

For participants who are eligible for matching Employer contributions (all employees who meet the eligibility requirements previously described, but excluding those who are eligible for the non-elective Employer contributions at the 5% or the 8% rate), the Company contributes a basic match and, for a small group of members from certain collective bargaining units who elected the choice offered during periods in years 2007 through 2010, an enhanced match. The basic match is 50% of the first 4% of eligible compensation that a participant contributes to the Plan each pay period for the years ended December 31, 2024 and 2023. The enhanced match requires a minimum participant contribution of 2% and provides a per pay period match on base pay of 2% for less than five years of service, 4% for five to nine years of service, 6% for 10 to 19 years of service, and 8% for 20 or more years of service.

Non-elective Employer contributions are based on 5% of the eligible participant's compensation if that participant is not accruing retirement benefits under the UMass Memorial Health Care Pension Plan for periods after December 31, 1999, or 1% of the eligible participant's compensation if that participant is accruing retirement benefits under the UMass Memorial Health Care Pension Plan for periods after December 31, 1999. In addition, certain former UMass Medical School physicians who are now employees of the Company are eligible for a non-elective Employer contribution based on 8% of the eligible participant's compensation.

All contributions are invested in the Plan based upon participant elections.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions, (b) the Plan's earnings and (c) the Plan's administrative expenses. Allocations are based on participant earnings, contributions, and account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. A participant becomes 100% vested in any type of Company contribution after three or more years of credited service in accordance with the following schedule:

Years of Credited Service	Vesting Percentage
Less than three years	0%
Three or more years	100%

Investments

Participants direct the investment of the employee and Employer contributions into various investment options offered by the Plan. The Plan currently offers a money market fund, mutual funds, and a common/collective trust.

Notes Receivable from Participants

Participants may borrow, from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, as defined by the Plan. Participants are limited to two outstanding loans. Loans must be fully repaid within five years, or within 10 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9%, which are commensurate with local prevailing interest rates, as determined by the trustee. Principal and interest are paid ratably through periodic payroll deductions.

Payment of Benefits

Plan participants are permitted to withdraw funds from their accounts upon retirement or termination of service, or upon attainment of age 59 ½. Upon retirement or termination of service, a participant is entitled to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. If the account balance is greater than \$1,000, the retiring participant may elect to receive periodic installments. Upon attainment of age 59 ½, an active participant may take a partial or full lump-sum distribution, excluding non-elective contributions. For reasons of financial hardship, a participant is entitled to receive a hardship withdrawal equal to the amount of the documented hardship or the eligible portion of the participant's before-tax and Roth accounts, whichever is less.

Forfeited Accounts

Forfeitures of the non-vested portion of withdrawing employees' accounts are retained in the Plan and used to reduce future Employer contributions or to reduce Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$370,561 and \$189,629, respectively. During 2024, forfeitures of \$15,703 were used to reduce Employer contributions and \$50,630 were used to pay plan expenses.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared under the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements, in accordance with GAAP, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair values. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers and the trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Contributions

Contributions from Plan participants and matching Employer contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation. Non-elective Employer contributions are recorded in the year in which the contributions are earned.

Other Income

Other income consists of revenue earned from recordkeeping services in connection with Plan services in excess of contractual compensation. These amounts must be used for payment of qualified Plan expenses or allocation to eligible participants, as defined by the agreement.

Fidelity Investments Institutional Operations Company, Inc. (FIIOC) provides certain administrative services to the Plan pursuant to a Recordkeeping Agreement (RA) between the Company and FIIOC. FIIOC receives revenue from fund service providers for services FIIOC provides to the funds. This revenue is used to offset certain amounts owed to FIIOC for its administrative services to the Plan.

If the revenue received by FIIOC from such fund service providers exceeds the amount owed under the RA, FIIOC remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. There were excess amounts of \$3,180,618 during 2024, which are included in other income on the statement of changes in net assets available for benefits. The Plan or Plan Sponsor may make a payment to FIIOC for administrative expenses not covered by revenue sharing.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments on the statement of changes in net assets available for benefits.

Note 3 – Certified Investments

The Plan administrator has elected the method of compliance permitted by Section 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company (FMTC), the trustee of the Plan.

Note 4 – Fair Value Measures

Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. As such, fair value is a market-based measurement that should be determined based on assumptions that market participants would use in pricing an asset or liability. Assets and liabilities reported at fair value are classified and disclosed in one of the following three categories:

Level 1 – Observable inputs such as quoted prices for identical assets and liabilities in active markets at the measurement date. The fair value hierarchy gives the highest priority to Level 1 inputs;

Level 2 – Valuations using observable inputs other than Level 1 prices such as quoted prices in active markets for similar assets and liabilities; quoted prices for identical or similar assets or liabilities in markets that are not active; broker or dealer quotations; or inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; and

Level 3 – Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

In accordance with Subtopic 820-10, certain investments that are measured at fair value using the net asset value (NAV) per share (or its equivalent) as a practical expedient to fair value have not been classified in the fair value hierarchy. The fair value amounts represented in this table are intended to permit reconciliation of the fair value hierarchy to the amount presented in the statements of net assets available for benefits.

The Plan categorizes, for disclosure purposes, investments measured at fair value in the financial statements based upon whether the inputs used to determine their fair values are observable or unobservable. Observable inputs are inputs that are based on market data obtained from sources independent of the reporting entity. Unobservable inputs are inputs that reflect the reporting entity's own assumptions about pricing the investments based on the best information available in the circumstances.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds and Money Market Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust: The fair value of a single common/collective trust, Fidelity Managed Income Portfolio (MIP) is based on the NAV of the fund, representing the fair value of the underlying investments, which are generally securities traded on an active market and are redeemed daily. The NAV is used as a practical expedient to estimate fair value.

There were no unfunded commitments for the Fidelity MIP as of December 31, 2024. Participant level transactions take place daily at the current NAV. Were the Plan to initiate a full redemption of the Fidelity MIP, notice to Fidelity is required and could result in the Plan's investment in the MIP being placed into an investment only account for up to twelve (12) months. The fund's strategy is income and capital preservation. In accordance with the current accounting guidance, certain investments that were measured at NAV per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are managed by FMTC. FMTC is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment. The Plan made direct payments to the service providers of \$814,808 during the year ended December 31, 2024, which were not covered by revenue sharing. These transactions qualify as exempt party-in-interest transactions. Notes receivable from participants also qualify as exempt party-in-interest transactions. The Company pays, directly, any other fees related to the Plan's operations.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

Note 7 – Tax Status

The Internal Revenue Service (IRS) has determined, and informed the Company by a letter dated December 12, 2017, that the Plan is designed in accordance with applicable sections of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the DOL. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

Note 9 – Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.
