INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the
401(k) Plan for the Kappa Group of Companies

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the 401(k) Plan for the Kappa Group of Companies, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 401(k) Plan for the Kappa Group of Companies financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the 401(k) Plan for the Kappa Group of Companies and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the 401(k) Plan for the Kappa Group of Companies' ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE A – DESCRIPTION OF PLAN

The following description of the 401(k) Plan for the Kappa Group of Companies, (the Plan) is provided for general information purposes only. Participants should refer to the plan document and other material distributed to participants for more complete information.

General

The Plan is a defined contribution plan established January 1, 2001 by Spartan Organization, Inc. (the “Company”) covering employees of the Kappa Group of Companies. The Plan has been amended and restated to comply with current Internal Revenue Code changes. Participating employer companies are Spartan Organization, Inc., Erga, Inc., Jericho National Golf Club, Inc., Kappa Graphics, L.P., Krasi LLC, and Kappa Product Fulfillment Services, LLC (the “Employer Companies”). All participants are able to make salary reduction contributions after completing six months of service with nine-hundred hours from the date of hire and who have attained the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

The Plan allows pretax contributions by means of regular payroll deductions up to 100% of a participant’s compensation as defined by the Plan, subject to limitations prescribed by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Employer Companies, at its discretion, may match the employee’s salary reduction contribution. Participants are only eligible for employer matching contributions if they are employed on the last day of the plan year. For the year ended December 31, 2024, the Employer Companies’ matching contribution is 25% of the employee contribution.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and the allocations of (i) the Company’s contribution and (ii) Plan earnings and losses and (iii) charged with an allocation of administrative expenses. Allocations are determined in accordance with the provisions of the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer Companies’ contribution portion of their accounts is based on years of continuous services. A participant is 100% vested after six years of credited service.

Investment Options

All investments are participant-directed. Upon enrollment, a participant may direct contributions among a wide variety of investment products offered by Ascensus Trust Company and may change their investment options at any time, subject to the terms of the funding vehicles.

Notes Receivable from Participants

Notes receivables are not available to participants under the Plan. The prior termination of the Times Printing, LLC 401(k) Plan and Vanguard Graphics, LLC 401(k) Plan did allow notes receivables. The outstanding participant notes from those plans were transferred to the 401(k) Plan for the Kappa Group of Companies in February 2018. Note interest rates on the loans were 5.25% as of December 31, 2024 and 2023. No new notes were issued for the year ending December 31, 2024 and 2023.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant can receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In-service withdrawal of vested balances may be elected by participants who have reached normal retirement age. In addition, the Plan also allows for hardship distributions if certain criteria are met.

Forfeitures

As of December 31, 2024 and 2023, there were no forfeited non-vested accounts. These accounts would be used to reduce future employer contributions or pay administrative expenses of the Plan. During 2024, no amounts were applied to plan activities from forfeited non-vested accounts.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure of the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes gains and losses on investments bought and sold during the year as well as the unrealized appreciation or depreciation on those investments.

Payment of Benefits

Benefits are recorded when paid.

Administrative Fees

Certain administrative expenses related to the Plan are paid by the Employer Companies, however certain costs may be paid from the assets of the Plan. Fees related to the investment management and administrative costs from service providers of the Funds are paid using the net assets of the investment funds and are reflected as a separate component on the Statements of Changes in Net Assets Available for Benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Excess Contributions Payable

Amounts payable to participants totaling \$17,868 for contributions in excess of amounts allowed by the IRS are recorded as a liability, with a corresponding reduction in 2024 contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 17, 2025.

NOTE C – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

- Level 2 – inputs to the valuation methodology include the following:
 - Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies

- Mutual Funds: The fair value of mutual funds are determined by obtaining quoted prices on nationally recognized securities exchanges. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There were no changes in methodologies used at December 31, 2024 and 2023.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

The Plan’s policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024 there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

NOTE D – CERTIFIED INVESTMENT INFORMATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company, the trustee of the Plan.

NOTE E – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE F – TAX STATUS

The Plan adopted a pre-approved prototype plan offered by Ascensus LLC. The prototype plan received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 that the Plan and related trust are designated in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles (GAAP) requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the applicable authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

NOTE G – RELATED PARTY TRANSACTIONS and PARTY IN INTEREST TRANSACTIONS

Plan investments are managed by Ascensus Trust Company. Ascensus Trust Company is the trustee/record-keeper as defined by the Plan and, therefore investments and investment transactions qualify as party-in-interest transactions. Certain administrative functions related to the operation, recordkeeping and financial reporting of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Fees may be paid by the Plan for investment management services.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE H – RISK AND UNCERTAINTIES

The plan participants invest in various investment securities. Investment securities in general are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

The plan participants' exposure to a concentration of credit risk is limited by the diversification of investments across all fund elections. Additionally, the investments within each fund election are further diversified into varied financial instruments. Some of the Plan's investments may invest directly or indirectly in securities with contractual cash flows, such as asset-backed securities, collateralized mortgage

obligations, and commercial mortgage-backed securities, including securities backed by subprime mortgage loans. The value, liquidity, and related delinquencies or defaults, or both, may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

NOTE I – TERMINATION OF PARTICIPATING EMPLOYER COMPANIES

On February 29, 2024 Kappa Graphics, L.P. and Kappa Product Fulfillment Services, LLC both entered into an agreement providing the sale of certain assets to an unrelated corporation. As a result the Company had discontinued all salary deferrals as of the effective date of their final paycheck. Participants who are continuing employment with the acquiring corporation will have the option to rollover their balances into an existing plan at the new corporation. Participants also have the option to either keep their account balance in the Plan or receive distributions in accordance with plan provisions.

NOTE J – SUBSEQUENT EVENTS

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 6, 2025, the date the financial statements were available to be issued.
