- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### 1. DESCRIPTION OF THE PLAN

The following description of the *Dana Hourly Bargained Retirement and Savings Plan* (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering employees of participating U.S. facilities of *Dana Limited* (the "Company") who belong to certain collective bargaining units represented by the International Union, United Automobile, Aerospace, and Agricultural Implement Workers of America, the United Steel Workers and the International Association of Machinists and Aerospace Workers, and its Local No. 2293, AFL-CIO (the "IAM") (together, the "Unions"). Employees are eligible to participate in the Plan as of the later of their date of hire or the date which they become a member of one of the covered collective bargaining units. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

In an effort to align participation under the Company's two defined contribution plans between union and nonunion employees, the Plan transferred account balances totaling \$550,487 in 2024 to the Dana Retirement Savings Plan ("the Savings Plan"). Balances totaling \$3,899,095 in 2024 were transferred from the Savings Plan to the Plan. Employees whose balances were transferred between plans became participants in the plan into which the balances were transferred, on or near the date their balances were transferred.

#### *Administration*

Dana Incorporated is the Company's parent. The Plan is administered by the Dana Incorporated Investment Committee (the "Investment Committee") who is responsible for oversight of the Plan and the appropriateness of the Plan's investment offerings and monitors investment performance. The Investment Committee has caused the Plan to enter into a trust agreement with Vanguard Fiduciary Trust Company ("Vanguard") to hold the Plan's investment assets and execute investment transactions in accordance with the terms of the Plan document.

## DANA HOURLY BARGAINED RETIREMENT AND SAVINGS PLAN

### Notes to Financial Statements

#### *Contributions*

Subject to certain limits established by the Internal Revenue Service (the "IRS"), participants may contribute up to 50% of annual eligible compensation each year on a pre-tax basis, on an after-tax basis, as Roth 401(k) contributions, or a combination thereof, as determined under the Plan document. Participants who attain age 50 before the end of the Plan year are eligible to contribute an additional amount to the Plan without regard to the IRS' general contribution limits. The additional maximum contribution amount was \$7,500 in 2024. Participants may also make rollover contributions from other qualified retirement plans. The Company automatically enrolls newly hired eligible employees into the Plan at a rate of 3% unless they affirmatively elect not to make deferral contributions. Deferrals and Company contributions for these participants are invested in the applicable target date retirement trust unless they elect otherwise. The Company makes nonelective contributions to the Plan in an amount equal to 3% of compensation for those participants actively employed as members of the bargaining units listed in the Plan document who are not accruing benefits under any defined benefit pension plan maintained by the Company or the IAM or having contributions made by the Company to the Steel Workers National Pension Trust on their behalf. The Company also makes matching contributions for participants at certain facilities based upon terms of the collective bargaining agreements for those facilities, as specified in the Plan document.

The Company makes special contributions to each eligible participant's account of \$0.35 for each hour worked as defined by the Plan document.

Participants can direct the investment of contributions into various investment options offered by the Plan.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, the Company's special and matching contributions and an allocation of the Company's nonelective contributions based on eligible compensation or hours worked and Plan earnings based on the performance of each participant's selected investment options. Administrative expenses are allocated to participants' accounts as described in Note 2.

#### *Vesting*

Participants are completely vested in their individual contributions and related Company nonelective, matching and special contributions at all times. The Company reserves the right to impose future vesting requirements on Company contributions to the Plan.

### *Notes Receivable from Participants*

Participants may borrow from their compensation deferral accounts (including that portion of their prior plan fund accounts) a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balances. The \$50,000 maximum note amount is reduced by the excess of the highest outstanding note balance during the previous 12-month period over the outstanding note balance as of the date the new loan is made. A participant, other than a former participant of the Fairfield Plan, may not have more than one loan outstanding at any time. The notes receivable are secured by the balance in the participant's account and bear interest at 1% above prime rate quoted by *Reuters* on the last day of the calendar quarter preceding the inception of the loan (rates ranging from 4.25% to 9.50% at December 31, 2024). Principal and interest are collected ratably through payroll deductions over a period not to exceed 5 years (10 years [30 years for former participants of the Fairfield Plan] if proceeds are used for the purchase of a principal residence).

### *Payment of Benefits*

Upon termination of service, disability, or retirement (as such terms are defined in the Plan document), a participant may elect to receive a lump-sum amount equal to the value of the participant's account. For those participants who had account balances transferred from other Company retirement plans pursuant to a direct trustee-to-trustee transfer or plan merger, various optional forms of benefit distributions that the former plans allowed, such as installment or annuity payments, are available for those transferred amounts. If the participant's account balance is \$1,000 or less, payment will be made in a lump-sum without the participant's consent. If the account balance is greater than \$1,000 but does not exceed \$7,000 (\$5,000 prior to March 1, 2024), payment will be made as a direct rollover to an individual retirement account at Vanguard, or such other provider as the Company designates in accordance with Department of Labor ("DOL") guidelines, unless the participant requests a different disposition of their account balance within the applicable election period. In-service withdrawals may be elected by participants who have reached 59½ years of age. The Plan also permits withdrawals of after tax and rollover contributions and earnings on those contributions and active participants' elective contributions only in amounts necessary to satisfy financial hardship, as defined by the Plan document. Participants who are employees of the Fort Wayne bargaining units are eligible to make hardship withdrawals from specified portions of their accounts during weeks in which they are on temporary or indefinite layoff.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### *Basis of Accounting*

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### *Use of Estimates*

The preparation of financial statements in accordance with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments includes the Plan's aggregate gains and losses on investments bought and sold as well as held during the year.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the note receivable to be in default, according to the terms of the Plan document, the participant note receivable is reduced and a deemed distribution of notes receivable from participants is recorded.

### *Contributions*

Participant contributions are recorded when withheld from compensation. Employer contributions are recorded in the period in which they become obligations of the Company.

### *Benefits Paid to Participants*

Benefit payments to participants are recorded when paid.

### *Administrative Expenses*

The Plan's administrative expenses, including audit and legal fees and salaries related to administration of the Plan, qualify as party-in-interest transactions that are exempt from ERISA's prohibited transaction rules.

Plan expenses and fees generally fall into three categories:

#### *Investment Fees*

These fees are borne by the participants and are generally assessed as a percentage of assets invested. They are paid in the form of an indirect charge that is deducted directly from investment returns. The participant's net total return is the return after these fees have been deducted. A portion of these fees are also used by Vanguard to pay Plan administrative expenses as discussed below.

### Plan Administrative Expenses

These are the fees that cover basic administrative services (such as Plan recordkeeping, audit, legal, investment advisory and trustee services) necessary for the Plan's day-to-day operations. A portion of the investment fees deducted from participant investment returns are used to indirectly subsidize Plan administrative expenses. Fees for investment advisory and recordkeeping services are paid by the Plan. The remainder of administrative expenses (other than individual service fees described below) are paid by the Company and are excluded from these financial statements.

### Individual Service Fees

In addition to overall administrative expenses, there are individual service fees associated with optional features offered under the Plan. Individual service fees are charged separately to the accounts of individuals who choose to take advantage of a particular Plan feature or who are subject to a fee based on a particular set of facts such as the receipt of a domestic relations order from a family court. Also, participants with an outstanding note receivable are charged an annual maintenance fee for the term of the note.

### **Subsequent Events**

In preparing these financial statements, Plan management has evaluated, for potential recognition or disclosure, significant events or transactions that occurred during the period subsequent to the most recent statement of net assets available for benefits presented herein, through the date these financial statements were available to be issued.

## 3. CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net change in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to and derived from information certified as complete and accurate by Vanguard.

## 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;

- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy of each of the Plan's assets and liabilities is based on the lowest level of any input that is significant to the fair value measurements. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Shares held in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trusts:* These investments are public investment securities valued using the NAV provided by Vanguard. The NAV is used as a practical expedient to estimate fair value and, as a result, the investments are classified as "other" and not assigned a level in the fair value hierarchy. The NAV is quoted in a private market that is not active; however, the unit price is based on underlying investments which are traded in an active market. This practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

### 5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are in funds and accounts that are managed by affiliates of Vanguard. Participant loan and distribution processing fees are paid to Vanguard by participants. The Plan paid for recordkeeping, investment advisory, and plan audit fees which qualify as party-in-interest transactions. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. Certain management fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on investments. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

#### 6. TAX STATUS

The Plan has received a favorable determination letter dated August 24, 2017 from the IRS, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (the "IRC"). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's legal counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, that the Plan is qualified and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. While the Plan may be subject to routine audits by taxing jurisdictions, there are currently no audits for any tax periods in progress.

#### 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the full value of each participant's account as of the valuation date coincident with or next following the effective date of such termination would immediately become distributable to the participant or transferred to a successor plan, as applicable.

#### 8. RISKS AND ECONOMIC UNCERTAINTIES

The Plan invests in various investment securities with the underlying assets consisting of any combination of stocks, bonds, fixed income securities, and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of interest rate, market, and credit risks inherent with certain of the Plan's investment securities, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes in net assets available for benefits.
