**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Jackson County Bank Deferred Savings Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General and Eligibility: The Plan was established July 1, 1997 and is a qualified salary reduction 401(k) plan. The Plan covers substantially all employees of Jackson County Bank (“Company”). All employees (with exception to the subsequent exclusions listed) are eligible for elective deferrals and matching contributions. Eligibility terms for profit sharing contributions include an age requirement of 20.5 years and at least 6 months of service (not to exceed 12 months of service). Employees who are excluded from the plan are union employees, nonresident aliens, leased employees, and residents of Puerto Rico. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, participants may contribute up to 100% of eligible compensation, as defined in the Plan not to exceed the limits of Code Sections 401(k), 404 and 415. Employees are automatically enrolled at a 4% rate upon becoming eligible to participate in the Plan. Following enrollment at 4%, participants’ deferral percentages will automatically increase based on the Qualified Automatic Contribution Arrangement (QACA) statutory schedule within the adoption agreement. This schedule will automatically increase the deferral percentage of a participant based on their Plan Year of application, with the automatic deferral rate increasing to 5% after two years and 6% after three years. Each participant may elect to change or discontinue deferrals at any time. Any participant who is age 50 by the end of the plan year may contribute additional “catch-up” contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The employer will make a safe harbor matching contribution and a discretionary profit-sharing contribution. Employees are immediately eligible to receive the safe harbor matching contributions upon employment of 100% of up to 4% of employee compensation contributed. To be eligible for the employer profit sharing contributions, the employee must complete a year of service. There were no employer profit sharing contributions made to the Plan for the year ended December 31, 2024.

Participant Accounts: Each participant’s account is credited with the participant’s contribution, an allocation of any Company contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options: Each participant may direct his or her contributions into any of the investment options available under the Plan. Participants may change their investment options at any time.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are immediately vested in their own contributions plus earnings thereon. Vesting in the Company’s matching and discretionary contributions portion of participant accounts plus actual earnings thereon is based upon years of continuous service. A participant is 100% vested after three years of credited service.

Payment of Benefits: Upon termination of participation, the participant is entitled to the value of his or her vested account as soon as administratively feasible following the date on which the distribution is requested. Benefit payments are made in the form of a lump-sum cash distribution or installments. The plan provides automatic lump sum distribution for accounts less than \$5,000. The account will automatically rollover into an IRA if the balance is less than \$1,000. Withdrawals may also be made under Plan provisions that allow

for in-service distributions if normal retirement age (65) has been reached. Hardship distributions are allowed, subject to limitations in the Plan agreements. Active participants may also take distributions from the Plan upon attainment of age 59 ½.

Notes Receivable from Participants: Participants may borrow from their fund accounts with a minimum amount of \$1,000 and up to a maximum of the lesser of \$50,000 or 50 percent of their vested account balance with no minimum balance required. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid through payroll deductions. The term of the notes cannot exceed five years, except for notes used to purchase a principal residence, which may have a term up to ten years. At December 31, 2024, the interest rate on outstanding notes was between 4.25% and 9.5%. The notes receivable outstanding are due in various amounts through July 12, 2030.

Forfeitures: Forfeitures may be the result of matching contributions that relate to excess deferrals or excess contributions or the result of a participant's termination of service prior to being vested in the employer contribution. All forfeitures will be applied first to offset the employer contribution and then to pay expenses of the Plan. During 2024, \$13,508 of unvested balances from terminated participants were added to the Plan's forfeiture account. The amount of forfeitures used to reduce employer contributions was \$29,969 for the year ended December 31, 2024. Forfeited accounts available as of December 31, 2024 and 2023 to offset future employer contributions equaled \$4,902 and \$21,363, respectively.

Administrative and Investment Management Expenses: Loan origination fees associated with notes receivable from participants and the Plan's record keeping fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan. All other expenses of the Plan are paid by the Company.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Contributions: Participant contributions are recognized in the year withheld. Employer matching and profit-sharing contributions are recognized upon authorization and in the year the underlying compensation is recognized under the Plan. All participant and employer contributions are participant-directed. Participant contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction in contributions.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that

such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit responsive investment contracts, which are reported at contract value, are reported at fair value as further described in Note 4. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest is recorded on the accrual basis. Related fees are recorded as administrative expense and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023 as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. If a participant ceases to make loan payments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits: Benefits are recorded when paid.

**NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable and contract value from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends from investments, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Standard Insurance Company (the trustee of the Plan).

**NOTE 4 - FAIR VALUE**

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and gives the lowest priority to unobservable inputs (level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability. In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. Transfers between hierarchy measurement levels are recognized by the Plan as of the end of the reporting period.

The following are descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments held by the Plan.

*Pooled separate accounts:* The fair values of participation units held in pooled separate accounts are based on their net asset values (NAV) reported by the fund managers as of the financial statement dates and recent transaction prices. The NAV is used as a practical expedient to measure fair value. Each of the pooled separate accounts invests in a single, open-ended mutual fund which is generally identified in the name of the pooled separate account. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's NAV.

**NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS**

The Plan holds fully benefit-responsive investment contracts that are reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the Plan's fully benefit-responsive investment contracts is presented below:

Traditional Guaranteed Investment Contract: The Plan holds a benefit-responsive deposit administration contract with Standard Insurance Company (Standard). Standard maintains the contributions in its general account. Standard guarantees the Plan a return of principal and interest under the terms of the contract. The interest crediting rate is updated monthly based upon contract provisions. Standard's general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of the Issuer or otherwise.

The contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances may include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. The issuer may terminate the contract for reasonable cause. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company and certain others. Certain administrative functions are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan. Plan investments are units of participation in a pooled separate account and a deposit administration account managed by Standard Insurance Company, a service provider to the Plan, and therefore, these qualify as party-in-interest investments. Notes receivable from participants also reflect party-in-interest transactions. The Plan paid fees to Standard Insurance Company of \$29,675 in 2024, which qualifies as a party-in-interest transaction.

**NOTE 7 - RIGHTS UPON PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100% vested in their accounts.

**NOTE 8 - TAX STATUS**

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Company believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and that, therefore, the Plan continues to qualify under Section 401(a) and the related trust continues to be tax-exempt as of December 31, 2024. Therefore, no provision for income taxes is included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9 - SUBSEQUENT EVENTS**

Effective May 2025, the Plan's recordkeeping and administrative services were transitioned from Standard Insurance Company to Voya Institutional Trust Company. The decision to change service providers was made by the Plan Administrator in order to enhance operational efficiencies and provide expanded participant services.

In connection with this transition, all participant accounts, investment elections, and related records were transferred to Voya Institutional Trust Company. The transfer was completed without impact to participants' account balances or the net assets available for benefits.

The Plan Administrator has evaluated the transition and determined that the change in service providers does not have a material impact on the Plan's financial statements.

Management evaluated subsequent events for the Plan for recognition and disclosure through October 9, 2025, the date the financial statements were available to be issued.
