Note 1 - Plan Description

The following description of Advanced Radiology Services, P.C. Cash Balance Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a cash balance defined benefit plan and covers all eligible shareholders of Advanced Radiology Services, P.C. and Strategic Administrative and Reimbursement Services, LLC (collectively, the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

U.S. Bank National Association (US Bank) is the Plan's custodian. US Bank invests all employer contributions, as well as earnings thereon, pursuant to the terms of the Plan. The ARS Retirement Plan Committee (the "Committee") serves as the plan administrator and is responsible for the general administration of the Plan. US Bank determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Funding Policy

The Plan's funding policy is for the Company to contribute an amount that will meet or exceed the annual ERISA minimum funding requirement. The Company has the right, but not the obligation, to contribute such additional amounts as it deems necessary or desirable to maintain the actuarial soundness of the Plan. All contributions to the Plan are made subject to the condition that such contributions are fully deductible for federal income tax purposes. Participant contributions are neither required nor permitted under the Plan.

Eligibility and Vesting

Shareholders are enrolled in the Plan on the first day of the month following the completion of one hour of service as a shareholder-employee. All participants have a 100 percent vested and nonforfeitable interest in their cash balance accounts at all times.

Benefit Payments

Benefits are payable to the participant or beneficiary at the time of retirement, disability, termination, or death. The normal retirement date is the day the participant attains 65 years of age.

The normal form for married participants is a qualified joint and survivor annuity. For single participants, it is a single life annuity. In lieu of the normal form of retirement benefit payment, all participants may elect to receive a lump-sum benefit, and married participants may also elect other annuity methods.

Accrued Benefits

A notional account is established and maintained for each participant. Participant cash balance accounts are credited on an annual basis with contribution allocations based on level of participation, employment status and age as defined by the plan document. Additionally, accounts are adjusted monthly to reflect an interest credit at a guaranteed 4 percent annual interest rate. The minimum benefit payable under the Plan equals the sum of all contribution allocations that have been credited to the participant's cash balance account. A participant's accrued benefit under the Plan is expressed as a life annuity that is the actuarial equivalent of the participant's cash balance account.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by U.S. Bank National Association or its affiliates. U.S. Bank National Association is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Death Benefits

If a participant dies prior to the annuity start date, the total value of the participant's account will be paid to the surviving spouse or other designated beneficiary using the payment method selected by the surviving spouse or other designated beneficiary.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value.

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by investment advisors and the custodian. See Note 6 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Administrative expenses of maintaining the Plan are paid by the Company. Expenses paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments. Personnel and facilities of the Company have been used by the Plan for its accounting and other activities at no charge to the Plan.

Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, that are attributable, under the Plan's provisions, to the service employees have rendered. These include benefits expected to be paid to:

- (a) Retired or terminated shareholders or their beneficiaries
- (b) Beneficiaries of shareholders who have died
- (c) Present shareholders or their beneficiaries

Benefits are based on the notional cash balance accounts. Benefits payable under all circumstances, retirement, death, disability, and termination of employment are included to the extent they are deemed attributable to shareholder service rendered to the valuation date.

Actuarial Assumptions

The actuarial present value of accumulated plan benefits is determined by an actuary and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and probability of payment (by means of decrement, such as death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

Note 2 - Summary of Significant Accounting Policies (Continued)

The significant actuarial assumptions used in the valuation of the Plan at December 31, 2023 are summarized as follows:

Life expectancy	2023 Static Mortality Table for annuitants and nonannuitants
Retirement age	Normal retirement age, or age on valuation date, if greater
Actuarial cost method used	Accrued benefit cost method
Interest rate	5.29 percent

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

Contributions to the Plan and the accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics. Due to the changing nature of these assumptions, it is at least reasonably possible that changes in these assumptions will occur in the near term and, due to the uncertainties inherent in setting assumptions, that the effect of such changes could be material to the financial statements. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. It is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 3, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

U.S. Bank National Association (the "Custodian") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedules of assets held at end of year and reportable transactions are based solely on information certified by the Custodian.

Note 5 - Tax Status

On March 10, 2018, the Internal Revenue Service stated that the prototype plan adopted by the Plan, as then designed, qualified under IRC Section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator and the Plan's tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is subject to examination by the Internal Revenue Service for the statutory period.

Note 6 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 7 - Plan Termination

In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- Annuity benefits that former shareholders or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan.
- Other vested benefits insured by the Pension Benefit Guaranty Corporation (PBGC) up to the applicable limitations, as described by ERISA.
- All other vested benefits (that is, benefits not insured by PBGC).
- All nonvested benefits.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to limitation.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the Company and the level of benefits guaranteed by the PBGC.

Summary of Plan Provisions

Advanced Radiology Services Cash Balance Plan is a defined benefit pension plan that was established January 1, 2021. The plan year begins January 1 and ends December 31.

Eligibility To Participate

A shareholder becomes a participant in the Plan on the first day of the month following, or coinciding with, his first day of becoming a shareholder. Only employees who are shareholders are eligible to participate in the plan.

Normal Retirement Benefit

Normal Retirement Date

A participant is eligible for his normal retirement pension as of the first day of the month on or after the participant satisfies the following condition:

- Attainment of age 65.

Normal Retirement Benefit

The normal retirement pension is payable monthly as long as the participant lives, with payments ceasing upon the participant's death.

Normal Retirement Pension Formula

If the participant retires as of his normal retirement date, his monthly pension will equal the actuarially equivalent of his account balance. A participant's account balance is equal to the sum of the participant's principal credits and interest credits.

A participant shall earn a principal credit for each plan year in which the participant completes at least one hour of service in covered employment. The principal credit shall be credited to the participant as of the last day of the plan year or, if earlier, the date employment terminates or the employee is no longer a shareholder. The amount of the "Principal Credit" for each Participant shall be determined under Schedules B and C of the Plan Document.

Accrued Benefit

A monthly pension benefit, payable as a Single Life Annuity, beginning on the first day of the month following the Participant's Normal Retirement Date that is Actuarially Equivalent to the Participant's Account Balance as of such determination date.

Retirement Payment Options

A participant may elect to receive his monthly pension in one of these optional forms of payment:

- **Lifetime Pension**
- **Joint and Survivor Pension** with 100%, 75% or 50% survivor pension.
- **Lump Sum Payment** – If the present value of the vested pension does not exceed \$5,000, this is the only payment option. This payment option is not available if the Plan does not meet certain Internal Revenue Code funding requirements.

If the present value of the vested pension does not exceed \$1,000, the Plan will automatically distribute the benefit in cash if there is no election.

Summary of Plan Provisions

If the participant commences benefits prior to age 65, the Joint and 100% Survivor Pension option will not be available.

If the participant is married at the time payments are to begin, the automatic form of payment will be a Joint and 50% Survivor Pension with the spouse named as survivor annuitant. If the participant is not married at the time payments are to begin, the automatic form of payment will be a Lifetime Pension.

Employment after Retirement. If a participant in pay status returns to employment, retirement benefits will not be suspended.

Other Retirement Benefits

Late Retirement

If a participant continues working after his normal retirement date, his pension will not commence until he actually retires. The late retirement benefit is the greater of:

- The retirement benefit accrued as of the end of the preceding plan year, as actuarially increased; or
- The normal retirement benefit determined under the pension formula using benefit service to date.

Death Benefit

Preretirement Death Benefit

If a participant dies before he begins to receive a retirement pension benefit, his surviving spouse will receive a 50% survivor benefit if he has been married at least one year. The amount of his surviving spouse's benefit is equal to the 50% survivor benefit payable under the joint and 50% survivor pension option, based upon his accrued pension at the date of death. The 50% survivor form of payment can be waived by the participant and spouse, and be paid as a lump sum.

If the participant is not married or has not been married for a full year at the time of death, the Plan will pay the named beneficiary a preretirement death benefit equal to the present value of the participant's benefit accrued to date.

Termination Of Employment Benefits

Vesting in Accrued Pension

The participant is 100% immediate vesting upon participation in the Plan.

Time of Payment

After termination of employment, a participant may elect to receive his vested accrued pension as soon as administratively possible after the date of severance. The forms of payment available before the participant meets the requirements for normal retirement are: Lump Sum Payment, Lifetime Pension, and Joint and 75% or 50% Survivor Pension.

An active employee may elect to receive the vested accrued benefit once reaching the Normal Retirement Date. The same optional forms as described under the Normal Retirement Benefit section above will be available.
