Independent Auditor's Report

To the Plan Administrator
Fort Worth Community Credit Union Retirement Investment Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Fort Worth Community Credit Union Retirement Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Fort Worth Community Credit Union Retirement Investment Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Fort Worth Community Credit Union Retirement Investment Plan's ability to continue as a going concern for one year from the date of audit issuance.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

Supplemental Schedule Required by ERISA

The Supplemental Schedule of Assets (Held at End of Year) at December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements, but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. NOTE A - DESCRIPTION OF PLAN

The following description of the Fort Worth Community Credit Union Retirement Investment Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of the Fort Worth Community Credit Union (the “Company”, “Plan Sponsor”, “Plan Administrator”) as defined below. The Plan is designed to comply with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code, as amended (“IRC”). In addition, the Plan’s financial statements have been prepared in compliance with accounting principles generally accepted in the United States of America (“US GAAP”) and with ERISA.

Plan Administration

The Plan Sponsor is responsible for the administration and operation of the Plan. Standard Insurance Company (“Trustee”, “Standard”) serves as the Plan’s asset trustee and is responsible for custody and management of the Plan’s assets and for executing transactions. In addition, Standard provides recordkeeping services for the Plan which includes the responsibility for maintaining participant account records and transactions.

Eligibility

For elective contributions, employees who have completed one month of service and have attained age 18, excluding independent contractors, are eligible to participate in the Plan. Employees may enter the Plan on the first day of the month following the date eligibility requirements are satisfied.

Additionally, participants are eligible for non-elective contributions from the Plan Sponsor upon reaching the age of 21 and completion of one year of service. Participants may enter the Plan for these non-elective contributions on the first day of the quarter following the date eligibility requirements are satisfied.

Contributions

Participants may defer a specific percentage or dollar amount of their eligible compensation up to 92% of their total annual compensation, as defined, up to the maximum amount allowed by law (\$23,000 for 2024). This Plan also allows for catch-up contributions for participants over 50 years of age (\$7,500 for 2024) of pretax annual compensation.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan upon eligibility unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation.

The Company makes bi-weekly non-elective contributions of 3% of each participant’s eligible compensation to the Plan. The Plan also provided safe harbor matching contributions equal to 100% of each participant’s contribution up to 4% of their eligible compensation. Contributions are subject to certain limitations.

Participants direct the investment of their contributions and the Company contributions into various investment options offered by the Plan. The Plan currently offers several pooled separate account mutual funds and one guaranteed interest fund as investment options for participants.

Rollovers and Transfers

Participants who have a balance in another qualified employee benefit plan, as described in Section 401(a) of the Internal Revenue Code, may transfer or rollover the lump sum values of their account directly into the Plan, provided it meets the requirements of the Internal Revenue Code.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions, Employer's contributions, and allocations of investment earnings/losses and charged with administrative expenses. Allocations related to investments are based on the participant's account balance as a percentage of the total participants' account balances in each investment or the change in unit or share value of the individual investments.

Vesting

Participants are immediately vested in their elective contributions and the Plan Sponsor's safe harbor matching contributions, plus actual earnings thereon. Vesting in the Plan Sponsor's non-elective contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service as follows:

<u>Years of Service</u>	<u>Safe Harbor Vesting Percentage</u>	<u>Employer Non-Elective Vesting Percentage</u>
Less than 3	100%	0%
3 or more	100%	100%

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000, or 50% of their vested account balance, whichever is less. The loans are secured by the vested balance in the participant's account and bear interest which is commensurate with local prevailing rates (rates ranged from 3.25% to 8.5% at December 31, 2024) as determined by the Plan Administrator. All Plan loans must be repaid in 5 years, unless for the purchase of a principal residence in which case up to 15 years. In most cases repayment of the loan will be made through after-tax payroll deductions.

Payment of Benefits

Benefits become available to participants on the earliest of four events: (1) termination of employment, (2) death of the participant (benefits are payable to the participant's spouse or beneficiary), (3) upon the participant's retirement, or (4) disability. Benefits are payable as lump sums, rollover distributions, or installment distributions.

Terminating employees with vested account balances (including rollovers) below \$1,000 are paid in a lump sum. Terminating participants with balances greater than \$1,000 but less than \$5,000 may elect to request a rollover to another qualified plan or take a lump sum distribution. If the participant's account balance exceeds \$5,000, the participant may choose to keep the funds in the Plan, request a direct rollover to another qualified plan, or take a lump sum distribution. If no choice is made, the distribution is rolled over to an individual retirement plan designated by the Plan Administrator.

Payment of Benefits - Continued

On termination of service due to death prior to retirement or due to retirement after age 65, 100% of the Plan Sponsor contributions become immediately vested. The account balance is paid to the participant in a lump sum if the participant's vested balance is \$5,000 or less. If the vested balance exceeds \$5,000, the payout will be set up as an annuity starting as soon as administratively practicable. Should a participant reach age 65 and not elect to terminate employment, the participant can take an in-service distribution from the vested accounts balance. However, the participant is required to begin taking minimum distributions no later than April 1 of the calendar year following the calendar year the participant turns 72 or terminates employment, whichever is later. In-service withdrawals are permitted after age 59 ½.

If the participant becomes disabled and is eligible for Social Security disability benefits, or is determined disabled by a physician selected by the Plan Administrator, the full value of the participant's account becomes 100% vested.

Distributions during Employment

As a general rule, participant's contributions will remain in the Plan as long as the participant remains employed by the Plan Sponsor. The Plan does provide exceptions to this rule for withdrawals of the participant's contributions under certain circumstances (subject to the satisfaction of the Plan Administrator) that include the following:

- Medical expenses
- Purchase of a principal residence
- Post-secondary education for participant or their dependents
- To prevent eviction from or foreclosure on the participant's principal residence
- Participant reaches age 59 ½
- Hardship, as defined
- Required minimum distribution

Forfeitures

Forfeitures of terminated participants' non-vested account balances may be used to reduce future employer contributions. At December 31, 2024 and 2023, the balance in forfeited non-vested accounts was \$3,582 and \$1,727, respectively. In 2024, forfeited non-vested accounts totaling \$4,672 were used to reduce employer contributions.

Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in the net appreciation of fair value of investments.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with US GAAP and present the Plan's net assets available for benefits and changes therein. Investments are presented at fair value or contract value in accordance with US GAAP as prescribed for defined contribution plans.

Estimates

The preparation of financial statements in conformity with US GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates. Significant estimates include the fair value of investments.

Investment Valuation and Income Recognition

The Plan invests in pooled separate accounts ("PSAs") and a guaranteed interest general account ("GIA"). Investments in PSAs are valued at net asset value ("NAV") as a practical expedient to fair value as determined by the issuer. The net investment income of PSAs represents the change in NAV per unit of the individual PSA times the number of units held by the Plan in each individual PSA. The Plan's investment in the GIA is valued at contract value as determined by the issuer.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks as well as risks related to the financial strength of the insurance company. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments may not necessarily be indicative of amounts that could be realized in a current market exchange.

Contributions and Contributions Receivable

Contributions from participants are recorded based on the date the contributions have been separated from participants' pay by the Plan Sponsor, which is the pay date. The Plan records receivables for participants' contributions, if any, based upon contributions recognized, less amounts received by the Plan as of the last day of the Plan year.

Employer matching contributions are recorded in the year they are earned to coincide with the year which the Plan Sponsor records the contributions to the general ledger as an expense and reported on the Plan Sponsor's tax return. The Plan records receivables for employer matching contributions, if any, based upon the contributions recognized, less amounts received by the Plan as of the last day of the Plan year.

Payment of Benefits

Benefits are recorded when paid.

NOTE C - INVESTMENTS CERTIFICATION

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

In instances where the determination of fair value measurement is based on inputs from different levels of the fair value hierarchy, the level in the fair value hierarchy within which the entire fair value measurement falls is based on the lower-level input that is significant to the fair value measurement in its entirety.

As a practical expedient, units of PSAs are valued at NAV as determined by the issuer based on the fair value of the underlying investments less fund expenses. The Plan's investment in the fully benefit responsive GIA is valued at contract value (see Note E). Investments valued at NAV as a practical expedient and at contract value are not disclosed within the fair value hierarchy.

As of December 31, 2024 and 2023, there were no restrictions on redemption or unfunded commitments for any of the major types of assets.

NOTE E – INVESTMENT CONTRACTS WITH INSURANCE COMPANY

The Plan has entered into a guaranteed interest fund (“GIF”), a fully benefit-responsive investment contract with the Trustee. The Trustee maintains the Plan’s contributions in the GIF within its general account. The GIF is included in the financial statements at contract value. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than one percent. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date. Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) the Plan’s failure to qualify under Section 401(a) of the Internal Revenue Code (“IRC”) or the failure of the trust to be tax-exempt under Section 501(a) of the IRC; (2) premature termination of the contracts; (3) Plan termination or merger; (4) changes to the Plan’s prohibition on competing investment options; or (5) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan’s normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan’s investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; or (4) a material amendment to the agreements without the consent of the issuer.

NOTE F – NON-PARTICIPANT DIRECTED INVESTMENTS

The Plan’s participants direct all investments. There are no non-participant directed investments as of December 31, 2024 and 2023.

NOTE G - RELATED PARTY TRANSACTIONS

The Company paid certain Plan expenses totaling approximately \$117,000 during 2024 which are not reflected in the accompanying financial statements of the Plan.

The Plan incurred expenses totaling \$41,181 during 2024 for administrative and investment management fees from the Plan Trustee.

NOTE H - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act ("ERISA"). In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE I - TAX STATUS

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA sponsored by Standard Retirement Services Inc. On June 30, 2020, the Internal Revenue Service ("IRS") stated in an advisory letter that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA, as then designed, was in compliance with the applicable requirements of the IRC and therefore, the related trust is exempt from taxation. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified and the related trust is tax-exempt.

US GAAP requires the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE J - FIDELITY BOND

The Plan was covered by a \$9,000,000 fidelity bond during 2024 and 2023.

NOTE K – SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued. No subsequent events were noted for disclosure.
