1. Description of the Plan

The following description of OrthoTennessee 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions. Copies of the Plan Document are available from OrthoTennessee, P.C. (the “Plan Sponsor”).

General

The Plan is a defined contribution plan and is subject to the Employee Retirement Income Security Act of 1974 (ERISA). Substantially all employees of the Plan Sponsor that are age 21 or older and have completed one year of qualifying service are eligible to participate in the Plan.

Contributions

Each year, participants may contribute, on a pre-tax or Roth basis, up to 100% of their eligible compensation, as defined by the Plan Document, subject to certain Internal Revenue Service (IRS) limitations. In addition, participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants can change the investment options previously elected at any time.

Each payroll period, the Plan Sponsor contributes to the Plan an equal safe harbor matching contribution up to 4% of a participant’s compensation as defined in the Plan Document. The Plan Sponsor may also make a discretionary profit-sharing contribution to participants employed on the last day of the plan year. The Plan Sponsor made a discretionary profit-sharing contribution ranging from 6.5% to 9.33% of eligible compensation in 2024 and 2023.

For discretionary contributions, the Plan Sponsor may make periodic deposits to the Plan, which are maintained in certain investments, as directed by the trustees of the Plan. These discretionary contributions are then allocated to each participant account prior to April 15 of the following year, based on the eligibility of the participant at year-end, at which time the contributions and related earnings are distributed among the investment options according to the direction of the participant.

Cash contribution receivables, if any, are unsecured.

1. Description of the Plan (continued)

Participant Accounts

Individual accounts are maintained for each participant to reflect the participant's contributions, Plan Sponsor contributions, and investment earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective salary deferral contributions, rollover contributions from other qualified plans, Plan Sponsor safe harbor contributions, and related earnings thereon. Participants become fully vested in the Plan Sponsor's discretionary profit-sharing contributions after three years of service as follows:

3 or more	100%

Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures of terminated participants' non-vested accounts may be used to reduce plan expenses or future Plan Sponsor contributions. If a terminated participant is rehired by the Plan Sponsor, the participant may be entitled to a restoration of certain amounts forfeited, based on provisions in the Plan Agreement.

Forfeitures totaled \$37,397 in 2024 and \$42,283 in 2023. Forfeitures used to reduce Plan Sponsor contributions totaled \$53,537 in 2024 and \$33,941 in 2023. As of December 31, 2024, forfeited non-vested accounts totaled \$48,547 and \$45,632, respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts. The minimum amount of the loan is \$1,000, and the maximum amount is the lesser of one-half of the participant's vested account balance or \$50,000. Two loans may be outstanding at a time per participant, and the loans generally bear a reasonable interest rate. The loans are generally repayable in level periodic payments over various terms of up to five years, except for those utilized for the acquisition of a principal residence, which may be repaid over a period of time up to 30 years. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions.

1. Description of the Plan (continued)

Payment of Benefits

Upon termination of service, death, disability, or retirement, a participant (or his or her beneficiaries) shall receive a lump sum amount equal to the vested value of his or her account. Partial withdrawals or installments are only permitted for participants who must receive required minimum distributions in accordance with the IRC.

In-service hardship withdrawals are available in certain circumstances.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under plan provisions to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants will become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP), as are the annual returns filed under applicable provisions of ERISA and the Internal Revenue Code (IRC).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts in the Plan's financial statements. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Empower Trust Company, LLC (Empower) is the primary custodian that holds the assets of the Plan. Various other custodians exist for participant-directed brokerage accounts.

The maximum loss, if any, that would be incurred by the Plan if the counterparties to the Plan's investments failed to perform is the recorded amount of such investments. The investments, with the exception of its fully benefit-responsive contract, are stated at fair value. Fully benefit-responsive contracts are reported at contract value.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Upon default of notes receivable from participants, the entire outstanding principal and interest shall be immediately due and payable. If a distributable event, as defined by the IRC, has occurred, the note receivable will be foreclosed on and be offset against the participant's account balance. If a participant's note receivable is in default, the participant shall be treated as having a taxable deemed distribution whether or not a distribution event has occurred.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain plan administrative expenses are paid by the Plan Sponsor and are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net realized and unrealized appreciation or depreciation in the fair value of investments.

Subsequent Events

Plan management has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued.

3. Income Tax Status

The Plan adopted a volume submitter plan sponsored by SageView Retirement Plan Consultants, Inc. that received an advisory letter from the IRS dated June 30, 2020, which states the form of the plan is acceptable for use under applicable sections of the IRC. The Plan has been amended since the latest opinion letter date; however, the Plan Administrator believes the Plan is being operated in accordance with applicable requirements of the IRC and, accordingly, remains exempt from income taxes.

4. Certified Information (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including cash (\$250 and \$500 as of December 31, 2024 and 2023, respectively), investments (\$142,503,881 and \$134,210,381 as of December 31, 2024 and 2023, respectively), and notes receivable from participants held as of December 31, 2024 and 2023, as well as net realized and unrealized appreciation in the fair value of investments (\$9,770,603 in 2024 and \$14,032,190 in 2023), interest income from the guaranteed interest account, investment income (\$4,547,156 in 2024 and \$3,115,127 in 2023), and interest income on notes receivable from participants, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower and The Trust Company of Tennessee.

5. Other Investment Information

Other investment information of the Plan not certified totaled \$5,592,676 and \$5,433,597 as of December 31, 2024 and 2023, respectively. This other investment information as of December 31, 2024 and 2023 consisted of cash totaling \$49,130 and \$80,364, respectively, common stocks of \$1,347,696 and \$1,049,958, respectively, mutual funds and exchange-traded funds of \$4,195,850 and \$3,623,780, respectively, and annuities of \$679,495 as of December 31, 2023. These investments experienced investment income of \$102,114 in 2024 and \$127,742 in 2023. Net appreciation in these investments totaled \$497,359 in 2024 and \$741,960 in 2023.

6. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

6. Fair Value Measurements (continued)

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level of the asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for investments measured at fair value, which have not changed as of December 31, 2024 and 2023, except as noted below:

Mutual funds and exchange-traded funds, and annuities: Valued at the net asset value of shares held by the Plan at year-end.

Common stocks: Valued at the closing price reported on the active market on which the shares are traded.

Pooled separate account: Valued at the NAV which equals the number of shares of the respective underlying fund, multiplied by the closing NAV per share quoted by that fund. The NAV is used as a practical expedient to estimate fair value.

Common collective trusts: Valued at fair value using the NAV practical expedient as determined by the issuer based on the current fair values of the underlying assets of the fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7. Investment Contract with Empower

The Plan has a guaranteed interest account (GIA) with Empower that is a fully benefit-responsive investment contract. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIA issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the GIA is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the GIA. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of Empower or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on an annual basis for resetting.

7. Investment Contract with Empower (continued)

Certain events limit the ability of the Plan to transact at contract value with Empower. Such events include amendments to the plan documents (including complete or partial plan termination or merger with another plan), changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator believes any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

The GIA does not permit Empower to terminate the agreement prior to the scheduled maturity.

8. Other Party-in-Interest Transactions

Certain plan investments are in accounts with the custodians; therefore, these transactions are considered party-in-interest transactions.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. Delinquent Participant Contributions

Defined contribution plans are required to remit participant contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. During 2023, contributions totaling \$60,635 were not remitted within the required time period. During October 2024, the Plan Sponsor corrected these 2023 delinquent participant contributions, including remitting lost earnings to the Plan.
