Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Norwood Medical LLC Employee Savings Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Notes to Financial Statements

Note 1. Description of Plan

The following description of the Norwood Medical LLC Employee Savings Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan was effective January 1, 1990.

General: The Plan is a defined contribution plan covering employees of Norwood Medical LLC (the Company, Employer and Plan Sponsor) and its wholly owned subsidiaries. Employees who have one month of service and are age 18 or older are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant and rollover contributions: Each year, participants may contribute up to the lesser of 60% of pretax annual compensation, as defined in the Plan and the annual limit imposed by the law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans with approval from the Plan Sponsor.

There is a limit placed on the percent of compensation deferred by those participants defined as highly compensated employees. The Company determines that the salary deferral percentage complies with several tests as prescribed by law. If the tests are not met, the Company reduces the contribution percentage of the group comprising the highly compensated employees until the tests are met. If at the end of the year the tests are still not met, the Company will refund an amount of salary deferral made by the participants in the highly compensated group or make qualified nonelection contributions to certain nonhighly compensated employees.

Employer contributions: The Plan Sponsor provides a discretionary contribution equal to a percentage of each eligible individual's compensation. The exact percentage is determined each year by the Company's board of directors. The Plan Sponsor provided a match in 2024 equal to one-half of the funds contributed by each employee, to a maximum of 2% of eligible compensation.

Participant accounts: Each participant's account is credited with their contribution, the Company's discretionary contribution, if any, and actual earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their account plus actual earnings thereon is based on years of continuous service. Participants vest 20% per year of service after two years of service and are 100% vested after six years of service.

Investment options: The participant directs the investment of their contributions and the Company's discretionary contribution into various investment options offered by the Plan.

Payment of benefits: On termination of service due to death, disability, retirement or termination of employment, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in their account. Participants are allowed to take in-service distributions during employment if older than 59½ or for a hardship as defined in the Plan document. The minimum hardship withdrawal is \$500.

The Plan allows for automatic payment of a participant's vested balance upon termination, provided that the vested balance is less than \$5,000.

Note 1. Description of Plan (Continued)

Forfeited accounts: Forfeited, nonvested accounts totaled \$1,130 and \$2,765 at December 31, 2024 and 2023, respectively. These amounts are periodically used to reduce employer discretionary contributions or are reallocated among the participants' accounts. Forfeitures used to offset employer contributions during 2024 totaled \$146,104.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America as more explicitly described in the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC).

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Capital gain distributions are included in dividend and interest income.

Contributions: Participant contributions are recognized when earned. Employer discretionary contributions are recognized concurrently with participant contributions.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: The Plan Sponsor has elected to pay certain costs associated with Plan administration from its operating assets.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Subsequent events: The Plan has evaluated subsequent events for potential recognition and/or disclosure through October 1, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by the Plan's Trustee

The Plan's asset information included throughout the Plan's financial statements and supplemental schedule as of December 31, 2024 and 2023 and for the year ended December 31, 2024, was prepared by or derived from information provided by the trustee and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator by the trustee related to these assets are complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information in Note 4 and the supplemental schedule related to the Plan's assets.

The trustee, Fidelity Management Trust Company, also certified the completeness and accuracy of \$6,400,767 of net appreciation in fair value of investments. In addition, Fidelity Management Trust Company certified interest and dividends related to investments of \$3,135,818 for the year ended December 31, 2024.

Note 4. Fair Value Measurements

The Plan has determined the fair value of certain assets through application of accounting guidance that establishes a framework for measuring fair values. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under this standard are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds and money market funds: Valued at the closing price reported on the active market on which the individual securities are traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of transfer relative to total assets available for benefits.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6. Income Tax Status

Effective April 6, 2022, the Plan adopted a pre-approved defined contribution plan sponsored by Fidelity Management Trust Company. The Plan operates under a determination letter obtained on June 30, 2020, in which the Internal Revenue Service stated that the Plan is in compliance with the applicable requirements of the Internal Revenue Code (IRC); therefore, is not subject to tax. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan Administrator evaluated the Plan's tax positions and concluded that there are no uncertain tax positions that require recognition or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by tax authorities for years before 2021.

Note 7. Risks and Uncertainties

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Party-in-Interest Transactions

Fidelity Management Trust Company is the current trustee of the Plan and qualifies as a party-in-interest. The trustee performs services for the Plan, sells products to the Plan and manages and maintains certain investments of the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping and other services amounted to \$91,420 for the year ended December 31, 2024.
