## Report of Independent Auditors

## Notes to Financial Statements

December 31, 2024

### **1. Description of the Plan**

The following description of the Delaware Park & Affiliates 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan was adopted on July 1, 1997 and restated on May 5, 2021. The Plan is a deferred compensation plan under Section 401(k) of the Internal Revenue Code covering all employees of Delaware Park & Affiliates (the Company) who have reached the age of twenty-one and have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Trustees are responsible for the general administration of the Plan. Capital Bank and Trust Company is the custodian and American Funds is the record-keeper for the Plan.

#### **Contributions**

Each year, participants may contribute up to 100% of their annual earnings, subject to the limitations under applicable provisions of the Internal Revenue Code. The Company may make matching contributions to the Plan, at the discretion of the Board of Directors. The Company contributes 50% up to 6% of eligible compensation that a participant contributes to the Plan. The Company matching contribution for the year ended December 31, 2024 is \$438,557.

Participants will share in the matching contribution in the year they terminate employment as a result of death, disability or attainment of normal retirement age.

Effective January 1, 2020, the Plan was amended to include an automatic deferral feature. The Company will automatically withhold 1% of an employee's compensation upon meeting the eligibility requirement. The automatic deferral will be contributed to the employee's account in the Plan unless the employee makes a contrary election. If an employee who is automatically enrolled in the Plan subsequently does not want to participate in the Plan, the deferral can be refunded to the employee within ninety days of the first deferral.

## Delaware Park & Affiliates 401(k) Plan

### Notes to Financial Statements (continued)

#### 1. Description of the Plan (continued)

All contributions are subject to certain limitations of the Internal Revenue Code (the Code).

#### Participants' Investment Options

Upon enrollment, a participant may direct his or her contributions and any related earnings into any of the Plan's investment options. Participants may change their investment options daily. If a participant is automatically enrolled, his or her contributions are invested in the applicable target date funds based on his or her age until the participant changes his/her election. The Company's contributions are allocated in the same manner as that of the participant's elective contributions.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions and allocations of plan earnings, and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions and earnings thereon. Vesting in the Company's matching contributions is graded based on years of service according to the following schedule:

#### **1. Description of the Plan (continued)**

##### **Forfeitures**

Upon termination of employment, participants forfeit their nonvested balances. The portion of a terminated participant's account balance that is not vested at the date of termination can be used to reduce employer matching contributions or Plan expenses.

As of December 31, 2024 and 2023, \$12,428 and \$9,828, respectively, was available from forfeited non-vested accounts. The employer matching contribution at December 31, 2024 and for the year then ended has been reduced by \$12,630 from forfeited non-vested accounts.

##### **Participant Loans**

Active employees participating in the Plan may apply for a loan from the Plan. The minimum loan available is \$1,000 and all loans are limited to the lesser of 50% of a participant's vested account balance or \$50,000. Loans are secured by the balance in the participant's account. Interest rates are computed based on a rate comparable to those currently available from outside sources. Principal and interest are paid ratably through payroll deductions.

##### **Payment of Benefits**

A participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or a series of payments, in substantially equal amounts, upon termination of employment, death, disability or retirement. Participants, who are no longer employed by the Company, with vested account balances of \$5,000 or less, will be distributed in a lump sum as soon as administratively possible.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan.

### Notes to Financial Statements (continued)

#### **1. Description of the Plan (continued)**

##### **Administrative Expenses**

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Administrative expenses paid by the Plan include third-party investment fees, participant transaction fees, and record-keeping fees. Expenses relating to purchases, sales or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. All other administrative expenses of the Plan are paid by the Company and are excluded from these financial statements.

##### **Plan Termination**

Although it has not expressed any intent to do so, the Company's management has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### **2. Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Notes Receivable from Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

### Notes to Financial Statements (continued)

#### **2. Summary of Significant Accounting Policies (continued)**

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **3. Investments**

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, other income and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Capital Bank and Trust Company.

#### **4. Fair Value Measurements**

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

### Notes to Financial Statements (continued)

#### 4. Fair Value Measurements

- Level 2 – Inputs to the valuation methodology include:
  - Quoted prices for similar assets and liabilities in active markets
  - Quoted prices for identical or similar assets or liabilities in inactive markets
  - Observable inputs other than quoted prices that are observable for the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety. There were no transfers between the different levels within the fair value hierarchy.

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value by the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Interest-bearing cash:* Valued at cost which approximates fair value. Interest-bearing cash is held within the self-directed brokerage accounts.

*Mutual funds:* Valued at quoted market prices as reported on the active market in which the mutual funds are traded. One mutual fund is held within the self-directed brokerage accounts.

*Common and preferred stocks:* Valued at the closing market price reported on the active market on which the individual securities are traded. Common and preferred stocks are held within the self-directed brokerage accounts.

*Common collective trust fund:* Valued using the net asset value (NAV) as a practical expedient. The NAV is based on the underlying investments of the trust fund.

If the Plan initiates a full redemption, the issuer reserves the right to require notification in order to ensure that securities liquidation will be carried out in an orderly business manner.

#### **5. Risks and Uncertainties**

The Plan provides for investment options in various combinations of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to levels of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the short term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

#### **6. Related-Party and Party-in-Interest Transactions**

The Plan invests in shares of registered investment companies managed by American Funds. Additionally, certain officers and employees of the Company (who may also participate in the Plan) perform administrative services related to the operation, record-keeping and financial reporting of the Plan. The Company pays these individuals' salaries and other administrative expenses. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

#### **7. Tax Status**

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the written form of the underlying pre-approved document is qualified under Section 401 of the Internal Revenue Code (the Code). Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
