Report on the Audit of the Financial Statements ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Euler Hermes North America Insurance Company dba Allianz Trade Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Euler Hermes North America Insurance Company dba Allianz Trade Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). 

NOTE 1 DESCRIPTION OF PLAN

The following description of Euler Hermes North America Insurance Company dba Allianz Trade Retirement Savings Plan (the Plan), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Euler Hermes North America Insurance Company dba Allianz Trade Americas (the Company) as of July 1, 2000, and most recently amended January 1, 2025. The Plan is subject to the provisions of ERISA. The Plan covers all eligible employees of Euler Hermes Collections North America Company dba Allianz Trade Americas. Employees of the Company are eligible upon attaining the age of 18. Employees who are classified as part-time, temporary, or seasonal employees are eligible to participate upon attaining the age of 18 and completing one year of service, as defined in the Plan document as having worked 1,000 hours. The Plan does not cover nonresident aliens or leased employees.

Contributions

Eligible participants may contribute up to 100% of pre-tax annual compensation each year, as defined by the Plan, up to the maximum allowable annual contributions under the Internal Revenue Code (IRC). Participants can elect all or a portion of their elective deferrals as Roth deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit, defined contribution, annuity, and tax-sheltered annuity plans. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions up to annual limits set by the Internal Revenue Service (IRS).

New employees who meet eligibility requirements are automatically enrolled in the Plan at 6% unless they elect otherwise. Participants who are automatically enrolled will have their automatic deferral percentage increased as soon as administratively feasible on or after March 1 of each Plan year by 1% per year up to a maximum of 12%, unless they elect otherwise. The Company matches 100% of the first 3% of total compensation that a participant contributes to the Plan. The Company may also make an annual discretionary profit sharing contribution. For the year ended December 31, 2024, the Company made a profit sharing contribution of 5% of eligible participant's compensation, as defined in the Plan. To be eligible for the profit sharing contribution, a participant must meet the eligibility requirements set forth above and be employed on the last day of the Plan year. The discretionary profit sharing contribution was \$3,156,684 for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, matching contributions and allocations of the profit sharing contribution, plan earnings or losses, and administrative expense. Allocations are based on participant's eligible compensation, account balances, or participant transactions as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All accounts are participant directed.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive a lump sum, substantially equal installments, or partial withdrawal amount equal to the value of the participant's vested interest in their account. For termination of service due to other reasons, a participant may receive a lump sum or annuity payments equal to the value of the vested interest in their account. The Plan also allows for in-service withdrawals for hardships and participants who have reached the age of 59½ years old. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name. Effective April 1, 2024, the minimum cash out limit was increased from \$5,000 to \$7,000 under the SECURE Act.

Vesting

Participants are immediately vested in their contributions, plus actual earnings and losses thereon. Participants vest in Company contributions, plus actual earnings and losses thereon by the following vesting schedule:

1	50%
2	100%

In addition, upon death, permanent disability, or reaching normal retirement age of 65 years old or early retirement age of 55 with five years of service while being employed by the Company, a participant becomes 100% vested in their account balance.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. Participant's loans bear interest equal to the prime rate of interest, plus 1%, and will remain the same for the duration of the loan. Loan terms may range from one to five years, or longer if for purchase of a primary residence. Principal and interest are paid ratably through payroll deductions.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Forfeited Accounts

Available forfeitures were \$200,842 and \$64,145 at December 31, 2024 and 2023, respectively. These accounts will be used to satisfy future Company contribution requirements and pay Plan expenses. The Company used \$27,211 to fund Company contributions during the year ended December 31, 2024. The Company used \$2,590 of forfeitures to pay Plan expenses during the year ended December 31, 2024.

NOTE 2 SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates in Preparing Financial Statements

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Contributions

Contributions from participants and Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to participant transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFIED INVESTMENTS

Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively referred to as Empower), the qualified institutions of the Plan, have supplied the Plan administrator with certifications as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liabilities;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts and Variable Annuities: Valued at the NAV of units of the insurance company. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their entire accounts.

NOTE 6 RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Empower. Empower is the qualified institution and record-keeper as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net depreciation in fair value of the investment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 TAX STATUS

The Plan is placing reliance on an opinion letter from the IRS on the pre-approved plan indicating that the Plan is designed in accordance with the applicable section of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

NOTE 7 TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 RISK AND UNCERTAINTIES

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
