INDEPENDENT AUDITORS' REPORT

SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT

We performed audits of the accompanying financial statements of the Aegis Project Controls 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 DESCRIPTION OF PLAN

The following brief description of the Aegis Project Controls 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan offered to employees of the Aegis Project Controls Corp. (Company) who complete three consecutive months of service. Entry dates for the Plan are the first day of the month following completion of the eligibility requirement. There is no age requirement for these employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute up to 100% of compensation, as defined in the Plan, subject to certain annual limitations in the Internal Revenue Code. Unless a participant makes an affirmative election, the participant will be automatically enrolled in the Plan upon meeting the eligibility requirements at a deferral rate of 7% of compensation.

The Company may make discretionary and matching contributions for active participants in the Plan to be determined annually. During the year ended December 31, 2024 and 2023, the Company made matching contributions equal to 100% of the first 1% and 50% of the next 6% of participant deferrals.

Participant Accounts

Each participant's account is credited with the participant's contribution, Company contributions, and an allocation of Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant's account is charged with withdrawals and an allocation of administrative expenses.

Vesting

Participants are immediately vested in their voluntary and rollover contributions and actual earning thereon. A participant's interest in employer matching contributions generally becomes fully vested upon two years of service, retirement, disability (as defined by the Plan), or death of the participant. A participant's interest in Company discretionary contributions generally becomes fully vested upon six years of service, retirement, disability (as defined by the Plan), or death of the participant.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions into various investment options offered by the Plan. Specific information regarding these options may be obtained from the Plan Administrator. Participants may change their investment options at any time.

Notes Receivable From Participants

Participants may borrow an amount from the Plan collateralized by their account balance. The minimum borrowing amount of any loan is \$1,000. The number of loans approved for a participant in any 12-month period shall be limited to five, and participants may not have more than one loan outstanding at any given time. Loan terms require amortization of principal and interest over a period not to exceed five years. Loans used to acquire a principal residence may extend beyond a five-year term. Loans bear interest at a rate comparable to rates charged by commercial lending institutions for loans of similar terms. Loans are repaid through payroll deductions and may be repaid in full at any time.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$9,360 and \$8,457, respectively. During the year ended December 31, 2024, Company contributions and administrative expenses were reduced by \$8,416 from forfeited non-vested accounts, in accordance with the Plan agreement.

Payment of Benefits

Upon termination of employment or service due to retirement, disability, or death, a participant or beneficiary has the right to receive distribution of the participant's vested interest in the Plan in the form of fixed period and fixed payment installment options. If the balance of the account is less than \$1,000, the balance is automatically distributed as a lump-sum payment. Benefits from the Plan for terminated participants whose vested account balances are greater than \$1,000 but not more than \$5,000 and who do not make payment elections shall be rolled over to individual retirement accounts designated by the Plan Administrator.

Plan Expenses

Substantially all administrative expenses incurred by the Plan are paid by the Company.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. Upon

termination of the Plan, all interest of the participants not previously vested would become vested and non-forfeitable, and the net assets of the Plan would be distributed to participants based upon individual equities in the Plan.

NOTE 2 **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Accounting Standards Codification

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

Basis of Presentation

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with GAAP in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Valuation of Investments

Investments are reported at fair value, except for fully benefit responsive investment contracts, which are reported at contract value. See Note 4 for a discussion of fair value measurements.

Notes Receivable From Participants

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with

certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Subsequent Events

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through September 23, 2025, the date the financial statements were available to be issued.

NOTE 3 INFORMATION CERTIFIED BY THE TRUSTEE

Financial information related to investments is included in the accompanying financial statements based on information certified as complete and accurate by the Trustee, Principal Trust Company. The information was not audited by the Plan's independent auditors. As of December 31, 2024 and 2023, certified investment information consisted of the following:

NOTE 4 VALUATION OF INVESTMENTS

Investments are recorded at fair value in accordance with the provisions of the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the Codification are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodology used for assets measured at fair value. There was no change in the methodology used at December 31, 2024 and 2023.

Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 **GUARANTEED INVESTMENT CONTRACT**

The Plan has an investment in the Principal Life Guaranteed Income Fund Account (Principal), which is a fully benefit-responsive investment contract and, therefore, reported at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the fund, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the Plan's ability to transact at contract value with the issuers. Such events include the following: (a) amendments to the Plan agreement (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan Administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 6 **INCOME TAX STATUS**

The Plan Administration adopted the Principal Financial Group prototype plan. The prototype plan received a letter dated June 30, 2020, in which the Internal Revenue Service stated the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan was amended since receiving the letter, and the Plan Administrator believes the Plan is currently designed and operating in compliance with the applicable

requirements of the Internal Revenue Code. Therefore, no provision for income taxes was included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions taken as of December 31, 2024.

NOTE 7 RELATED-PARTY TRANSACTIONS

Certain Plan investments are managed by the Trustee of the Plan. The Plan pays administrative fees to parties in interest. The Plan paid approximately \$53,000 to parties in interest for the year ended December 31, 2024. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

In addition, administrative fees were paid indirectly through revenue sharing and are included in the net appreciation in fair value of investments.
