INDEPENDENT AUDITOR'S REPORT

To the Participants and Board of Trustees of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Sandusky Newspapers Group 401(k) Retirement Plan and Trust (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions, Transamerica Life Insurance Company (“Custodian”) as of and for the years ended December 31, 2024 and 2023, State Street Bank and Trust Company as of and for the period ended October 1, 2024 and as of and for the year ended December 31, 2023, and Transamerica Trust Company (“Trustee”) and Reliance Trust Company (“Trustees”) as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor’s

Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. NOTES TO FINANCIAL STATEMENTS

Sandusky Newspapers Group 401(k) Retirement Plan and Trust

1 Participant Employers of the Plan

The Sandusky Newspapers Group 401(k) Retirement Plan and Trust (the "Plan") includes the following related group members collectively known as the "Employer": Sandusky Newspapers, Inc.; Kingsport Publishing Corporation; Ogden Publishing Corporation; Reflector-Herald, Inc.; Grand Haven Publishing Corporation; Johnson City Publishing Corporation; Erwin Publishing Company, Inc.; Jonesborough Publishing Company, Inc.; Tomahawk, Inc.; Lebanon Publishing Company, Inc.; Sandusky Digital Sales Development, Inc; and Six Rivers Media, LLC. The Plan operates under agreements between the related group members and the Trustees and Custodian. Ogden Publishing Corporation was sold on May 14, 2018, which resulted in a partial plan termination. As a result of the partial plan termination, all of the Plan participants at Ogden became 100% vested.

Grand Haven Publishing Corporation and Lebanon Publishing Company, Inc. were sold on May 31, 2019. In addition, Sandusky Newspapers, Inc. and Reflector-Herald, Inc. were sold on July 31, 2019. These transactions resulted in a partial plan termination and as a result, all of the Plan participants at these Companies became 100% vested.

Six Rivers Media, LLC became a participating member of the Plan effective December 31, 2019. Kingsport Publishing Corporation, Johnson City Publishing Corporation, Erwin Publishing Company, Inc., Jonesborough Publishing Company, Inc. and Tomahawk, Inc. were merged into Six Rivers Media, LLC and ceased to be participating members of the Plan effective December 31, 2019.

2 Description of Plan

The following description of the Plan provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all common law employees of the Employer who have completed one "Year of Service" (as defined by the Plan) and are age twenty-one or older, except those persons who are members of a unit of employees covered by a collective bargaining agreement where retirement benefits were a subject of good faith negotiations, unless a labor agreement has been adopted causing the Plan to be applicable to such persons. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Participant Elected Contributions – Participants may elect salary reduction contributions up to the maximum amount allowed by law. Eligible participants may also make catch-up contributions. ROTH deferral option is available under the Plan. Participants may increase or decrease the amount of contributions made to the Plan on any business day effective with the next pay. The Plan includes an automatic contribution arrangement for newly eligible participants. The Employer will withhold 4% of compensation each pay period unless the Participant affirmatively elects not to withhold.

Rollover and Transfer Contributions - Rollover contributions from other plans are also accepted, provided certain specified conditions are met.

2 Description of Plan, Continued

Contributions, Continued:

Employer Discretionary Matching Contributions - The Employer, at its sole discretion, may contribute matching funds to the Plan, determined on an annual basis. The contribution amount, if any, will be determined as a percentage of each participant's elected contribution. Participants that have completed at least 1,000 hours of service and are employed on the last day of the Plan year are eligible if the Employer elects to make matching contributions.

The Employer matching contribution for 2024 and 2023 was fifty percent (50%) of the first four percent (4%) of the participants' compensation deferred pursuant to a Salary Reduction Agreement.

Employer Discretionary Profit Sharing Contributions - On an annual basis, the Employer, at its sole discretion, may make a profit sharing contribution to the Plan. These funds are allocated to all eligible Plan participants who, during the Plan year, completed a year of service and are employed by the Employer at the end of the Plan year regardless of whether they make participant elected contributions to the Plan.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code, as defined in the Plan agreement.

Participants' Accounts:

Each participant's account is credited with the participant's contribution and allocations of the Employer matching and profit sharing contribution, if made, and earnings and losses thereon. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participants' non-vested accounts are used to reduce future employer contributions and Plan expenses.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's matching and profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of credited service. A participant is 100% vested after six years of credited service.

2 Description of Plan, Continued

Forfeited Accounts:

The Plan received \$2,228 and \$2,435 of forfeitures for 2024 and 2023, respectively.

The Plan used forfeitures of \$2,000 (2024) and \$2,000 (2023) to reduce the Employer's matching contribution.

Forfeited non-vested accounts totaled \$2,392 and \$3,031 as of December 31, 2024 and 2023, respectively. Employer contributions and Plan expenses were or will be reduced by these amounts.

Notes Receivable from Participants:

In accordance with Plan provisions, participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are repaid over a period not to exceed 5 years with exceptions for the purchase of a primary residence. The loans are secured by the balance in the participants' accounts and bear interest at rates equivalent to those charged by local lending institutions. Principal and interest are paid ratably through payroll deductions. The note becomes due and payable upon termination of employment with the Company. The notes are measured at their unpaid principal balance plus accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Payment of Benefits:

Upon termination of employment, retirement, death or disability, a participant may choose to receive the value of the vested interest in his or her account as either a lump sum distribution or rollover his or her account balance to a new qualified Plan. Participants with account balances of \$5,000 or more, may choose to leave his or her account balance with the Plan.

The Plan also provides for mandatory distributions of certain small account balances upon severance of employment. A mandatory distribution is an eligible rollover distribution that is made without the participant's consent and that is made to the participant before he or she attains normal retirement age.

Investment Options:

Upon enrollment in the Plan, a participant may direct contributions in 1% increments to any of the investment options offered by the Plan. Once enrolled, participants may change their investment options daily.

3 Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's financial statements are prepared on an accrual basis of accounting.

Use of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties:

The Plan's investments include investments in mutual funds and a stable value fund with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Benefits.

Valuation of Investments:

Investments are stated at fair value. Marketable securities are reported at fair market value as of the balance sheet date. Fair values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker. The fair value of the stable value fund is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Gain on sale of investments and net unrealized gain includes the Plan's gains and losses on investments purchased and sold as held during the year.

Payment of Benefits:

Benefits are recorded when paid. There were no benefits due and payable to terminated participants at December 31, 2024 and 2023.

Contributions:

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. Matching contributions from the Employer are recorded in the year for which the employer contribution is paid.

Fees:

Fees are paid by the Plan, Employer, and participants.

The Plan paid \$23,554 and \$22,466 in investment advisory fees during 2024 and 2023, which were offset by \$12,432 and \$23,428 in variable asset charges received by the Plan during 2024 and 2023, respectively.

The Employer paid \$14,275 for professional fees at December 31, 2024 and 2023, respectively.

During 2024, participants paid fees of \$19,330 consisting of \$2,265 in loan fees, labeled "Loan initiation and maintenance fees" and wrap fees of \$17,065 associated with Vanguard targeted funds, labeled "Vanguard fees".

During 2023, participants paid fees of \$14,072 consisting of \$1,850 in loan fees, labeled "Loan initiation and maintenance fees" and wrap fees of \$12,222 associated with Vanguard targeted funds, labeled "Vanguard fees".

Plan Termination:

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Subsequent Events:

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through October 2, 2025, which is the date the financial statements were available to be issued.

4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- * Quoted prices for similar assets or liabilities in active markets.
- * Quoted prices for identical or similar assets or liabilities in inactive markets.
- * Inputs other than quoted prices that are observable for the asset or liability.
- * Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds:

The fair value of the mutual funds are based on quoted market prices and classified as a Level 1.

Stable Value Fund:

The fair value of the stable value fund is an investment in the general account of the Custodian and the value is guaranteed by the Custodian. Transactions (purchases and sales) may occur daily and the investment advisor may impose up to a 12-month delay period on all withdrawal requests. The stable value fund is a depository liability with no formal underlying maturities and is classified in Level 2 category of the valuation hierarchy.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

7 Tax Status

The Plan adopted a pre-approved plan document from Transamerica Retirement Solutions LLC. On June 30, 2020, the Internal Revenue Service stated that the pre-approved Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.
