**Note 1. Description of the Plan**

The following description of Nebraska Spine Center, LLP 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan sponsored by Nebraska Spine Center, LLP (Company) and participating employers Jeremiah Ladd, MDPC, Michael C. Longley, MDPC, GML Services, Inc., John W. McClellan, MDPC, Timothy A. Burd, MDPC, J. Brian Gill, MDPC, Scott Haughawout, DOPC, Matthew P. West, MDPC, Chase C. Woodward, MDPC, John D. Hain, MDPC, and Travis L. Bailey, MDPC for the benefit of its employees who have at least one year of service with 1,000 hours and are age 21 or older. Effective January 1, 2024, the Plan was amended to add Travis L. Bailey, MDPC, as a participating employer. Effective April 1, 2024, the Plan was amended to implement automatic deferral provisions and to modify the conditions of eligibility and entry date. With this amendment, employees who have at least six months of service and are age 21 or older are eligible to participate in the Plan. Additionally, effective April 1, 2024, Timothy Burd, MD, was added as a Trustee, J. Brian Gill was removed as a Trustee, and the Plan implemented a Qualified Default Investment Alternative per the amendment presented in Note 5. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Vanguard Group, Inc. (Vanguard) serves as Plan custodian with Ascensus Trust Company (Ascensus) serving as a subcontractor for Vanguard. Newport Group, Inc. serves as the administrator for the Plan.

***Contributions***

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 100% of their eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company makes safe harbor contributions of 3% percent of employees' compensation and profit-sharing contributions. The profit-sharing contributions are discretionary as determined by the Company's Board of Directors. Contributions are subject to certain limitations.

***Participant Investment Account Options***

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily. Effective April 1, 2024, the Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant made an affirmative election otherwise.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary and safe harbor matching contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. Participants' profit sharing contributions are fully vested after six years of continuous service.

***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or installments. Upon termination of service for other reasons, a participant may receive the value of the vested interest in their account only as a lump-sum distribution.

***Forfeited Accounts***

At December 2, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$4,788 and \$5,995, respectively. Forfeited nonvested accounts are used to reduce future employer contributions, reallocated to participants in the same manner as employer contributions, or to reduce plan expenses. In 2024 and 2023, plan expenses were reduced by \$1,969 and \$2,543, respectively, from forfeited nonvested accounts.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds and money market funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions***

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which participant compensation is withheld.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements:

- Investments as shown in the statements of net assets available for benefits as of December 2, 2024 and December 31, 2023.
- Investment income as shown in the statements of changes in net assets available for benefits for the period January 1, 2024 to December 2, 2024 and for the year ended December 31, 2023.

The Plan's independent auditor did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

**Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain plan investments are shares of mutual funds managed by Vanguard. Vanguard is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan sponsor pays directly any other fees related to the Plan's operations.

The Plan paid \$81,188 and \$74,729 of recordkeeping fees to Vanguard during the period January 1, 2024 to December 2, 2024 and for the year ended December 31, 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

**Note 5. Plan Amendments**

Effective January 1, 2024, the Plan was amended to add Travis L. Bailey, MDPC, as a participating employer.

Effective April 1, 2024, the Plan was amended to implement automatic deferral provisions and to modify the conditions of eligibility and entry date. With this amendment, employees who have at least six months of service and are age 21 or older are eligible to participate in the Plan. Additionally, effective April 1, 2024, Timothy Burd, MD, was added as a Trustee, J. Brian Gill was removed as a Trustee, and the Plan implemented a Qualified Default Investment Alternative.

Effective December 2, 2024, the Plan was merged and all plan assets were transferred into the FlexPEP(k) Pooled Employer 401(k) Plan held at Lincoln Financial Group (LFG). Plan assets transferred to the PEP were transferred into funds comparable to those offered by the previous custodian.

**Note 6. Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

**Recurring Measurements**

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

**Note 7. Transfer of Plan Assets**

On December 2, 2024, Nebraska Spine Center, LLP merged its Nebraska Spine Center, LLP 401(k) Profit Sharing Plan into the FlexPEP(k) Pooled Employer 401(k) Plan. An aggregate of \$21,005,586 was transferred out of the Plan at December 2, 2024 and is included as a transfer on the statements of changes in net assets available for benefits.

**Note 8. Tax Status**

The Plan operates under a volume submitter agreement sponsored by Newport Group, Inc. This plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
