1. Plan description:

General:

The zZounds Music, LLC 401(k) Profit Sharing & Trust (the "Plan") is a defined contribution plan covering all full-time employees of zZounds Music, LLC and its affiliates Mbira Technologies, LLC and Chirem, LLC (collectively referred to as the "Company") who have one year of service and are age 21 or older. The Plan is subject to the provisions of ERISA. The Plan Administrator is responsible for the oversight of the Plan, determines the appropriateness of investment offerings and monitors investment performance. Participants should refer to the plan document or summary plan description for a more complete description of the Plan's provisions.

Contributions:

Each year, participants may contribute up to 50% of annual compensation, as defined in the Plan. Participant contributions cannot exceed the maximum amount allowable by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. The Company contributes 50% of participant contributions that do not exceed 5% of eligible compensation. The Company may also contribute a discretionary amount of its annual net earnings (profit sharing) as determined by its Board of Directors and/or make non-elective contributions to the Plan. The Company made no profit sharing or non-elective contributions for the year ended December 31, 2024.

Participant accounts:

Each participant's account is credited with the participant's contributions, Company contributions and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately 100% vested in both their contributions and Company contributions.

Notes receivable - participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Loans bear interest at the prime rate (as printed in the Wall Street Journal) plus 1% at the inception of the loan and provide for periodic repayment over a period of 1 to 30 years, based on the type of loan. Principal and interest is paid ratably through monthly payroll deductions. The entire unpaid principal balance of the loan is due upon the participant's termination of employment with the Company. The interest rate on loans outstanding at December 31, 2024 ranged from 4.25% to 9.50%.

1. Plan description (continued):

Payment of benefits:

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to 100% of the value of his or her account or annual installments. For termination of service for other reasons, a participant would receive the value of his or her account as a lump-sum distribution.

2. Summary of significant accounting policies:

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

The investments in registered investment companies relate to shares of participation in mutual funds. The share price of participation is based on the market value of the mutual funds' investments at the end of each day divided by the number of outstanding shares. Purchases and sales are transacted and recorded daily. Net appreciation (depreciation) includes the Plan's gains and loss on investments bought and sold as well as held during the year. Dividend income is recorded on the ex-dividend date.

Notes receivable – participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded at December 31, 2024.

Payment of benefits:

Benefits are recorded when paid.

Expenses:

Expenses related to maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

2. Summary of significant accounting policies (continued):

Subsequent events:

The Plan's management has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

3. Fair value measurements:

Accounting Standards Codification 820 – *Fair Value Measurement* (“ASC 820”) defines fair value and establishes a framework for measuring fair value under generally accepted accounting principles. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The valuation methodology used for assets measured at fair value:

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are registered with the SEC and are required to transact at their daily published net asset value (“NAV”). The funds held by the plan are deemed to be actively traded.

3. Fair value measurements (continued):

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Investments:

6. Income tax status:

The Internal Revenue Service has determined and informed the Company by letter dated March 31, 2014, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. Although the plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe the Plan is currently designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and uncertainties:

The Plan invests in various mutual funds which are exposed to various risks such as stock market fluctuations, interest rates, economic conditions and world affairs. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of changes in net assets available for benefits.

Significant market disruptions, such as those caused by pandemics, natural disasters or environmental disasters, war, instability in the banking and financial services sectors, including bank failures, or other events, can adversely affect local and global markets and normal market operations. Any such disruptions could have an adverse impact on both the Plan's investments and the Plan's sponsor.
