NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024, AND 2023

1. DESCRIPTION OF PLAN

The following description of the William F. Ryan Community Health Center Pension Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of William F. Ryan Community Health Center, Inc., Ryan-NENA Community Health Center, and Ryan/Chelsea-Clinton Community Health Center (collectively, the Organization). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Organization is the plan sponsor and is responsible for administration of the Plan. Mutual of America Life Insurance Company contracts with Mid Atlantic Trust Company (MATC) for trade agent and custodial services. The Plan assets are held by MATC, the trustee and custodian of the Plan. MATC maintains separate records with respect to employer contributions, including any earnings thereon credited to a participant's account. Mutual of America Life Insurance Company is the record keeper of the Plan and also holds a portion of the Plan assets as well.

Eligibility

All employees, except employees covered by a collective bargaining agreement, leased employees, peer educators and independent contractors are eligible to participate in the Plan. Employees who have one year of service, have provided a minimum of 1,000 hours of service in the last year, and are employed on the last day of the Plan year are considered eligible.

An employee becomes a participant in the Plan on the first day of the Plan's year (January 1) or the first day of the seventh month of the Plan's year (July 1) coinciding with or next following, achievement of the eligibility requirements. The employee must be employed by the Plan Sponsor on the last day of the Plan Year (December 31) in order to be eligible for the contribution for that Plan year.

Contributions

The Plan is non-contributory that only allows for employer contributions. The Organization contributes 2% of the compensation paid to such eligible employees for the contribution period. Employer contributions are allocable to a participant upon completion of at least 910 hours. Contributions are subject to certain limitations. Participants may elect to roll over qualified distributions to the Plan, regardless of whether they have satisfied any age or service requirements to participate in the Plan.

Vesting

The Organization's contributions vest 20% per year beginning after two years of service. Participants are fully vested after six years of credited service or upon normal retirement age.

Notwithstanding the foregoing, if a participant is employed by the Organization on their normal retirement age, the date they become disabled, or the date they die, their vested interest in the Employer contributions shall be 100%. A participant is 100% vested in their rollover contributions at all times.

1. DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account is credited with allocations of (a) the Organization's contribution and (b) Plan earnings. Allocations are based on a participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. In addition, the participant account may be charged for the cost of administrative expenses that are directly attributable to each account or as determined by the Plan administrator.

Participants direct the investment of the Organization's contributions into various investment options offered by the Plan.

Forfeitures

If a participant terminates employment and is less than 100% vested in their Organization contributions, the participant will forfeit the non-vested portion of their account. The Organization uses forfeited non-vested amounts to pay Plan expenses or reduce the Organization's contributions. At December 31, 2024, and 2023, forfeited non-vested accounts totaled approximately \$24,200 and \$8,500, respectively. During 2024 and 2023, forfeitures of \$5,097 and \$30,592, respectively, were used to reduce the Organization's contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of 50% of a participant's vested account balance or \$50,000, subject to the approval of a loan application. Participants may not have more than two loans outstanding at any time. The interest rate will be at the prime rate plus 1%. Loans are repaid through payroll deductions within a five-year period, unless the loan was made to acquire a primary residence, in which case the loan can be repaid over a ten-year period.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a lump-sum amount equal to the value of the participant's vested interest in their account.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted (GAAP) in the United States of America.

Employer Contributions Receivable

Employer contributions receivable represent amounts due to the Plan but not yet received as of year-end. Contributions are recorded on the accrual basis of accounting. Employer contributions are accrued in accordance with the terms of the Plan and are generally funded subsequent to year-end but prior to the filing of the Plan's Form 5500. All contributions receivable are expected to be collected within a reasonable period and, therefore, no allowance for credit losses has been recorded.

Investment Valuation and Income Recognition

The Plan's investments in mutual funds and a stable value funds are reported at fair value as reported by the Trustee. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair value Measurements and Disclosures provides a framework for measuring fair value. The Plan uses various valuation techniques in determining fair value. GAAP establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that observable inputs be used when available. Observable inputs are inputs that market participants would use in pricing the asset or liability developed based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect the Plan's estimate about the assumptions market participants would use in pricing the asset or liability, developed based on the best information available in the circumstances.

The fair value hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations are based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations are based on quoted prices in markets that are not active or for which all significant inputs are observable, directly, or indirectly.
- Level 3 - Valuations are based on inputs that are unobservable and significant to the overall fair value measurement.

Mutual funds: Valued at fair value based on quoted prices in active markets.

Stable Value funds: The funds are valued at the net asset value (NAV) per unit by dividing the total assets of the fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the funds and included in the determination of unit values. These contracts contain certain restrictions on the Plan participants' ability to cash out their contracts and thus are not fully-benefit responsive contracts.

The Plan's investments in stable value funds is comprised of guaranteed insurance contracts established between the Plan's participants and the Plan's custodian. These contracts guarantee the participants' principal and a minimum interest rate. In addition, participants have the opportunity to earn amounts in excess of the guaranteed rate. The contract returns are backed by investment contracts which invest in a broadly diversified portfolio of private placement bonds, commercial mortgages, and publicly traded securities. Since the agreement or funding agency has the ability to restrict certain transfers and withdrawals.

Redemptions are generally restricted to processing on a valuation date at the NAV per unit computed on that date. Trust units may be redeemed on a daily basis to meet benefit payments and other participant-initiated withdrawals permitted by retirement plans invested in the trust. The Fund does not have any unfunded commitments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurements (Continued)

There were no changes in the valuation methodologies used during 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable inputs can vary and is affected by a wide variety of factors. To the extent that valuation is based on models or inputs that are less observable or unobservable in the market, the determination of fair value requires more judgment. Accordingly, the degree of judgment exercised in determining fair value is greatest for instruments categorized in Level 3. In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes the level in the fair value hierarchy within which the fair value measurement is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

Risks and Uncertainties

Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect participant account balances and the amounts reported in the financial statements.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued unpaid interest. If a participant ceased to make loan repayments and the Plan administrator deems the loan to be in default, the participant loan balance was reduced and a benefit payment was recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Administrative expenses of maintaining the Plan may be paid by the Organization or the Plan, at the Organization's discretion. Certain administration fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation on fair value of investments.

Estimates

The preparation of financial statements in accordance with GAAP requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements. Actual results could differ from those estimates.

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan assets are held by MATC, the custodian of the Plan and Mutual of America Life Insurance Company is the record keeper of the Plan. As such transactions between MATC, Mutual of America Financial Services, and the Plan qualify as party-in-interest transactions. Additionally, notes receivable from participants were party-in-interest transactions.

6. TAX STATUS

The Plan adopted a pre-approved plan offered by Mutual of America Financial Group (now known as Mutual of America Life Insurance Company). The pre-approved plan received an IRS Opinion Letter dated November 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions. All distributions would be made in accordance with any applicable requirements of ERISA and the Internal Revenue Code.
