### ***Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Flexsteel Industries, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## ***Basis For Opinion***

## **NOTES TO FINANCIAL STATEMENTS**

### **1. Description Of The Plan**

The following description of the Flexsteel Industries, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution 401(k) plan covering substantially all employees of Flexsteel Industries, Inc. (the Employer), other than those employees who are independent contractors, leased employees, members of a collective bargaining agreement or non-resident aliens with no U.S. earned income. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Employees are eligible to participate on their date of hire and are automatically enrolled in the Plan on the first of the month following their hire date with a deferral amount of 3% of eligible compensation. The Plan includes an automatic escalation feature in which participants will automatically have their deferrals increased by 1% annually on the first day of the plan year until their election reaches 5%, unless a participant makes an election otherwise.

Participants may contribute up to 100% of eligible compensation in the form of pre-tax or after-tax (ROTH) contributions not to exceed Internal Revenue Code (IRC) limits. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans.

Under the provisions of the Plan, the Employer makes safe-harbor matching contributions equal to 100% of the participant's deferral up to 5%. Participants are eligible for safe-harbor matching contributions upon becoming eligible to participate in the Plan.

Under the provisions of the Plan, the Employer has the option to make additional discretionary matching contributions. Participants are eligible for additional matching contributions upon becoming eligible to participate in the Plan. Additional matching contributions were calculated as 100% of the participants deferral up to 5% of annual compensation limited by safe-harbor contributions already received. Employer discretionary matching contributions totaled \$86,702 for the year ended December 31, 2024, and are included within employer contributions receivable on the statements of net assets available for benefits at December 31, 2024.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions and employer safe-harbor matching and additional discretionary matching contributions as well as allocations of the Plan's earnings and expenses. Allocations are based on the participant's eligible compensation, the value of account balances or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their rollover, voluntary and employer safe-harbor and additional discretionary matching contributions.

### **Hardship Withdrawals**

Participants may elect to withdraw all or a portion of their vested account balance if they incur a financial hardship. Hardship withdrawals are subject to the terms of the plan agreement and provisions of the IRC.

### **Payment Of Benefits**

Upon termination of service due to death, disability, termination or retirement, participants with an account balance greater than \$7,000 may elect to receive a lump-sum amount equal to the value of the participant's account, receive installments over a period of time or leave their balance in the Plan subject to minimum distribution requirements. Participants with a vested balance of \$7,000 or less will receive a lump-sum payment upon termination.

### **In-Service Withdrawals**

Active participants who reach age 59 ½ may withdraw all or part of their vested accounts.

### **Forfeited Accounts**

At December 31, 2024 and 2023, there were no forfeited accounts. These accounts are first used to pay plan expenses and then used to reduce employer contributions. During the year ended December 31, 2024, forfeited accounts of \$359 were used to reduce employer contributions.

## **2. Summary Of Accounting Policies**

### **Basis Of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### **Use Of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation And Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's fiduciary committee determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

### **Contributions**

Contributions from participants and from the Employer are recorded in the year in which the employee contributions are withheld from compensation. Additional employer discretionary matching contributions are recorded in the year in which the contributions are declared.

### **Payment Of Benefits**

Benefit payments to participants are recorded when paid.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

### **Reclassifications**

Certain 2023 amounts have been reclassified, where appropriate, to conform to the presentation in the 2024 financial statements. The reclassifications had no effect on the overall financial position or changes in net assets available for benefits.

### **Subsequent Events**

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

### **3. Certified Investments**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023 and net appreciation in fair value of investments, dividends and other income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustee of the Plan.

### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-ended funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Common/Collective Trusts:* Valued at the NAV of the units of the trust. NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common/collective trusts, the investment advisor reserves the right to temporarily delay withdrawal from the trusts in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Pooled Separate Accounts:* Valued at the NAV per unit based on either the observable NAV of the underlying investments or the NAV of the underlying pool of securities. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities and then divided by the number of shares outstanding.

### **5. Related-Party And Party-In-Interest Transactions**

Certain plan investments are shares of pooled separate accounts or common/collective trusts managed by Principal Life Insurance Company and Principal Global Investors Trust Company, members of Principal Financial Group. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustee of the Plan, is also a member of the Principal Financial Group. Therefore, these transactions qualify as party-in-interest transactions.

### **6. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **7. Tax Status**

The Employer has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Department of Labor or IRS. Management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **8. Risks And Uncertainties**

The Plan invests in a variety of investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
