The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Their report dated July 10, 2024 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with U.S. GAAP, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meet the requirements of ERISA Section 103(a)(3)(C). 1. Description of the Plan

The following description of Granite VNA, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Adoption Agreement for a more complete description of the Plan's provisions.

General

The Plan is a tax-exempt, defined contribution retirement plan sponsored by Granite VNA, Inc. (Sponsor). Employees may begin participation in the Plan on the first day of the month following their date of hire, provided they have attained the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Charles Schwab Trust Bank and Voya Retirement Insurance and Annuity Company (the trustees) are the trustees of the Plan. Charles Schwab Trust Bank was the trustee through July 1, 2024. Voya Retirement Insurance and Annuity Company became the trustee effective July 1, 2024.

Contributions

Each year eligible employees who elect to become participants may elect to contribute up to 75% of their eligible compensation, as defined by the Plan, up to a maximum allowable amount as determined by the Internal Revenue Code (Code). The Sponsor makes safe harbor matching contributions equal to 100% of employee deferrals that do not exceed 3% of employee compensation, plus 50% of employee deferrals that exceed 3% of employee compensation, but do not exceed 5% of employee compensation, plus 25% of employee deferrals that exceed 5% of employee compensation, but do not exceed 6% employee compensation. Participants are immediately 100% vested in their participant and employer safe harbor matching contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Sponsor's safe harbor matching contributions, and an allocation of Plan earnings. Participant accounts are also charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Notes receivable from participants are recorded at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Participants may borrow from the Plan a minimum of \$1,000 up to the lesser of 50% of their vested account balance or \$50,000. Participant loans are secured by the balance in the participants' accounts and bear interest at a rate that is commensurate with the local prevailing rates. Principal and interest are paid ratably through payroll deductions.

Payments of Benefits

Participants shall become eligible to receive their vested account balances upon retirement (normal retirement age is 65), death, disability, or termination. Participants may withdraw their account balances upon attaining age 59½. Participants may receive their benefit payments in a single lump-sum payment or a monthly annuity. In addition, participants may withdraw their pre-tax contributions upon demonstration to the plan administrator that they are suffering a hardship, as defined in Section 401(k) of the Code. Participants may only take a hardship withdrawal after they have received all other withdrawals or loans available to them under the Plan.

2. **Summary of Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of the fair value measurement.

Purchases and sales are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Plan Expenses

Certain Plan expenses have been paid by the Sponsor. See Note 9 for a description of other Plan expenses paid for by the Plan.

Subsequent Events

Management has considered transactions or events occurring through October 7, 2025, which is the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Fully Benefit-Responsive Investment Contract

Investments in the Voya Fixed Account are in insurance company general accounts. Contributions to these investments buy contractual or guaranteed amounts of future benefits for the participant. Interest credited to the investments include a guaranteed rate plus additional amounts established on a year-by-year basis.

The contract meets the fully benefit-responsive contract criteria and therefore is reported at contract value, as reported to the Plan by the trustee. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion of, their investment at contract value.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; or (4) a material amendment to the agreement without the consent of the issuer.

4. Fair Value Measurement

U.S. GAAP provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability. The Plan does not have any Level 2 investments.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The Plan does not have any Level 3 investments.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Money market funds and mutual funds are valued at quoted prices in active markets for identical assets. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Income Tax Status

The Plan is part of a prototype plan designed by the trustee. The Internal Revenue Service has determined and informed the trustee, by a letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the Code. The Plan has been amended since receiving the determination; however, the plan administrator believes that the Plan is designed and currently operated in compliance with the applicable requirements of the Code.

6. Information Prepared and Certified by the Trustees

The investments, investment transactions, net appreciation in fair value of investments, notes receivable from participants, and interest and dividends were obtained by management and agreed to or derived from the information certified by the trustees, as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits;
- Statement of Changes in Net Assets Available for Benefits; and
- Schedule H, line 4i – Schedule of Assets (Held at End of Year).

7. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

8. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Party-in-Interest

Fees paid to USI Consulting Group, Inc., Charles Schwab Trust Bank, and Voya Retirement Insurance and Annuity Company for investment management, recordkeeping, third-party administrator and trustee services for the year ended December 31, 2024 were \$67,047. These fees qualify as party-in-interest transactions.
