Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of News-2-You, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Notes to Financial Statements

1. Description of the Plan

The following description of the News-2-You, Inc. 401(k) Plan (the Plan) provides only general information. Therefore, participants should refer to the Plan agreement or Summary Plan Description (SPD) for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan covering substantially all employees of News-2-You, Inc. (the Plan Sponsor and Company). The Plan is designed to comply with the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA), and the Internal Revenue Code (IRC). The Plan's financial statements and supplemental schedule have been prepared in compliance with ERISA and with accounting principles generally accepted in the United States of America (GAAP).

Administration

Effective January 1, 2022, the Plan was restated with no changes to the structure of the Plan.

Effective January 1, 2025, the TextHelp, Inc. 401(k) Plan merged into the News-2-You, Inc. 401(k) Plan.

Effective June 20, 2025, the News-2-You, Inc. 401(k) Plan changed its name to the Everway, LLC 401(k) Trust.

Eligibility

Employees who have attained the age of 18 and completed three consecutive months of service (as defined) with the Company are eligible to enroll in the Plan. Eligible employees may enroll in the Plan on the first day of the month following the date on which eligibility requirements are met.

Participant Contributions

Participants may contribute a voluntary percentage or dollar amount of pre-tax annual compensation, as defined by the Plan. Contributions are subject to limitations on annual additions and other limitations imposed by the IRC as defined in the Plan document. Eligible participants may make a rollover contribution to the Plan as a distribution from a prior employer's qualified Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participants who are eligible to make salary deferral contributions under the Plan and have attained age 50 before the close of the Plan year may make catch-up contributions in accordance with, and subject to the limitations imposed by, the IRC.

Employer Contributions

The Company may make a discretionary contribution on behalf of each participant equal to a percentage of the participant's eligible compensation. The Company elected to contribute 1.56% of eligible compensation to the Plan in 2024. The discretionary contribution totaled \$378,427 for the year ended December 31, 2024.

The Company has elected to make a safe harbor matching contribution on behalf of each participant equal to 3% of eligible compensation to the Plan. The Company may also make other contributions subject to IRC limitations, as determined by the Company. Employer contributions are approved by management before the beginning of each Plan year. Contributions are subject to certain limitations. The safe harbor matching contributions totaled \$679,637 for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, including amounts rolled over from other qualified plans, the Company's safe harbor and profit-sharing and discretionary contributions, and an allocation of the Plan's earnings and administrative fees, as defined by the Plan document. Allocations of earnings are based on participant account balances. Other discretionary amounts contributed to the Plan by the Company are allocated to participant accounts based on compensation.

Vesting

Participants are immediately vested in their contributions, rollover contributions, and safe harbor contributions and actual earnings or losses thereon. Vesting in the Company's discretionary contributions, if any, is based on years of service, as follows:

Upon death or disability, the participant (or his/her beneficiary in case of his/her death) becomes 100% vested in the Plan. Upon reaching normal retirement age of 65 or after six years in the Plan, the participant becomes 100% vested in the Plan.

Forfeitures

Forfeitures of terminated participants' non-vested account balances are retained in the Plan and may first be used to pay administrative expenses. Remaining amounts will be used to reduce future employer contributions to the Plan. There were no forfeitures used to reduce discretionary contributions during the year ended December 31, 2024. As of December 31, 2024 and 2023, the balances of unused forfeitures were \$83,921 and \$56,378, respectively.

Payment of Benefits

The benefit to which a participant is entitled equals the value of the participant's vested interest in his or her account. Upon termination of service due to death, disability, severance, or retirement, a participant may elect to receive a lump-sum payment equal to the vested portion of his or her account. Upon termination of employment, vested account balances of less than \$5,000 may be

distributed in a lump sum or rolled over to another qualified plan or an Individual Retirement Account or Annuity for the benefit of the participant.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. Participants may have only one loan outstanding at a time. The notes are secured by the vested balance in the participant's account and bear interest at a reasonable rate determined by the Company. Interest rates ranged from 4.25% to 9.50% as of December 31, 2024 and 2023. Any loan must be repaid within five years unless otherwise approved. Principal and interest are paid ratably through payroll deductions. Participant loans receivable are stated at the unpaid principal balance, plus accrued interest. No allowance is recorded as the loans are secured by the participant's account balance as of December 31, 2024 and 2023.

Administrative Expenses

Administrative expenses may be paid by the Company. However, the Plan may pay transaction fees, which are charged directly to the specific participant generating the transaction.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared in conformity with GAAP.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported on the financial statements.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the custodians. See Note 3 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses for investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Evaluation of Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date that the financial statements were available to be issued. No material transactions have occurred that require recognition or disclosure in the financial statements, other than those disclosed in Note 1.

3. Fair Value Measurements

Accounting Standards Codification Topic 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobserved inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Registered Investment Companies (Mutual Funds) - Investments in registered investment companies are valued at the daily closing price as reported by the fund manager. Funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common/Collective Trusts - Common/collective trusts are valued using NAV as a practical expedient, as reported by the fund manager, based on the underlying investments. The common/collective trusts held by the Plan provide for daily redemptions by the Plan at the reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date. The investment objective of the collective trust is to provide preservation of capital and provide relatively stable returns consistent with a low-risk profile. There are no redemption restrictions or unfunded commitments on these investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

5. Guaranteed Income Fund

In 2024, the Plan entered into a benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America (EAICA). EAICA maintained the contributions in a general account. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1.00%.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants ordinarily may direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The average yield based on actual earnings was 2.41% for the year ended December 31, 2024. The average yield based on interest rate credited to participants was 2.41% for the year ended December 31, 2024.

Participants may transfer their account balance to any other investment option offered under the Plan at any time with no restrictions or penalties. If a participant transfers out of the Guaranteed Income Fund, Empower Annuity Insurance Company of America reserves the right to restrict transfer for 30 days. These transactions are processed after the resolution of closed or disrupted financial exchanges or markets.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.

7. Income Tax Status

The Plan adopted a prototype plan document sponsored by Empower Retirement, LLC (Empower). Empower received an opinion letter from the Internal Revenue Service (IRS), dated November 14, 2022, which states that the pre-approved plan document, as then-designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Party-in-Interest Transactions

Parties-in-interest are defined under Department of Labor's Regulations as any fiduciary of the Plan, any party rendering services to the Plan, the Company, and certain others. As such, transactions conducted by Empower Retirement Company and its affiliates qualify as party-in-interest transactions.
