To the Plan Administrator
of **Sheltair Resources 401(k) Plan**:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Sheltair Resources 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(1) Description of plan

The following description of the Sheltair Resources 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

General - The Plan is a qualified defined contribution plan sponsored by Sheltair Resources, LLC (the "Company") for the benefit of its employees who have completed 60 days of service and are age 21 or older. Part-time, temporary, and seasonal employees need to complete 1,000 hours of service to be eligible to participate in the Plan. The Plan also covers the employees of the Company's affiliates who executed a plan participation agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan amendments - Effective April 1, 2023, the Plan was amended, waiving the eligibility conditions for Gwinnett Aero LLC employees, employed on April 2, 2023, and including part-time, temporary, seasonal, and leased employees as eligible employees to participate in the Plan.

Effective January 1, 2024, the Plan was restated, amending the following:

- Removed leased employees as eligible participants in the Plan.
- Permitted employees previously employed by Denton Enterprise Airport ("Denton Employees") to count years of service earned with employers other than the Company for vesting and eligibility purposes.
- Waived eligibility requirements for Denton Employees who were employed by the Company on January 1, 2024.

Contributions - Participants may contribute up to 100% of annual compensation as pre-tax or Roth contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company may make a discretionary matching contribution. For the years ended December 31, 2024 and 2023, the Company elected to match 50% of the first 6% of eligible compensation that a participant contributes to the Plan. Additional qualified non-elective amounts may be contributed at the option of the Company. To start receiving a Company contribution, employees must have completed a year of service, as defined in the Plan with the exception of Denton Employees employed on January 1, 2024, who have no service requirement.

Contributions (continued)

Matching contributions, including qualified non-elective contributions, made by the Company for the years ended December 31, 2024 and 2023 totaled \$350,868 and \$405,929, respectively. All participant and Company contributions are subject to certain Internal Revenue Code ("IRC") limitations.

Participant investment account options - Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a self-directed brokerage account as investment options for participants. Participants may purchase investments not offered by the Plan through the self-directed brokerage account.

Participant accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of service. Company contributions are subject to the following vesting schedule:

Notes receivable from participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. All notes have a definite repayment period not to exceed five years, or a reasonable number of years greater than five years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at rates of 1% over the prime rate. Principal and interest are paid ratably through payroll deductions. Participants may not have more than one note outstanding at any time.

(1) Description of plan (continued)

Payment of benefits - On termination of service due to death, disability, retirement, or attaining age 59 ½ a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments as specified in the Summary Plan Description. Participants may also receive a distribution from their deferrals account balance for qualifying events under certain "hardship" rules, as prescribed by the Internal Revenue Service ("IRS").

Forfeited accounts - At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$54,000 and \$109,000, respectively. These accounts will be used to reduce future employer contributions or pay administrative expenses. During 2024 and 2023, approximately \$75,000 and \$37,000, respectively, of forfeited non-vested accounts were used to reduce employer contributions. During 2024 and 2023, approximately \$31,000 and \$0, respectively, of forfeited non-vested accounts were used to pay administrative expenses.

(2) Summary of significant accounting policies

Basis of accounting - The financial statements of the Plan are prepared on the accrual method of accounting.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions - Contributions from Plan participants and the Company's contributions are recorded in the year in which the participant contributions are withheld from compensation.

(2) Summary of significant accounting policies (continued)

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of benefits - Benefits are recorded when paid.

Administrative expenses - Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

(3) Information prepared and certified by the trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate with respect to investments:

- Investments at fair value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent certified public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

(4) Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common stocks (within self-directed brokerage accounts): Valued at the closing price reported on the active market on which the individual securities are traded.

(5) Related party transactions and party-in-interest transactions

Certain Plan investments are shares of mutual funds in the custody of Empower Trust Company, LLC. Empower Trust Company, LLC is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to its record-keeper and other service providers totaling approximately \$164,000 and \$100,000 for the years ended December 31, 2024 and 2023, respectively, which were not covered by revenue sharing. Certain other Plan related expenses are paid for by the Company, and as such, are not included in the statements of changes in net assets available for benefits.

(6) Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

(7) **Tax status**

The IRS determined that the non-standardized pre-approved profit-sharing plan provided by Empower Retirement, LLC is designed in accordance with applicable sections of the IRC and informed Empower Retirement, LLC of such in a letter dated November 14, 2022.

Effective January 1, 2024, the Company adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

The Plan has identified numerous operational errors made during 2021, 2022, and 2023, which relate to employee deferrals, employer contributions, application of Plan terms with respect to the definition of compensation, and other similar errors. The Plan Sponsor has engaged a third-party administrator to assist with the correction of these operational errors.

In addition, as described in Note 9, the Plan identified and reported prohibited transactions during the years ended December 31, 2023, 2022 and 2021 related to late remittances of employee deferrals, which were fully corrected by October 2024.

(8) **Risks, uncertainties and concentration**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflicts. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024, approximately 39% of the Plan's investments were invested in three mutual funds. At December 31, 2023, approximately 16% of the Plan's investments were invested in one mutual fund.

(9) Delinquent participant contributions

Defined contribution plans are required to remit employee contributions, including note repayments, to the Plan as soon as they can be reasonably segregated from the employer's general assets. Employee contributions, including participant note repayments, in the amounts of \$2,661, \$100,636 and \$71,433 were not remitted within the required time period for the years ended December 31, 2023, 2022 and 2021, respectively. All employee contributions were remitted to the Plan as of December 31, 2024. In January 2024, the Company remitted lost earnings as a result of the 2022 and 2021 delinquent participant contributions. In October 2024, the Company remitted lost earnings as a result of the 2023 delinquent participant contributions.

(10) Other liabilities

During 2024, the Plan Sponsor remitted employee and employer matching contributions intended for the 2025 Plan year into the Plan. As these contributions relate to compensation earned and paid in 2025, the Plan recorded these amounts as a liability at December 31, 2024. These contributions will be recognized as additions to net assets available for benefits in the 2025 Plan year when the employee compensation is earned. The total amount of contributions received in advance as of December 31, 2024 was \$40,386.

(11) Subsequent events

Effective January 1, 2025, the Plan was amended for the following:

- Adopted an annual auto escalation feature which increases participants' deferral elections by 1% at the beginning of each year up to a maximum of 6%.
- Removed the provision that participants can elect to receive distributions from the Plan after termination for reasons other than death in equal annual installments.

The Plan has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued. Except as noted above, no significant matters were identified for disclosure during this evaluation.
