## INDEPENDENT AUDITOR'S REPORT

NOTE A - DESCRIPTION OF THE PLAN

The following description of La Red Health Center, Inc. 403(B) Plan (The “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General.* The Plan is a tax-sheltered annuity plan covering substantially all employees of La Red Health Center, Inc. (the Organization), other than employees who normally work less than twenty hours per week.

*Contributions.* Each year, participants may contribute up to one hundred percent of pre-tax annual compensation, as defined in the Plan limited only by the maximum contribution amount permitted under the IRS Regulations. Participants may also contribute amounts representing distributions from other defined benefit or contribution plans. The Organization can elect to contribute an amount determined by the Organization in any given year. Additionally, the Organization, at its discretion, may make a qualified non-elective contribution to the Plan. Such a contribution, if any, would be allocated to each participant in the ratio that such participant’s compensation bears to the compensation of all participants. These contributions will always be fully vested. The Plan also provides for special catch-up contribution provisions.

*Participant Accounts.* Each participant's account is credited with the a) participant’s contribution, b) the Organization's contribution and c) plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from a participant's vested account.

*Vesting.* Participants are immediately vested in their contributions. The vesting schedule for the Organization’s contributions is as follows:

NOTE A - DESCRIPTION OF THE PLAN (*CONTINUED*)

*Participant Loans.* Participants may borrow from their pre-tax deferral fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or fifty percent of their vested pre-tax deferral fund account balance. Loan terms require a definite repayment period which provides for monthly payments to and for the loans to be amortized on a level basis over a reasonable period of time, not to exceed five years. If a participant defaults on their loan, they will be taxed on the amount of the outstanding loan balance and will be subject to a ten percent penalty if they are under the age of 59 ½. The loans are secured by the balance in the participant's account and bear interest at the prime rate, as specified by the Wall Street Journal, plus one percent.

*Payment of Benefits.* Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. In certain instances, a terminated participant may elect to remain in the Plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

*Forfeited Accounts.* Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures are used to reduce the Organization's contribution to the Plan.

*Pension Benefit Guaranty Corporation.* Benefits provided by the Plan are not insured by the Pension Benefit Guaranty Corporation (PBGC) since insurance provisions under ERISA are not applicable to the Plan.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting*

The Plan follows accounting standards set by the Financial Accounting Standards Board (FASB), which establishes generally accepted accounting principles (GAAP) that are followed in reporting the statements of net assets available for benefits and the statements of changes in net assets available for benefits. References to GAAP issued by the FASB in financial statements as well as these notes are to the Accounting Standards Codification (ASC).

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (*CONTINUED*)

*Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Although these estimates are based on management's knowledge of current events and actions it may take in the future, they may ultimately differ from actual results. Accounting measurements most affected by management's estimates of future events include the determination of fair value of investments, the realization of contributions receivable, loans receivable and accrued interest and dividends. Estimates and assumptions are reviewed periodically, and the effects of revisions are reflected in the financial statements in the period determined.

Management does not believe that any of its estimates involve assumptions that are highly uncertain or that different, reasonable estimates, or changes in accounting estimates that are reasonably likely to occur, would have a material impact on the financial statements. To the extent there are material differences between management's estimates and actual results, future results of operations will be affected.

*Investment Valuation and Income*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments which consist of the realized gains and losses and the changes in unrealized appreciation (depreciation) on those investments

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (*CONTINUED*)

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

*Payment of Benefits*

Benefits are recorded when paid.

*Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included as investment advisory and management fees. Investment related expenses are included in the appreciation of the fair value of investments.

NOTE D - FAIR VALUE MEASUREMENTS

The Plan adheres to ASC 820, *Fair Value Measurements and Disclosures*. ASC 820 defines fair value, establishes a framework for measuring fair value under generally accepted accounting principles and enhances disclosures about fair value measurements. Fair value is defined under ASC 820 as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date.

As a basis for considering assumptions, ASC 820 establishes a hierarchical framework for measuring fair value (the fair value hierarchy) as follows:

*Level 1* - Quoted prices in active markets for identical assets or liabilities. Level 1 assets include money market funds, debt and equity securities that are traded in active exchange market, as well as certain U.S. Treasury and other U.S. Governments and agencies that are highly liquid and are actively traded in over-the-counter markets.

*Level 2* - Observable inputs other than Level 1 such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the same term of the assets or liabilities.

NOTE D - FAIR VALUE MEASUREMENTS (*CONTINUED*)

*Level 3* - Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and maximize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

*Money market funds*: Valued using quoted market prices in active markets. These instruments are considered highly liquid and are redeemable on demand.

*Mutual funds*: Valued at the quoted net asset value.

The valuation methodologies used for assets measured at fair value may produce a fair value calculation that may not be indicative of net realizable values or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The tables on page 14 present the financial instruments carried at fair value as of December 31, 2024 **and** 2023 as required by the valuation hierarchy defined above.

NOTE E - TAX STATUS

The Internal Revenue Service (IRS) has determined that the prototype Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although there are certain amendments applicable to the La Red Health Center, Inc. 403(b) Tax Sheltered Annuity Plan, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable IRS requirements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan is subject to routine audits by this tax jurisdiction; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for periods before **December 31, 2021**.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will maintain one hundred percent vested in their accounts.

NOTE G - RELATED PARTY TRANSACTIONS

The majority of the Plan's investments are with Ascensus Trust Company and Empower or related entity products for the years ended December 31, 2024 **and 2023**. Ascensus Trust Company and Empower are the asset Custodians and/or third-party Administrator, as defined by the Plan, and therefore, these transactions or holdings qualify as party-in-interest transactions.

At December 31, 2024 **and 2023**, the Plan held investments of \$3,283,258 and \$2,535,325, respectively which qualify as party-in-interest holdings. The supplemental Schedule H Line 4(i) Schedule of Assets Held for Investment Purposes at December 31, 2024 identifies the specific assets deemed as party-in-interest holdings.

NOTE H - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIANS

The Plan Administrator has elected the method of compliance in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform an auditing procedure with respect to the following information certified by Ascensus, LLC, as an administered representative of Ascensus Trust Company, except for comparing such information certified by the Custodians with information included in the Plan's financial statements and supplemental Schedule H Line 4(i) – Schedule of Assets Held for Investment Purposes at December 31, 2024:

NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. NOTE J - BENEFIT OBLIGATIONS

Included in net assets available for benefits are amounts allocated to individuals who are no longer participating in the plan but have not been paid. Plan assets allocated to these participants at December 31, 2024 and 2023 amount to \$785,342 and \$465,335, respectively.

NOTE K - PROHIBITED TRANSACTIONS

For the year ended December 31, 2024 and 2023, the Plan had Delinquent contributions of \$125,119 and \$0 respectively, which is included in the Schedule of Delinquent Participant Contributions on page 20.

NOTE L - SECURE ACT 2.0

The SECURE Act 2.0, also known as the Setting Every Community Up for Retirement Enhancement Act 2.0, was enacted into law on December 29, 2022, and is aimed at improving retirement savings opportunities for individuals. The provisions of the law are expected to have a profound impact on nearly every aspect of retirement plan administration

Section 101 of the SECURE Act 2.0 requires 401(k) plans to automatically enroll participants into the Plan upon reaching eligibility unless the employee opts-out, at a rate of at least 3 but no more than 10 percent, unless the employer has less than 10 employees, is a new business in operation for less than three years or is a church or governmental plan. However, all current 401(k) Plans are grandfathered in from this requirement.

Under the SECURE Act 2.0, starting in 2024, if the taxpayer has income of at least \$145,000 for the year, a catch-up contribution must be treated as a Roth contribution. That means these funds are contributed with after-tax dollars, so they will not reduce current taxable income, but can be withdrawn tax-free in the future. The \$145,000 income threshold will also be indexed for inflation in future years.

Starting in 2025, a new special catch-up contribution is permitted for taxpayers who are between ages 60 and 63. That contribution limit will be equal to the greater of (1) \$10,000 or (2) 150% of the standard catch-up contribution limit for 2024. The \$10,000 limit will also be indexed for inflation. Once the taxpayer reaches age 64, the regular (lower) catch-up contribution limit applies.

The SECURE Act 2.0 increases the age thresholds for required minimum distributions (RMD's) from age 72 to age 73 as of January 1, 2023. It additionally increases the age threshold to age 75 as of January 1, 2033.

Furthermore, the legislation includes provisions aimed at expanding access to retirement savings plans for part-time employees. It seeks to make it easier for these individuals to participate in employer-sponsored plans, thus promoting greater retirement preparedness among a broader range of workers.

Further provisions of the SECURE Act 2.0 will begin coming online in future plan years and their impact to the operation of 401(k) plans may be affected by future legislation.
