To the Management of the

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit on the 2024 Financial Statements***

We have performed an audit of the accompanying financial statements of the RTM & Associates, Inc. Profit Sharing/401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ["ERISA Section 103(a)(3)(C) audit"]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## NOTES TO THE FINANCIAL STATEMENTS

## NOTE 1 – DESCRIPTION OF PLAN

The following description of the RTM & Associates, Inc. Profit Sharing/401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more comprehensive description of the Plan’s provisions.

**General.** The Plan is a defined contribution plan, sponsored by RTM Engineering Company, Inc, (the “Employer”), as defined in the Plan. The Plan covers all employees of the Employer and its affiliates with the exception of nonresident aliens, leased employees, or part of a collective bargaining agreement. The Employer controls and manages the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

**Eligibility.** There is no service requirement or age limit to be eligible to participate in the Plan. Initial enrollment is available immediately on their date of hire.

**Participant Contributions.** Participants may make an elective deferral of up to 100% of their eligible compensation to the Plan, subject to maximum pre-tax and/or post-tax contribution limitations as permitted by the Internal Revenue Service (“IRS”). The Plan defaults participants to automatically defer 6% of their compensation each payroll period, treated as pre-tax deferrals, unless they elect a different percentage, amount or elect post-tax deferrals, or choose to opt out of contributing. Participants may also contribute “catch-up” contributions and contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

**Employer Contributions.** The Employer, at its sole discretion, may make a matching or profit-sharing contribution to the Plan on behalf of each eligible participant who is employed as of the last day of the Plan year. Such contributions would be funded subsequent to year end. Any Employer discretionary matching and non-elective contributions are based upon participants’ annual compensation subject to IRS limitations. The Employer approved matching contributions of 100% of the participant’s contribution, not to exceed 3% of the participant’s compensation, for the year ended December 31, 2024. Employer matching contributions were \$1,187,029 for the year ended December 31, 2024. There were no Employer profit-sharing contributions elected for the year ended December 31, 2024.

**Participant Accounts.** Each participant’s account is credited with the participant’s elective deferral, any Employer matching contribution, any Employer profit-sharing contribution, and the participant’s earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balance as described in the Plan Agreement. Any profit-sharing contribution is allocated to participants’ accounts based on the participants’ eligible compensation. Employer contributions to the Plan are invested among investment funds in the same proportion as the participant’s contribution.

**Investment Options.** Participants direct the investment of their contributions into various investment options offered by the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted pursuant to Plan provisions.

**Vesting.** Participants are immediately vested in their contributions and the income earned on such contributions. For Employer matching and profit-sharing contributions, a participant vests 20% per year, starting at the end of the second year, for each year of service and is 100% vested after six years.

**Notes Receivable from Participants.** The Plan provides loans to participants from their vested account balance up to \$50,000, subject to a limitation of 50% of their vested account balance. Interest is charged on the loans and is fixed at the time of issuance at a rate of prime (7.50% as of December 31, 2024) plus 1.00%. Payments are immediately reinvested in the individual participant’s funds. The loans are collateralized by the vested account balance of the participant receiving the loan. Participants may have no more than one loan outstanding at any time. Loans are repayable in periods up to five years, or thirty years if entire loan proceeds are used to acquire a principal residence. Should a participant default on a Plan loan, as defined by the Plan loan policy, the loan would then be considered a distribution.

**Payment of Benefits.** Upon termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Other withdrawals from participant's account balances may be made under certain circumstances, as defined in the Plan document. Participants may also receive in-service distributions upon reaching age 59 ½.

**Forfeitures.** Forfeited balances of terminated participants are used to reduce Employer contributions to the Plan. Forfeited non-vested accounts totaled approximately \$155,000 and \$31,000 as of December 31, 2024 and 2023, respectively. The Plan used \$136,274 of forfeitures for the year ended December 31, 2024 to reduce the Employer matching contribution.

**Recent Legislation.** In December 2022, SECURE Act 2.0 ("SECURE 2.0") was enacted. SECURE 2.0 contains numerous significant changes for retirement plans, plan sponsors, and retirement plan providers. For example, SECURE 2.0 contains provisions related to, among many other things, increasing the required minimum distribution age, reducing required minimum distribution penalties, and removing required minimum distribution barriers for annuities. Many of the provisions in SECURE 2.0 went effective in 2023, but SECURE 2.0 will not be completely implemented until 2027. The IRS has issued additional guidance addressing specific issues arising from the implementation of the provisions of SECURE 2.0.

## NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting.** The accompanying financial statements have been prepared on the accrual method of accounting.

**Estimates and Assumptions.** The preparation of the Plan's financial statements in conformity with generally accepted accounting principles in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates. Future events and their effects cannot be predicted with certainty; accordingly, accounting estimates require the exercise of judgment. Accounting estimates used in the preparation of these financial statements change as new events occur, as more experience is acquired, as additional information is obtained, and as the operating environment changes.

**Investment Valuation and Income Recognition.** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies are determined utilizing information provided by John Hancock Trust Company LLC, the "Custodian" of the Plan, which is a qualified institution pursuant to ERISA. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants.** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Benefit Payments.** Benefits are recorded when paid.

**Concentrations of Credit Risk.** Substantially all the Plan's assets are held by the Custodian.

**Administrative Expenses.** Certain administrative expenses, including functions performed by officers or employees of the Employer, are provided by the Employer at no charge to the Plan, and Employer's management has no plans to obtain reimbursement of these expenses from the Plan.

**NOTE 3 – INFORMATION CERTIFIED BY THE CUSTODIAN**

The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements and supplemental schedule that were prepared by the Custodian and furnished to the Plan's administrator ("Plan Administrator"). The Plan Administrator has obtained certifications from the Custodian that such information is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Note 4: All investment balances.
- The schedule of assets held for investment purposes at end of year as of December 31, 2024, as shown on Form 5500, Schedule H, Part IV, Line 4i.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

FASB *Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1.** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2.** Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3.** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

**Mutual Funds and Money Market Fund.** Valued at the closing price reported on the active market on which the individual securities are traded.

**Common/Collective Trust Funds.** Valued at their daily net asset value (“NAV”) of units of the collective trust funds, which are based on the fair value of the funds’ underlying assets. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The stable value fund is composed primarily of fully benefit-responsive investment contracts.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participants become 100% vested in their Employer discretionary contributions.

**NOTE 6 – INCOME TAX STATUS**

The Plan uses a prototype non-standardized cash or deferred Profit-Sharing Plan, which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan has been modified since receiving such letter, however, the Employer and the Plan’s advisors believe that the Plan is designed and is being operated in accordance with the applicable provisions of the IRC. The Employer is not aware of any course of action or series of events that have occurred that would adversely affect the qualified status of the Plan.

**NOTE 7 – RELATED-PARTY TRANSACTIONS**

Certain Plan investments are managed by the Custodian, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in any combination of mutual funds, registered investment companies and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**NOTE 9 – TRANSFERS IN FROM QUALIFIED PLANS**

During the year, the net assets available for benefits of BG Buildingworks, Inc. 401(k) Profit Sharing Plan were transferred into the Plan on June 27, 2024. The assets transferred in connection with the acquisition consisted entirely of investments at fair value totaling approximately \$4,077,000.

**NOTE 10 – SUBSEQUENT EVENTS**

Management has evaluated all known subsequent events or transactions from December 31, 2024 through October 3, 2025, the date the accompanying financial statements were available to be issued, and is not aware of any material subsequent events occurring during this period that have not been disclosed in the notes to the financial statements.
