Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of iCAD, Inc 401k Profit Sharing Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974 (ERISA)*, as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of iCAD, Inc 401k Profit Sharing Plan and to meet our other ethical responsibilities, in

accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about iCAD, Inc 401k Profit Sharing Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Supplemental Schedule Required by ERISA

The supplemental schedule listed in the table of contents is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of the Plan

The following description of iCAD, Inc 401k Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established to provide eligible employees of iCAD, Inc (Company) with retirement benefits in accordance with Section 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity is the trustee of the Plan. Fidelity Management Trust Company serves as Plan custodian.

Eligibility

All employees of the Company over the age of 21, other than college co-ops or interns with less than 1,000 hours of service, are eligible to participate in the Plan.

The Plan includes an automatic enrollment provision in which the Company automatically, on behalf of those participants meeting the eligibility criteria, defers 5% of the participants’ eligible compensation (as defined). Eligible employees are enrolled 30 days after such employee becomes eligible. These deferrals will be allocated to a default fund as defined in the plan document. Participants may cancel, modify or otherwise change any of the automatic elections.

Participant Contributions

Eligible participants may elect to contribute up to 90% of their eligible pre-tax annual compensation, as defined by the Plan, limited to the maximum amount allowable under the provisions of the IRC (\$23,000 in 2024). In addition, participants who are 50 years of age or older as of December 31, 2024, may contribute an additional “catch up” contribution (\$7,500 in 2024). The Plan also allows for participants to defer funds into a Roth 401(k). These deferrals are subject to federal income taxes, and the maximum allowable participant contribution is \$23,000 combined between both the Roth and the pre-tax deferral. The Plan currently offers various mutual funds and a stable value fund as investment options for participants.

Employer Contributions

The Company makes a safe harbor matching contribution of 100% of every dollar contributed, not to exceed 3% of the participants’ eligible compensation and 50% of every dollar contributed on the next 2% of the participants’ eligible compensation.

The Company may make additional discretionary matching contributions on behalf of eligible participants who are not highly compensated employees and discretionary non-elective contributions on behalf of eligible participants who are employed by the Company on the last day of the plan year and have met the minimum service requirement of 1,000 hours. No additional discretionary matching or non-elective contributions were made during the year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with its respective contributions and its allocation of (a) employer contributions and (b) Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined.

Vesting

Participants' voluntary contributions, rollover contributions, safe harbor matching contributions and any earnings thereon vest immediately. Vesting in additional discretionary matching and non-elective contributions and any earnings thereon is based on the number of years of continuous service (as defined). Participants are 100% vested after one year of continuous employment. In the event of death, disability, or attainment of age of 59½, participants' accounts become fully vested.

Payment of Benefits

Upon termination of employment, retirement, death, or disability, the participant or the participant's beneficiary is entitled to receive the vested portion of the participant's account in a single lump-sum or in installment payments. Further, withdrawals from the Plan before leaving the Company are available after attaining the age of 59½ or for special "hardship" reasons (as defined). Distributions to participants are recorded when paid.

The plan also allows partial withdrawals from the vested portion of a participant's account upon termination of employment, retirement, death or disability.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Participants may borrow up to 50% of their vested account balance with a minimum of \$1,000 and a maximum of \$50,000. Loans are subject to approval by the plan administrator and terms range from one to five years. However, if the loan is to acquire the principal residence of the participant, the term may be extended. Further, loans will bear interest at a reasonable percentage interest rate to be determined by the plan administrator and are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions.

Forfeitures

The Plan provides that forfeitures, the unvested portion of employer contributions for terminated participants, will be used to pay the Plan's administrative expenses as they occur. Any remaining forfeitures will serve to reduce future Company contributions. At December 31, 2024 and 2023, the net forfeiture balance was \$1,124 and \$933 respectively. No forfeitures were used during the year ended December 31, 2024.

Note 2. Summary of Significant Accounting Policies

The following is a summary of significant accounting policies followed by the Plan.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Administrative Expenses

Administrative expenses of the Plan are paid by either the Plan or the Company, as provided for in the Plan document.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains on investments bought and sold as well as held during the year.

Note 3. Certification of Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule, is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, or a person who owns more 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are shares of mutual funds and a stable value fund managed by Fidelity. Fidelity is the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Company directly pays any other fees related to the Plan's operations.

- The Plan paid \$225 of recordkeeping fees to Fidelity during the year ended December 31, 2024. The Company provides certain administrative services at no cost to the Plan.

Note 5. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets.
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets.

The following is a description of the valuation methodologies and inputs used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value fund: Value is based on the underlying unit value of the assets held. The assets of the underlying fund are invested primarily in certain government obligations, asset-backed securities, nonconvertible bonds, and other securities. The fair value of the contracts is determined using the market approach based on market prices of similar contracts. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the fund, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Investments Measured Using the Net Asset Value per Share Practical Expedient

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

Note 6. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Partial Termination of Plan

During the year ended December 31, 2024, the Company terminated employees which exceed the 20% turnover ratio, triggering a partial plan termination. As a result, Plan management determined a partial termination of the Plan had occurred. Plan management worked with a third-party administrator to fully vest the terminated employees and refund any amounts that were previously forfeited by these employees.

Subsequent to year-end, the Company made the decision to terminate the Plan, as further disclosed in Note 9.

Note 7. Tax Status

The Plan operates under a non-standardized Preapproved Profit Sharing Plan with CODA adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Fidelity. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

Subsequent events have been evaluated through October 2, 2025, which is the date the financial statements were available to be issued.

Plan Termination and Liquidation of Plan Assets

On July 16, 2025, the Company terminated the Plan. All Plan assets were liquidated and distributed to the participants. The participants had the option of receiving the liquidation distribution in the form of cash, a deferred annuity or as a rollover into another qualified plan. The remaining assets after the satisfaction of all liabilities of the Plan were distributed to the Company.

The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1. Description of the Plan

The following description of iCAD, Inc 401k Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established to provide eligible employees of iCAD, Inc (Company) with retirement benefits in accordance with Section 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity is the trustee of the Plan. Fidelity Management Trust Company serves as Plan custodian.

Eligibility

All employees of the Company over the age of 21, other than college co-ops or interns with less than 1,000 hours of service, are eligible to participate in the Plan.

The Plan includes an automatic enrollment provision in which the Company automatically, on behalf of those participants meeting the eligibility criteria, defers 5% of the participants’ eligible compensation (as defined). Eligible employees are enrolled 30 days after such employee becomes eligible. These deferrals will be allocated to a default fund as defined in the plan document. Participants may cancel, modify or otherwise change any of the automatic elections.

Participant Contributions

Eligible participants may elect to contribute up to 90% of their eligible pre-tax annual compensation, as defined by the Plan, limited to the maximum amount allowable under the provisions of the IRC (\$23,000 in 2024). In addition, participants who are 50 years of age or older as of December 31, 2024, may contribute an additional “catch up” contribution (\$7,500 in 2024). The Plan also allows for participants to defer funds into a Roth 401(k). These deferrals are subject to federal income taxes, and the maximum allowable participant contribution is \$23,000 combined between both the Roth and the pre-tax deferral. The Plan currently offers various mutual funds and a stable value fund as investment options for participants.

Employer Contributions

The Company makes a safe harbor matching contribution of 100% of every dollar contributed, not to exceed 3% of the participants’ eligible compensation and 50% of every dollar contributed on the next 2% of the participants’ eligible compensation.

The Company may make additional discretionary matching contributions on behalf of eligible participants who are not highly compensated employees and discretionary non-elective contributions on behalf of eligible participants who are employed by the Company on the last day of the plan year and have met the minimum service requirement of 1,000 hours. No additional discretionary matching or non-elective contributions were made during the year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with its respective contributions and its allocation of (a) employer contributions and (b) Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined.

Vesting

Participants' voluntary contributions, rollover contributions, safe harbor matching contributions and any earnings thereon vest immediately. Vesting in additional discretionary matching and non-elective contributions and any earnings thereon is based on the number of years of continuous service (as defined). Participants are 100% vested after one year of continuous employment. In the event of death, disability, or attainment of age of 59½, participants' accounts become fully vested.

Payment of Benefits

Upon termination of employment, retirement, death, or disability, the participant or the participant's beneficiary is entitled to receive the vested portion of the participant's account in a single lump-sum or in installment payments. Further, withdrawals from the Plan before leaving the Company are available after attaining the age of 59½ or for special "hardship" reasons (as defined). Distributions to participants are recorded when paid.

The plan also allows partial withdrawals from the vested portion of a participant's account upon termination of employment, retirement, death or disability.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Participants may borrow up to 50% of their vested account balance with a minimum of \$1,000 and a maximum of \$50,000. Loans are subject to approval by the plan administrator and terms range from one to five years. However, if the loan is to acquire the principal residence of the participant, the term may be extended. Further, loans will bear interest at a reasonable percentage interest rate to be determined by the plan administrator and are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions.

Forfeitures

The Plan provides that forfeitures, the unvested portion of employer contributions for terminated participants, will be used to pay the Plan's administrative expenses as they occur. Any remaining forfeitures will serve to reduce future Company contributions. At December 31, 2024 and 2023, the net forfeiture balance was \$1,124 and \$933 respectively. No forfeitures were used during the year ended December 31, 2024.

Note 2. Summary of Significant Accounting Policies

The following is a summary of significant accounting policies followed by the Plan.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Administrative Expenses

Administrative expenses of the Plan are paid by either the Plan or the Company, as provided for in the Plan document.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains on investments bought and sold as well as held during the year.

Note 3. Certification of Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule, is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, or a person who owns more 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are shares of mutual funds and a stable value fund managed by Fidelity. Fidelity is the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Company directly pays any other fees related to the Plan's operations.

- The Plan paid \$225 of recordkeeping fees to Fidelity during the year ended December 31, 2024. The Company provides certain administrative services at no cost to the Plan.

Note 5. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets.
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets.

The following is a description of the valuation methodologies and inputs used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value fund: Value is based on the underlying unit value of the assets held. The assets of the underlying fund are invested primarily in certain government obligations, asset-backed securities, nonconvertible bonds, and other securities. The fair value of the contracts is determined using the market approach based on market prices of similar contracts. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the fund, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Partial Termination of Plan

During the year ended December 31, 2024, the Company terminated employees which exceed the 20% turnover ratio, triggering a partial plan termination. As a result, Plan management determined a partial termination of the Plan had occurred. Plan management worked with a third-party administrator to fully vest the terminated employees and refund any amounts that were previously forfeited by these employees.

Subsequent to year-end, the Company made the decision to terminate the Plan, as further disclosed in Note 9.

Note 7. Tax Status

The Plan operates under a non-standardized Preapproved Profit Sharing Plan with CODA adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Fidelity. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

Subsequent events have been evaluated through October 2, 2025, which is the date the financial statements were available to be issued.

Plan Termination and Liquidation of Plan Assets

On July 16, 2025, the Company terminated the Plan. All Plan assets were liquidated and distributed to the participants. The participants had the option of receiving the liquidation distribution in the form of cash, a deferred annuity or as a rollover into another qualified plan. The remaining assets after the satisfaction of all liabilities of the Plan were distributed to the Company.
