Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Quality King Distributors, Inc. 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects,

the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

QUALITY KING DISTRIBUTORS, INC. 401(k) SAVINGS PLAN

Notes to Financial Statements

1. Plan Description

The following description of the Quality King Distributors, Inc. 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement or Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a contributory, defined contribution 401(k) plan established on March 1, 1997, and restated periodically for legislative matters and to add certain employee groups. The Plan covers all eligible employees of Quality King Distributors, Inc. and its Subsidiaries and Affiliates (the "Company" or the "Employer") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Management of the Plan

Plan assets are held and invested by Principal Trust Company ("Principal") as Trustee and Custodian, under the terms of a Trust Agreement. Principal is also the Recordkeeper of the Plan, which provides core administrative and consulting services under the terms of a Service Agreement. The Plan's administrator and sponsor, Quality King Distributors, Inc., is responsible for administration of the Plan. Contributions are invested in various funds made available at the discretion of the participants.

Eligibility

Employees of the Company are automatically enrolled in the Plan after completing 60 days of employment. To be eligible for employer contributions, the employee must complete one year of service, as defined, be at least 21 years of age and have worked not less than 1,000 hours. Enrollment for new eligible participants occurs monthly.

Contributions

Participants are automatically enrolled to defer 6% of their pay, with the deferral rate increasing by 1% each October 1 until it reaches a maximum of 15% (increased from 12% in December 2024), unless the participant elects to opt out or select a different percentage. Participants may elect to contribute up to 100% of their annual compensation, subject to certain regulatory limitations. Contributions may be made on either a pre-tax or Roth (after-tax) basis, and related earnings are nontaxable until withdrawn from the Plan. Employer matching contributions are discretionary. No employer contributions were made for the 2024 or 2023 plan years. Rollover contributions from another qualified plan owned by the participant are permitted and may vary each year depending upon participants' requests.

Participants' Accounts

Each participant's account is credited with the participant's contributions, any applicable employer contributions and an allocation of net plan earnings. Participants may direct the investment of their account balances and rollover contributions into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their voluntary contributions, rollovers, and any income or loss thereon. Participants become vested in Company contributions after two years at a rate of 20% annually, resulting in 100% vesting after six years of service.

Payment of Benefits

Upon termination of service due to death, disability, separation or retirement, a participant may elect to receive a lump-sum distribution or installment payouts. In service withdrawals are permitted for participants who are age 59 ½ or older or have a financial hardship.

Forfeitures

Forfeitures result when a participant has unvested employer contributions and terminates employment. Forfeitures may be utilized to reduce Company contributions or expenses paid to the Plan or allocated among participant accounts on the same basis as the employer contributions, at the discretion of the employer. Forfeitures during the years ended December 31, 2024 and 2023 were, \$34 and \$1,940, respectively. They are generally used to offset employer Plan expenses in the year following the year in which they occurred.

Notes Receivable from Participants

Participants are permitted to receive loans from the assets of the Plan subject to certain restrictions. Based on the terms of the Plan, participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of the value of the participant's vested account balance. Under the CARES Act, through December 31, 2020, qualified participants were permitted to withdraw up to \$100,000 and, as a result, certain notes receivable exceeded the \$50,000 maximum. The minimum loan amount is \$1,000. Loans are secured by the participant's account balance in the Plan. All loans, except for the purchase of a primary residence, are to be repaid in installments over a reasonable period of time, not to exceed five years, and bear interest at prevailing market rates. Interest rates on participant loans ranged from 4.25% to 9.50% at December 31, 2024 and 2023. Two outstanding loans are allowed per participant with only one loan approval allowed in a twelve-month period.

Administrative Expenses

Certain administrative expenses of the Plan are paid directly by the Company. Expenses that are paid by the Company are excluded from these financial statements. Service and transaction fees are paid by participants. Investment related expenses are included in net increase in fair market value of investments.

SECURE 2.0 Act of 2022

The SECURE 2.0 Act of 2022 (the "Act") was signed into law on December 29, 2022, to increase retirement savings, improve retirement rules, and lower employer costs of setting up a retirement plan. Plan amendments required by the Act generally need not be made until the end of the first plan year beginning on or after January 1, 2025; *however*, plans must be operated in accordance with the effective date of each new provision. Some of the more significant provisions that may affect the Plan include matters related to enrollment, distributions, contributions, loan payments and withdrawals. All required provisions for 2024 under the Act have been incorporated into the Plan.

Beginning January 1, 2025, individuals aged 60 to 63 are eligible for increased catch-up contributions of \$10,000 or 150% of the standard age 50+ catch-up contribution limit, whichever

is greater. Since the limit for those 50 or older for 2024 was \$7,500, the 2025 enhanced contribution limit for those 60-63 is \$11,250.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

All investments except for the guaranteed interest contract are stated at fair market value. Fair market value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The guaranteed interest contract is stated at contract value (see note 5). See note 6 for fair value measurements. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions of \$75,466 and \$204,747 in 2024 and 2023, respectively are included in the increase in fair market value of investments in the statements of changes in net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Form 5500 requires loans to be classified within investments, but this difference has no effect on net assets.

Payments of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan provides for various investment options including any combination of mutual funds, pooled separate accounts, collective investment trusts and a guaranteed interest contract. The underlying investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participants' individual account balances.

3. Reconciliation of Financial Statements and Form 5500

The accompanying financial statements have been prepared on the accrual basis of accounting, which may differ from the modified cash basis of accounting used to prepare the Plan's Form 5500. There were no differences for the years ended December 31, 2024 and 2023.

4. Certified Information

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

5. Guaranteed Interest Contract

This investment is a guaranteed-general-account backed group annuity contract, issued by Principal Life Insurance Company ("PLIC") to Principal Trust Company as custodian. A rate of interest contractually guaranteed by PLIC is credited to account balances. This stable value group annuity contract is referred to as the Principal Fixed Income Option ("PFIO"). Benefits payments are made at book value. No redemption fees, early withdrawal charges, or market value adjustments are charged on transfers of assets into or out of the contract initiated by a participant request. Thus, this contract is considered benefit responsive. An employer-level surrender or initiated transfer of an interest in the contract will be subject to either a 12-month advance notice or a 5% surrender charge, whenever the employer chooses.

As required by the Financial Accounting Standards Board ("FASB") Accounting Standards Codification (FASB ASC) 962, "Plan Accounting – Defined Contribution Pension Plans", investment contracts such as the PFIO are to be reported at contract value. Principal notes that the PFIO cannot be sold, transferred, or assigned externally. Thus, there is limited market data to support valuation and the best proxy for fair value for plans that intend to maintain this contract is an assumed transaction involving plan participants or plan sponsors. Most participant transactions are executed using contract value without adjustment. Therefore, contract value is a good proxy for fair value.

The methodology for calculating the interest crediting rate is defined in the contract. Under the terms of the existing contract, the crediting rate is reset on a semiannual basis. As a result, the average yield earned by the Plan is the yield earned (i.e. interest credited) on the group annuity contract.

The interest rate history and average yield earned for the contract is as follows:

January 1 – June 30, 2023	1.40%
July 1 – December 31, 2023	1.70%
January 1 – June 30, 2024	1.60%
July 1 – December 31, 2024	1.40%

The Plan may transact at contract value according to the terms defined in the contract at any time the contract remains in effect. There are no significant limitations on such transactions. The contract defines the circumstances and amounts for which the contract may be terminated by the Plan and under which the issuer, PLIC, has the right to no longer receive deposits. Terminations or amendments generally may be made without the consent of participants on 60 days written notice by PLIC or the Plan sponsor.

6. Fair Value Measurements

FASB ASC 820, “Fair Value Measurements and Disclosures”, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023.

Mutual funds: Fair values are based on unadjusted quoted prices in active markets for identical assets.

Pooled separate accounts and collective investment trusts: These investments are valued at their Net Asset Value (“NAV”) per share as of the close of business on the valuation date. These investments provide daily liquidity to the funds and do not currently include restrictions on redemptions by the funds or unfunded commitments at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7. Party-In-Interest and Related Party Transactions

Plan investments include a guaranteed interest contract as well as mutual funds, pooled separate accounts, and collective investment trusts managed by Principal, the Plan's Trustee and Custodian and, therefore these transactions qualify as party-in-interest. Administrative fees paid to Principal were \$9,857 and \$8,308 for the years ended December 31, 2024 and 2023. Though no compensation was paid through the Plan, Leumi Investment Services Inc. served as investment advisor and received fees paid by Principal. Loans to participants also qualify as party-in-interest transactions.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants' accounts will become fully vested and non-forfeitable.

9. Tax Status

A favorable opinion letter was received on June 30, 2020 from the Internal Revenue Service ("IRS") for the prototype plan adopted by the Plan. The updated plan became effective on April

1, 2022. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code ("IRC") and that the Plan is qualified and tax-exempt as of the financial statement dates.

The Plan administrator evaluates its activities annually for potential tax positions that might be considered "uncertain" and is not aware of any such positions. The Plan is subject to routine audits by taxing authorities; however, there currently are no audits for any tax periods in progress.

10. Compliance Test

In order to ensure favorable tax treatment of participant accounts, the Plan may not exceed certain maximums for employee elective contributions and employer-matching contributions of highly compensated employees, as defined by the IRC. The Plan is required to take appropriate actions and make corrective distribution of excess contributions or make additional contributions to the accounts of non-highly compensated employees if IRC requirements are not met. For the years ended December 31, 2024 and 2023 the Plan was in compliance with these IRC requirements.

11. Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued. No events have been identified that require adjustment to the financial statements.

The Plan is subject to provisions of the Act that become effective for Plan years beginning after December 31, 2024. In September 2025, the IRS issued final regulations regarding catch-up contributions made by employees 50 years old or older. These contributions must be designated as Roth contributions. This rule, effective January 1, 2026 and referred to as the Roth mandate, affects participants whose 2025 wages exceed a specific income threshold. The Plan is evaluating the impact of other provisions and will implement any required changes in accordance with applicable law.
