INDEPENDENT AUDITORS' REPORT

To the Participants and Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of 403(B) Thrift Plan of Frank Olean Center, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the 403(B)Thrift Plan of Frank Olean Center, Inc.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024, and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in *Note 6* to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the 403(b) Thrift Plan of Frank Olean Center, Inc. provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan. The plan covers employees of the Frank Olean Center, Inc. (the “Company”) with matching contributions for those who have completed one year of service and 1000 hours. Eligibility for making deferrals is immediate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions and Rollovers – Participants may contribute up to the maximum allowed by law of their compensation as defined in the Plan. The Company contributed the lesser of 2% of employee’s compensation or 100 percent of employee’s salary deferral during 2024. Participants direct the investment of their contributions into various investment options offered by the Plan. Currently, the Plan offers numerous mutual fund investment options, which are maintained in pooled separate accounts, as well as a guaranteed interest account option sponsored by Mutual of America. Participants are allowed to transfer or rollover funds into the Plan from other qualified or 403(b) plans.

Participant Accounts and Vesting – Each participant’s account is credited with participant salary deferrals, employer matching contributions and participant gains and losses. Participants are immediately vested in full in their own salary deferrals, employer matching contributions and investment earnings credited thereon.

Payment of Benefits Plan Loans Participant salary deferrals may be withdrawn in the case of hardships (as defined by the Plan), termination of employment, retirement, death or disability. Employer contributions may be withdrawn upon termination of employment, retirement, death or disability.

Plan Loans - Participants may borrow up to the lesser of \$50,000 or fifty percent (50%) of their account value from the plan custodian. These plan loans are secured by the participant’s balance in the plan, and payments on these loans are made outside of the plan. All loans must be repaid within five (5) years except for the purchase of a primary residence where the participant must repay within fifteen (15) years. As of December 31, 2024, a total of \$12,387 in plan loans were secured by their respective participants’ account balances.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

BASIS OF PRESENTATION AND ACCOUNTING

The information in the accompanying financial statements has been prepared from the financial data certified by the custodian of Plan assets in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information certified by the custodian differs from that which is included in the accompanying financial statements due to the use of the cash basis of accounting by the custodian and the accrual basis of accounting in the accompanying financial statements.

USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the dates of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the dates of the financial statements. Actual results could differ from those estimates.

INVESTMENTS

The Plan's investments are reported at fair value. Units of the pooled separate accounts are valued at the net asset value as reported by the custodian at year-end. The net appreciation in the fair value of investments includes realized and unrealized gains and losses on the fair value of investments held by the Plan.

FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan holds the type of fully benefit-response investment contracts known as traditional investment contracts. The traditional investment contracts are referred to by the Plan as the Guaranteed Interest Account ("GIA"). The Plan is required to report these investment contracts held by a defined contribution plan at contract value. Contract value is the relevant measurement attribute for full benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The statement of net assets available for benefits presents the contract value of the guaranteed interest account.

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than one percent (1%).

Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to a participant termination of employment due to:

- 1) Removal of a group of participants from plan coverage as a result of temporary absence.
- 2) Change in position or other occurrence qualifying as a temporary break in service under the plan.
- 3) Transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer.
- 4) Cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the plan sponsor's business.
- 5) Removal from the plan of one or more groups or classifications of participants.
- 6) Partial or complete plan termination.
- 7) Plan disqualification.

CONTRIBUTIONS

Contributions from employees and the Company are recorded in the period in which the Organization makes the payroll deductions from participant earnings.

BENEFITS PAID TO PARTICIPANTS

Benefits paid to participants are recognized when the disbursement is made. At December 31, 2024 and 2023, there were no benefits processed and approved for payment, but not paid.

ADMINISTRATIVE EXPENSES

The Company has paid the majority of Plan administrative expenses for the year ended December 31, 2024.

SUBSEQUENT EVENTS

The Plan has performed an evaluation of subsequent events through September 30, 2025, which is the date the financial statements were issued. Subsequent events are discussed in *Note 13*.

NOTE 3 - INCOME TAX STATUS

403(b) plans currently are not required to submit plans to the Internal Revenue Service for determination. However, the plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

NOTE 4 - CONCENTRATIONS OF CREDIT RISK

The Plan provides for various investment options in any combination of pooled separate accounts and a guaranteed interest account with various investment objectives. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE 6 - SUMMARY OF FINANCIAL DATA CERTIFIED BY THE CUSTODIANS

Plan financial information and data certified by the custodian of Plan assets (Mutual of America Life Insurance Company) in accordance with 29 CFR 2520.10 3-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA includes investment assets, transactions and income as well as the supplemental schedules to Form 5500.

NOTE 7 - FAIR VALUE OF INVESTMENTS

The Financial Accounting Standards Board (“FASB”) *Accounting Standards Codification*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under accounting principles generally accepted in the United States of America are described as follows:

Level 1 – Unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 – Quoted prices for similar instruments in active markets; quoted prices for identical or similar instruments in markets that are not active; and model-derived valuations in which all significant inputs and significant value drivers are observable in active markets.

Level 3 – Valuations derived from valuation techniques in which one or more significant inputs or significant value drivers are unobservable.

The Plan’s valuation methodology used to measure the fair value of the pooled separate accounts is net asset value per unit or share. As such, pooled separate accounts are excluded from the three level fair value hierarchy defined above. On a participant level, issuances and redemptions of units or shares in pooled separate accounts can be made on each business day without limitations or penalties. The pooled separate accounts have no unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

During the year ended December 31, 2024, the Company failed to automatically enroll new hires in accordance with the Plan's agreement and allow for employee deferrals for those new hires.. This non-compliance is being corrected in the 2025 Plan year (*See Note 13*).

NOTE 13 - SUBSEQUENT EVENT

As mentioned previously, the Company failed to automatically enroll employees hired during 2024 under its auto-enrollment provision within the Plan document. As of the date of the audit report, the Company was in the process of correcting the non-compliance by auto-enrolling all affected employees with official notice that they may formally opt out of the Plan within 30 days of notification.
