## Independent Auditors' Report

### Opinion

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the cash basis of accounting described in Note 2, and for determining that the cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.


In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Ozarks Coca-Cola/Dr Pepper Bottling Company Group Health Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

## 1. Description of Plan

The following description of the Ozarks Coca-Cola/Dr Pepper Bottling Company Group Health Plan (Plan), sponsored by Ozarks Coca-Cola/Dr Pepper Bottling Company (Company), provides only general information about the Plan's provisions. Participants should refer to the plan agreement for a more complete description of the Plan's provisions, copies of which may be obtained from the Plan sponsor.

**General:** The Plan provides eligible participants and their qualifying dependents with health, dental, vision, life, and short-term disability benefits as determined by the Plan and the various insurance policies in effect. Certain Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility:** An employee is considered to be eligible if the employee normally works at least 30 hours per week and is on the regular payroll of the Company, is in a class eligible for coverage, and completes the applicable waiting period of 60 days. A family member of an employee will become eligible for dependent coverage on the first day that the employee is eligible for coverage. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

**Post-retirement benefits:** Collective bargaining group employees who have reached age 61 and have at least 20 years of continuous service are provided post-retirement benefits. Coverage continues until the earlier of attaining age 65, receiving medical coverage from other employment, or receiving Medicare benefits.

**Self-insured benefits:** The claims for self-insured benefits are processed by the Plan's third-party claims processor under administrative services only arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan's trust or the general assets of the Company. This processor is considered a party-in-interest under ERISA. Despite the utilization of the third-party claims processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

**Stop loss coverage:** The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

**Employer contributions:** The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis. The costs of the postretirement benefits are shared by the Company and retirees.

**Participant contributions:** In addition to deductibles and copayments, participants pay a portion of their total premium and a portion of the cost of covering their eligible dependents based on their respective benefit elections.

**Parties-in-interest:** Certain employees of the Company serve as the Plan's Trustees. The Trustees do not receive any compensation for services rendered to the Plan. Substantially all of the administrative costs of the Plan are paid by the Company.

## 2. Summary of Significant Accounting Policies

**Basis of accounting:** The Plan's policy is to prepare its financial statements on the cash basis of accounting; consequently, certain revenues are recognized when received rather than when earned, and certain expenses are recognized when cash is disbursed rather than when the obligation is incurred.

**Estimates:** The preparation of financial statements in conformity with the cash basis of accounting requires plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Payment of benefits:** Premiums paid by either the Company or the VEBA trust are recorded as insurance premium payments in the accompanying statements of changes in net assets available for benefits – cash basis.

Claim payments and short-term disability payments are recorded when paid by the third-party claims processor. These payments are recorded as benefit claims paid in the accompanying statements of changes in net assets available for benefits – cash basis.

**Stop loss:** Premiums for stop loss insurance are included in insurance premium payments in the accompanying statements of changes in net assets available for benefits – cash basis. Stop loss refunds totaling \$1,207,857 and \$915,835 are recorded as reinsurance benefits in the accompanying statements of changes in net assets available for benefits – cash basis for the years ended December 31, 2024 and 2023, respectively.

**Refunds:** Refunds due from the Plan's PBM are recorded when received as an offset netted against benefit claims paid. Pharmacy rebates totaling \$286,981 and \$343,584 have been netted with benefit claims paid in the accompanying statements of changes in net assets available for benefits – cash basis for the years ended December 31, 2024 and 2023, respectively.

**Subsequent events:** Management has evaluated subsequent events between the end of the most recent fiscal year end and October 7, 2025, the date the financial statements were available to be issued.

## 3. Risks and Uncertainties

The actuarial present value of the benefit obligation is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to

change. The plan obligation for health claims incurred but not reported are estimated based on experience and actual claims reported subsequent to year end. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

### 4. Administrative Fees

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators. These expenses are reported on the statements of changes in net assets available for benefits as administrative fees. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

### 5. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to and contributions required of participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

### 6. Tax Status

The VEBA trust funding certain benefits of the Plan received an exemption letter from the IRS dated April 10, 1997, stating that the trust is tax-exempt under the provisions of Section 501(a) of the IRC. However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded for the years ended December 31, 2024 and 2023 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require disclosure in the financial statements. A tax liability would be recognized if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employee service rendered to December 31, reduced by the actuarial present value of contributions expected to be received in the future from current retirees of the Plan. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated collective bargaining group employees and their beneficiaries and dependents and (2) active collective bargaining group employees and their beneficiaries and dependents after retirement from service with the participating employer. Prior to an active collective bargaining group employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the Company rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

For measurement purposes, a 7% annual rate of increase in the per capita cost of covered health care benefits was assumed for both 2024 and 2023; the rate was assumed to decrease gradually to 4.75% and to remain at that level thereafter.

The weighted-average health care cost-trend rate assumption has a significant effect on the amounts reported above. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of December 31, 2024 and 2023, by \$118,017 and \$134,585, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

## 8. Reinsurance Agreements

The Plan has purchased excess loss reinsurance coverage from an unrelated insurer for individual claims in excess of specific deductibles for the years ended December 31, 2024 and 2023. To the extent the reinsurer is unable to meet obligations under the agreement, the Plan remains contingently liable for the excess with no annual limit. The specific deductible for excess loss reinsurance for most participants is \$100,000 for each year ended December 31, 2024 and 2023. For the year ended December 31, 2024, the deductibles for four specific beneficiaries ranged from \$150,000 to \$600,000 each. For the year ended December 31, 2023, the deductibles for six specific beneficiaries ranged from \$180,000 to \$525,000 each.
