## Independent Auditor's Report

### NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

#### NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Rotary Corporation 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

##### General

The Plan is a defined-contribution retirement plan which was established on January 1, 1971 and covers all full-time and part-time employees of Rotary Corporation (the Company) who have completed ninety days of services and who are at least eighteen years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### Contributions

Contributions to the Plan are made voluntarily by participating employees who elect a salary reduction which is remitted to the Plan by the Company on behalf of participants. Employees are automatically enrolled in the Plan on the first day of the month following ninety days of service with a pre-tax elective deferral of 4%, and the percentage automatically increases each January 1 by 1% up to a maximum percentage of 6%. Plan participants are permitted to contribute pre-tax deferrals to the Plan subject to ERISA limitation of \$23,000 and \$22,500 during the years ended December 31, 2024 and 2023, respectively. Participants who attain age 50 before the end of the Plan year may contribute an additional \$7,500 catch up amount for the years ended December 31, 2024 and 2023. The Plan also provides for rollover contributions by participants from other qualifying plans.

The amount of the Company's annual profit-sharing contribution to the Plan is determined at the discretion of the Board of Directors. There were no profit-sharing contributions for the years ended December 31, 2024 and 2023. The Plan has a Safe Harbor provision, and under this provision, the Company makes contributions that match 100% of participant contributions up to 3% of participant compensation and 50% of the next 2% that participants defer.

##### Participant accounts

Each participant's account is credited with the employee's contributions and the Company's related matching contributions and with an allocation of (a) the Company's profit sharing contribution, and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocation of the Company's profit sharing contributions is calculated using a pro rata method based on the participant's total compensation. Allocation of Plan earnings and administrative expenses are calculated using a pro rata method based on the participant's account balance. A participant is entitled to the benefit provided from the participant's vested account balance.

##### Investment options

Investments are participant-directed among forty-two funds.

## NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

### Forfeitures

Forfeitures of the nonvested portion of individual participants' account balances are used to pay other fees and reduce employer contributions. There were unallocated forfeited amounts of \$3,896 and \$0 at December 31, 2024 and 2023, respectively. Forfeitures utilized towards employer contributions totaled \$0 for the years ended December 31, 2024 and 2023.

### Participant loans

A participant may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of (a) 50% of the participant's vested balance reduced by any outstanding loan balance or (b) \$50,000 reduced by the highest outstanding loan balance during the one year period ending on the day before the loan is made. A participant may have only one outstanding loan at any given time and may not exceed two loan distributions in a twelve month period. Interest rates on outstanding notes receivable from participants ranged from 4.25% to 9.50% at December 31, 2024 and 2023.

### Payment of benefits

Benefits are payable upon (a) termination of service, (b) after attainment of age 59 1/2, or (c) death or permanent disability. A participant may elect to receive a lump sum equal to the value of his or her vested account, a qualified joint and survivor annuity, equal installments not to exceed the joint life expectancy of the participant and the participant's spouse (if married) or the participant's life expectancy (if not married), an annuity income payable which is in compliance with the Internal Revenue Code and Regulations, or periodic installments paid not more often than annually. Additionally, the Plan allows for in-service hardship distributions subject to Plan provisions. Benefits under the Plan are fully funded and are therefore exempt from the benefits termination insurance provision of ERISA.

At December 31, 2024 and 2023, \$0 of benefits had been processed for payment to persons who had requested distributions but had not yet been paid by the Plan.

### Vesting

Participants are fully vested in all employee and Safe Harbor Company contributions made to the Plan. The allocations to each participant's account arising from non-safe harbor Company contributions and Plan earnings are vested in accordance with the following schedule:

Upon attainment of normal retirement age, total permanent disability, or death, a participant or their beneficiary becomes 100% vested.

### Contributions receivable

Contributions receivable are based upon the timing difference between the determined contributions of the employer and employees and the receipts by the investment trustee.

## NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of accounting

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with the accounting principles generally accepted in the United States of America (U.S. GAAP). Accordingly, contributions are recognized when determined, rather than when received, and expenses are recognized when incurred, rather than when paid.

### Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements. Consequently, actual results could differ from those estimates.

### Valuation of investments

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Investment earnings include the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes receivable from participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

### Reclassification

Certain prior year amounts have been reclassified to conform to current year presentation.

### Subsequent events

The Plan has been evaluated for subsequent events through October 8, 2025, the date the financial statements were available to be issued.

## NOTE 3 - RELATED PARTY TRANSACTIONS

Advus Financial Partners is contracted to aid in management of the Plan at a cost of 20 basis points of the Plan size. This expense is assumed by the Plan.

The Company absorbs certain administrative expenses of the Plan which totaled \$9,700 and \$14,980 for the years ended December 31, 2024 and 2023, respectively. These fees were in addition to the administrative fees paid by the Plan.

## NOTE 4 - EXEMPT PARTY-IN-INTEREST TRANSACTIONS

The trustee is authorized under contract provisions, and by ERISA regulations providing an administrative or statutory exemption, to invest in funds under its control. Certain Plan investments, including collective investment trusts, are managed by Principal Trust Company, the trustee. These transactions qualify as exempt party-in-interest transactions. Fees paid for investment management services were included as a reduction of the return on each fund.

#### NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

#### NOTE 6 - DESCRIPTION OF INFORMATION CERTIFIED BY THE INVESTMENT TRUSTEE

As permitted by Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator has elected to have the investment trustee of the Plan, Principal Trust Company, certify as to the accuracy and completeness of certain information included in the accompanying financial statements and schedules in lieu of the Plan's independent accountants examining such information. Accordingly, the following information was certified by the investment trustee and was not subjected to any auditing procedures except for comparing such information with the related information contained in the accompanying financial statements and supplemental schedules:

- Investments in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Activity in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Information included in the supplemental schedule, as listed in the accompanying table of contents.

#### NOTE 7 - INCOME TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter, however the Plan administrator believes that the current design and operation of the Plan are in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. Management of the Plan evaluated the Plan's tax positions and concluded that the Plan had taken no uncertain tax positions that require adjustment to the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by federal, state, or local tax authorities for years before 2021.

#### NOTE 8 - RISKS AND UNCERTAINTIES

The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near future and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.

## NOTE 9 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Collective investment trusts:* Collective investment trusts (CITs) are a versatile, cost-effective, and competitive alternative to mutual funds for defined contribution (DC) plans. In addition to offering participants reasonable, cost-efficient investment options, they can also help plan sponsors fulfill their fiduciary duty. As tax-exempt, pooled investment vehicles—available only to DC and other ERISA-qualified plans, CITs are pooled investment vehicles managed collectively in accordance with a common investment strategy. CITs in general are pooled investment vehicles sponsored and maintained by a bank or trust company that also serves as the trustee. CITs combine assets from eligible investors into a single investment portfolio (or “fund”) with a specific investment strategy. These trusts are required to publish their daily net asset value (NAV) and to transact at that price. The CITs held by the Plan are deemed to be actively traded.

*Mutual funds:* Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
