NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the TrueCommerce, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time employees of TrueCommerce, Inc. (the “Company” and “Plan Sponsor”) who are age 21 or older. The Plan excludes employees covered under a collective bargaining agreement, non-resident aliens who do not receive any compensation from U.S. sources, independent contractors, and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective January 1, 2020, the Plan was amended to be a Qualified Automatic Contribution Arrangement (“QACA”) Safe Harbor Plan to have automatic pre-tax deferral contributions at 6% of pay.

Administration

The Plan is administered by the Company (the “Plan’s management”). The Plan’s management has been given all powers necessary to carry out its duties, including, but not limited to, the power to administer and interpret the Plan, to answer all questions affecting eligibility of participants in the Plan, and to authorize disbursements for the payment of plan benefits. The Plan’s management appointed Principal Trust Company and Great Gray Collective Investment Trust as trustees and Principal Life Insurance Company as recordkeeper of the Plan.

Contributions

Each year, participants may make salary deferral contributions up to 100% of pre-tax or after-tax annual compensation, as defined in the Plan, up to the maximum allowed by the Internal Revenue Code (“IRC”). The maximum annual deferral for 2024 was \$23,000. Participants age 50 and over were eligible to make additional catch-up contributions of up to \$7,500 in 2024. The Plan provides for an automatic election as of the date an employee becomes a participant in the Plan, with a pre-tax contribution election of 6%. The Plan also has an automatic escalation feature in which participant deferrals are increased by 1% each year up to a maximum of 10%. Participants have the option to opt out of automatic enrollment and/or the auto escalation. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

For the plan year ending December 31, 2024, the Company matched 100% of each participant’s compensation contributed as elective deferrals that were not over 1% of compensation, plus 50% of each participant’s compensation contributed as elective deferrals which were over 2% but are not over 6% of compensation. The Plan allows yearly, escalating deferral contributions by employees.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of (a) employer contributions, (b) plan earnings or losses, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is equal to the vested balance in the participant’s account.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in a variety of investment options. All funds vary in types of investments, rates of return, and investment risk and are described in more detail in the Plan's literature. Participants may elect, on a daily basis, to have all or part of their account balances and future contributions transferred from one fund to another or in any combination.

Vesting

During 2019 and prior, participants vested in company matching contributions at a rate of 40% after the first year of service and at a rate of 30% per year thereafter until 100% vested after three years. As of January 1, 2020, participants vest in QACA matching contributions at a rate of 50% per year of service until 100% vested after two years. Participants are always 100% vested in their salary deferral contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to the lesser of \$50,000 or 50% of their vested account balance, reduced by any outstanding notes. Participants are limited to no more than two outstanding loans. Note terms range from one to five years or extend to a reasonable period of time consistent with commercial home loan practices for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan's management. Principal and interest are paid ratably through semimonthly payroll deductions.

Payment of Benefits

Upon termination of service, death, disability, or attainment of normal retirement age 65, a participant may elect to receive a lump-sum distribution, installment payments equal to the vested value of the participant's account, or transfer these amounts to another qualified retirement plan or individual retirement account. Participants may also take voluntary in-service withdrawals upon reaching age 59½, qualified reservist distributions, and hardship withdrawals if certain criteria are met as outlined in the Plan document.

Forfeited Accounts

Forfeitures of nonvested participant balances are used to pay administrative expenses and reduce employer matching contributions for the Plan year in which the forfeiture occurs. At December 31, 2024 and 2023, forfeited nonvested accounts were \$74,417 and \$41,484, respectively. Forfeitures of \$74,409 were utilized during the year ended December 31, 2024. The remaining unused forfeiture balance was \$8 and \$0 as of December 31, 2024 and 2023, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Fiduciary Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments, and the Plan Administrator deems the participant loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in supplemental schedule H, part iv, line 4i - schedule of assets (held at end of year).

Contributions

Employee contributions and related employer contributions are recognized in the period during which the Company makes payroll deductions from the participant's compensation or the year in which the compensation relates.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

- Gains and losses on investments are disclosed in the aggregate, not by investment type (Part II).
- The Stable Value Fund's contract value is reported at fair value in the Statements of Net Assets Available for Benefits and eliminates the reconciliation to contract value.

NOTE 3 - INFORMATION CERTIFIED BY PLAN TRUSTEE

The Plan Sponsor has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulation for Reporting and Disclosure under ERISA. Accordingly, the Plan Administrator obtained certifications from the trustees, Principal Trust Company and Great Gray Collective Investment Trust, that the information

- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments included schedule H, part iv, line 4i - schedule of assets (held at end of year) as of December 31, 2024 and notes to the financial statements.

At the request of the Plan Administrator, the Plan's certified public accountants did not perform any auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan follows a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Pooled Separate Accounts

Pooled separate accounts are valued at the net asset value (“NAV”) of the underlying assets as reported by the investment manager, Principal Trust Company, at year end.

Registered Investment Companies

Registered investment companies are valued at the quoted market prices of shares held by the Plan at year end in the active market on which the individual securities are traded.

Common Collective Trust

The common collective trust fund is valued at the NAV as reported by the investment manager at year end, adjusted to fair value based upon its audited financial statements. The fund’s underlying assets consist of investment contracts and security-backed contracts.

The methods described above may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are shares of registered investment companies, pooled separate accounts, and a common collective trust fund managed by affiliates of Principal Trust Company and Great Gray Collective Investment Trust as defined by the Plan. Fees paid by the Plan for investment management services were included as a reduction of the return of each fund. The Plan also issues loans to participants, which are secured by the vested balances of the participants' accounts. As such, transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE 7 - INCOME TAX STATUS

The Plan document is a prototype basic savings plan sponsored by Principal Financial Group. In an opinion letter dated March 31, 2014, the Internal Revenue Service ("IRS") stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan utilizes various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

As of December 31, 2024 and 2023, there were 3 investments held which individually accounted for more than 10% of net assets available for benefits. See supplemental schedule of assets (held at end of year) for a complete listing of investments held at December 31, 2024.

NOTE 9 - SUBSEQUENT EVENTS

The Company has evaluated subsequent events through October 6, 2025 which is the date the financial statements were available to be issued. There were no events or transactions discovered during the evaluation that require recognition or disclosure in the financial statements.
