Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audits of the accompanying financial statements of Amada North America Group Profit Sharing and 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of Amada North America Group Profit Sharing and 401(k) Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan established on April 1, 1979, covering all eligible employees, as defined in the Plan, of Amada North America, Inc. ("AAI" or the "Plan Sponsor"), Amada Capital Corporation, Amada Tool America, Inc. and Amada America, Inc. (collectively, the "Companies"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

B. Contributions

The Plan permits each eligible participant to contribute up to 100% of eligible compensation, as defined in the Plan, subject to Internal Revenue Code (the "IRC") limitations. Eligible participants are automatically enrolled into the Plan at a contribution rate of 2% and the Plan will automatically increase pre-tax election by 1%, up to 6% for eligible participants who are contributing at least 1% of pre-tax compensation. Participants may elect to make Roth contributions to the Plan and may rollover Roth contributions from another qualified plan into the Plan. Eligible participants may also elect to make after-tax contributions, subject to IRC limitations. Company matching contributions are 50% of a participant's elective deferral in each pay period, up to 3% of compensation. The Company may make additional discretionary matching contributions. The Companies' Boards of Directors elected to contribute additional profit sharing contributions of \$1,744,955 for the year ended December 31, 2024.

C. Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, rollover contributions, the Companies' matching contribution, and allocations of Companies' profit sharing contributions and Plan earnings and charged with withdrawals and an allocation of Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. Investments

Participants direct the investment of their contributions and the Companies' contributions into various investment options offered by the Plan. The Plan currently offers nine mutual funds, a pooled separate account, and an unallocated insurance contract as investment options for participants.

E. Eligibility

With the exception of Japanese nationals, union or leased employees, full-time employees will become eligible to participate in the Plan after completing 30 days of service, and part-time employees will become eligible to participate in the Plan when they have completed one year of service, and completed at least 1,000 hours of service.

F. Vesting

Participants are vested immediately in their own contributions, rollovers plus actual earnings thereon. A participant is fully vested after five years of credited service or upon death, retirement, or permanent disability. Vesting in the Companies' matching and discretionary contributions is based on years of credited service as follows:

2	50%
3	75%
4 or more years	100%

G. Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. The \$50,000 maximum amount will be reduced by the participant's highest outstanding loan balance in the previous 12 months, even if the amount has been paid. Loan terms range from one to five years, or up to 30 years for the purchase of a primary residence. Loans are secured by the balances in the participants' accounts and bear interest at the prime rate plus 1%. Principal and interest payments are made through payroll withholdings according to the terms of the promissory notes. At December 31, 2024, interest rates on loans ranged from 4.25% to 9.50%.

H. Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$348,790 and \$39,314, respectively. Forfeitures totaled \$111,053 in 2024; \$71,357 and \$44,011 were used to offset Company contributions and Plan expense, respectively. Forfeited amounts attributable to Company matching contributions are first used to restore nonvested account balances of rehired participants and then to reduce Company matching contributions. A rehired participant is eligible to have nonvested account balances restored provided he or she repays all distributions received from the Plan within five years after the rehire date and the rehire date is before five consecutive one-year breaks in service. Forfeited amounts attributable to Company discretionary contributions are reallocated to eligible Plan participants according to the same methodology and requirements for allocating discretionary contributions.

I. Payment of Benefits

Normal retirement age is 65. Upon termination of service, benefits are distributed in a lump-sum amount equal to the value of the participant's account. Hardship withdrawals are permitted. Benefits are recorded when paid. Distributions of \$5,000 or more may be distributed as installments over a period of time, not to exceed the remaining life expectancy. Payments may be made either monthly, quarterly, semi-annually or annually.

J. Administrative Expenses

Most administrative expenses incurred by the Plan are paid by the Companies.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

The participants select how their share of plan assets will be invested among those investment vehicles made available. Participants may change their investment options at any time during the Plan year.

GAAP establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are quoted prices in active markets.

Level 2 – Inputs are quoted prices for similar instruments and model based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

C. Investment Valuation and Income Recognition (Continued)

^A In accordance with ASC 820, investments measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

Level 1 investments consist of mutual funds reported at fair value, which is determined daily based on quoted market prices. Pooled separate accounts are valued at net asset value. Shares may be redeemed any time at net asset value. There are no restrictions on redemptions and no unfunded commitments to purchase additional shares of the pooled separate accounts. Interest and dividends are recorded on the accrual basis. Capital gains are recorded as interest and dividends. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments relates to mutual funds.

D. Risks and Uncertainties

Plan investments are exposed to various risks such as interest rate, market fluctuations and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in equity markets, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and statement of changes in net assets available for benefits.

NOTE 3 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEES

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Retirement, LLC and Empower Annuity Insurance Company of America, the trustees of the Plan.

NOTE 4 - PLAN TERMINATION

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan's termination, participants will become 100% vested in their account balances.

NOTE 5 - INCOME TAX STATUS

The Plan has adopted a Prototype Volume Submitter 401(k) Savings Plan document sponsored by Empower Retirement, LLC, which received an opinion letter dated September 16, 2022. The letter states that the prototype documents satisfy the applicable provisions of the IRC. Further, the Companies and the plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the trustees and qualify as parties in interest. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibitions of party-in-interest transactions under ERISA.

NOTE 8 - GUARANTEED INCOME FUND

The Plan maintains a fully benefit-responsive group annuity contract with Empower Annuity Insurance Company of America ("EAICA") (formerly Prudential Retirement Insurance and Annuity Company ("PRIAC")) through the Fixed Income Guaranteed Option ("Guaranteed Interest Account"). Contributions to the Guaranteed Interest Account are maintained in an insurance company general account and credited for interest and charged for participant withdrawals and administrative expenses. EAICA is contractually obligated to repay principal and a specified rate of interest that is guaranteed to the Plan. The Guaranteed Interest Account meets fully benefit-responsive investment contract criteria and is reported at contract value. Contract value, which approximates fair value, is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants when they initiate permitted transactions under the terms of the Plan.

The Plan's ability to receive amounts due is dependents on EAICA's ability to meet its financial obligation. There are no reserves against contract value for credit loss. Certain events might limit the ability of the Plan to transact at contract value including premature termination of Plan investments in the Guaranteed Interest Account. The plan administrator does not believe that any events limiting the Plan's ability to transact at contract value are probable of occurring.

NOTE 9 - PLAN AMENDMENT

On March 17, 2023, the Plan adopted certain provisions of the Setting Every Community Up for Retirement Enhancement Act (the "SECURE Act").

NOTE 10 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 7, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
