Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedules Required by ERISA

The supplemental schedules of Assets Held at End of Year and Reportable Transactions are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 - Description of the Plan

The following description of the C4 Planning Solutions, L.L.C. (the "Company") Retirement Plan (the "Plan") provides only general information. For a more complete description of the Plan's provisions, refer to the agreement governing the Plan (the "Plan Agreement").

General - The Plan is a defined contribution plan covering substantially all full-time employees of the organization who have completed three (3) months of service and reached the age of twenty-one (21) years old. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 "ERISA". Plan entry dates for eligible employees are the first day of each quarter. Principal Trust Company is the "Trustee" of the Plan.

Contributions - Each year, participants may defer a portion of their pre-tax compensation into the Plan, not to exceed certain limitations set forth by the Internal Revenue Code. Limits are adjusted annually for cost-of-living increases as determined by the Internal Revenue Service. Participants who have attained the age of fifty (50) before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans upon meeting the eligibility requirements of the Plan. The Company contributes one hundred percent (100%) of the first five percent (5%) of base compensation a participant contributes to the Plan.

Investment Elections - Each participant may direct contributions to be invested in one or more of the twenty-seven (27) investment funds. Investment allocations may be changed by the participant.

Participant Accounts - Each participant's account is credited with the participant's pre tax and rollover contributions and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with losses, withdrawals and allocation of administrative expenses. Earnings, expenses, and gains and losses on investments are allocated to participant accounts based on participant earnings or account balances, as defined in the Plan agreement.

Vesting - All participants are immediately one hundred percent (100%) vested with respect to contributions and earnings thereon.

Distribution of Benefits - Upon termination of services due to death, disability or retirement, a participant may elect to receive a distribution of their vested interest in their account in a single lump sum distribution or direct rollover. Partial or installment distributions are only permitted for participants and beneficiaries who must receive required minimum distributions according to the Internal Revenue Code. If upon termination of employment or retirement, the account balance is \$5,000 or greater, election to defer payment can be made directly after the severance of employment. For accounts with vested balances that do not exceed \$5,000, the Company may distribute the balance of the account after the severance of employment.

Note 2 - Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared under the accrual basis of accounting with the exception of benefits paid to participants, which are recorded when paid, in accordance with accounting principles generally accepted in the United States of America "GAAP".

Investments - Investments are recorded at fair value. The Plan has adopted Accounting Standards Codification "ASC" 820 - Fair Value Measurements and Disclosures guidance which establishes a framework for measuring fair value under GAAP. Investments in pooled separate accounts are recorded at fair value as provided by the "Trustee".

Benefits - Benefits are recorded when paid.

Expenses - The Plan's administrative expenses are paid by either the Plan or the Company as provided by the Plan document.

Estimates - The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of the net assets available for benefits and the changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties - The Plan invests in various investment securities. Investment securities, in general, are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the financial statements.

Income Recognition - Net appreciation in the fair value of investments represents the change in fair value during the year, including unrealized gains and losses. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Note 3 - Information Certified by the Plan's Trustee, (unaudited)

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the following information certified by Principal Trust Company as of December 31, 2024 and 2023 respectively, except for comparing such information certified by the trustee to information included in the Plan's financial statements and supplemental schedule of assets held at year end.

Note 4 - Fair Value Measurements

ASC 820, Fair Value Measurements and Disclosures, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quote prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 Measurements). The three levels of the fair value hierarchy are described below:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other valuation methodologies.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023.

Pooled Separate Accounts: These investments issued by an investment company and are not publicly traded. Investments are valued daily using active quoted market prices based on the NAV of underlying mutual funds or securities that are publicly available. PSAs investing in mutual funds or domestic equity securities are classified within the Level 1 of the valuation hierarchy. PSAs directly investing in fixed maturity securities are measured based on the pricing data provided by outside valuation service providers are classified within the Level 2 of the valuation hierarchy.

Stable Value Options: This investment is classified as a benefit-responsive investment contract with an insurance company. The contract has no formal underlying maturities that would be reviewable for investment return information, however, it includes a wrapper contract which is designed to allow the stable value fund to maintain a constant NAV, with a guarantee the return of principal and a stated rate of interest. These investments are classified within Level 2 of the valuation hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable values or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Principal Trust Company performs recordkeeping services to the plan and therefore qualifies as a party in interest. Fees paid by the Plan for these services amounted to \$14,551 and \$12,142 for the years ended December 31, 2024 and 2023.

Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 6 - Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants remain one hundred percent (100%) vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts based on participant earnings and distributed in such a manner as defined by the Plan.

Note 7 - Tax Status

The Internal Revenue Service has determined and informed the Company, effective January 1, 2009, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and remains tax-exempt.

Note 8 - 5500 Reconciliation
