## **INDEPENDENT AUDITORS' REPORT**

To the Plan Administrator of  
Preston Management, Inc. 401(k) Profit Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed an audit of the accompanying financial statements of Preston Management, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ### NOTES TO FINANCIAL STATEMENTS

---

#### 1. DESCRIPTION OF PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of Preston Management, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General* - The Plan, established January 1, 1997 and restated effective April 1, 2022, is a multiple employer defined contribution plan which covers substantially all employees of Preston Management, Inc. (the "Sponsor") and other participating employers (collectively, the "Company"). Effective April 1, 2023, employees are eligible to participate upon completion of three months of service and enter the Plan on the first day of the month after meeting the eligibility requirements. Prior to April 1, 2023, employees were eligible to participate upon completion of six months of service and entered the Plan on January 1st or July 1st after meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Use of Estimates* - The preparation of financial statements in conformity with U.S. generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the dates of the financial statements and the reported amounts of changes in net assets during the reporting periods. Actual results could differ from these estimates.

*Contributions* - The Company deposits cash to the Plan based on withholdings from the employees' pretax and/or after-tax earnings. Participants may elect to contribute up to 100% of compensation. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan provides for discretionary annual employer matching contributions up to a maximum of 50% of the first 6% of participant salary deferrals. Matching contributions of \$413,691 and \$410,536 were receivable at December 31, 2024 and 2023, respectively. The Plan also provides for discretionary nonelective contributions, for which there were no nonelective contributions for the years ended December 31, 2024 or 2023. Only participants who are employed on the last day of the Plan year (or have terminated employment under certain circumstances with more than 1,000 hours of service in the Plan year) are eligible to receive the matching contribution and discretionary nonelective contribution.

*Participant Accounts* - Each participant's account is credited with the employee and applicable employer contributions and an allocation of the Plan's earnings on a daily basis. Allocation of Plan earnings are based on a participant's account balance as a percentage of the total account balances for the applicable investment option. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting* - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting of employer contributions and earnings thereon is according to the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 1	0%
1 but less than 2	20%
2 but less than 3	40%
3 but less than 4	60%
4 but less than 5	80%
5 or more	100%

*Forfeitures* - Forfeitures represent the portion of non-vested account balances remaining in the Plan for all terminated employees. Forfeiture balances are reallocated on the earlier of the distribution date of the employee's entire vested account balance or at the end of the fifth year in which a participant reaches their fifth consecutive one-year break-in-service. Forfeitures will serve to reduce future employer contributions. Available forfeitures were \$29,302 and \$18,993 at December 31, 2024 and 2023, respectively.

*Notes Receivable from Participants* - Participants may borrow up to 50% of their account balance up to a maximum of \$50,000. The original amount of the loan must be at least \$1,000. Participants may have up to three loans outstanding at any time. All loans must be repaid within five years, unless the purpose of the loan was to purchase a principal residence. The interest rate on new participant loans is the prime rate at loan inception plus 1%. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. The interest rate on loans outstanding as of December 31, 2024 and 2023 ranged between 4.25% and 9.50%.

*Investment Options* - Participants may direct their contributions as well as their share of employer contributions and any related earnings into various investment options. The Plan is invested in pooled separate accounts maintained by John Hancock Life Insurance Company (John Hancock).

*Investment Valuation and Income Recognition* - Investments are carried at their fair values based on published quotations or, in the absence of readily ascertainable market values, at such values as the custodian determines. The unrealized appreciation of investments is determined by the change in current market value from the beginning of the year (if held

for the entire year) to the end of the year, or from the date of purchase to the end of the year. The realized appreciation of investments is determined by the change in the current market value from the beginning of the year (if held since the beginning of the year) to the date of sale, or from the date of purchase to the date of sale. Gains and losses on securities sold or redeemed are determined on the basis of specific identification. Purchases and sales of securities are recorded on a trade-date basis.

*Fair Value Measurements* - U.S. GAAP establishes a framework for measuring fair value of financial assets. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

At December 31, 2024 and 2023, plan investments consist of pooled separate accounts, which are valued at the net asset value, which is estimated to approximate fair value because the pooled separate accounts can be traded on a daily basis at net asset value, which is based on the closing prices of the underlying investments as reported in their respective active markets (level 1 measurement).

*Refundable Contributions* - The Plan is subject to nondiscrimination and funding limitation tests. To the extent that these tests result in the identification of employee contributions in excess of amounts allowed by the Internal Revenue Service (IRS), the excess contributions are refunded, typically subsequent to year end, resulting in a liability being recorded with a corresponding reduction to employee contributions.

*Payment of Benefits* - On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum distribution for an amount equal to the value of the participant's vested interest in his or her account. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of a lump-sum payment. The Plan also allows for hardship distributions if certain criteria are met and in-service distributions if the participant has attained age 59 1/2.

*Administrative Expenses* - The Plan's expenses are paid by the Company or the Plan as provided by the Plan agreement.

*Reclassifications* - Certain amounts previously reported in the 2023 financial statements have been reclassified to conform to 2024 presentation.

*Subsequent Events* - Management has evaluated subsequent events through October 6, 2025, the date upon which the financial statements were available to be issued.

## **2. CERTIFIED FINANCIAL INFORMATION**

John Hancock, the custodian, has certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment activity and interest income on notes receivable, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- The schedule of assets held for investment purposes at December 31, 2024, as shown on the accompanying supplemental schedule.

## **3. PLAN TERMINATION**

The Sponsor anticipates and believes that the Plan will continue without interruption but reserves the right to discontinue the Plan at its discretion. In the event that such discontinuance results in the termination of the Plan, all amounts credited to participant accounts become 100% vested. The net assets of the Plan will be distributed by the custodian in accordance with the trust agreement in a uniform and nondiscriminatory manner.

## **4. INCOME TAX STATUS**

The Plan is a non-standardized, pre-approved plan for which the sponsoring organization has obtained a favorable opinion letter dated June 30, 2020, in which the IRS states that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Management believes that there is no liability related to uncertain tax positions at December 31, 2024 or 2023. The Plan is no longer subject to tax examinations for years before December 31, 2021.

## **5. PARTIES-IN-INTEREST AND RELATED PARTIES**

The custodian provides access to certain investments and, accordingly, is considered a party-in-interest.
