**NOTES TO FINANCIAL STATEMENTS**

**NOTE A - DESCRIPTION OF PLAN**

The following description of the Abercrombie and Kent USA, LLC 401(k) Savings & Benefit Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

***General***

The Plan is a defined contribution plan sponsored by Abercrombie and Kent USA, LLC (the “Company” or “Plan Sponsor”). Crystal Cruises USA, LLC, Abercrombie & Kent Travel, Inc., Abercrombie & Kent Philanthropy, Inc., and Abercrombie & Kent USA DMC LLC are also participating employers in the Plan. As of January 1, 2024, plan eligibility was amended to completion of 90 days of service for all employees to be allowed to enter the Plan.

Empower Annuity Insurance Company (“Empower” or the “Recordkeeper”) serves as the recordkeeper and administers the Plan’s assets for the benefit of participants. Empower Trust Company, LLC (the “Trustee”), serves as the trustee of the Plan’s investments. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

***Contributions***

Participants may contribute a percentage of their pretax annual compensation, as defined in the Plan agreement subject to Internal Revenue Code (“IRC”) limitations. Entrants into the Plan begin deferring at 6% unless an election is made to modify this election. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company will make a matching contribution in an amount equal to \$0.50 for each \$1.00 contributed by a participant, up to a maximum of 6% of the participant’s eligible compensation, as defined. As of 1/1/2024, the Plan was amended from a discretionary match to a safe harbor nonelective contribution of 3% for all participants. The Company’s contributions are invested as directed by the participant. Contributions are subject to certain limitations.

***Participant Accounts***

Each participant’s account is credited with the participant’s contributions and the Company’s matching contributions and an allocation of the Company’s discretionary non-elective contributions, if any, and Plan earnings (losses). Earnings (losses) are allocated by fund based on the ratio of a participant’s account invested in a particular fund to all participants’ investments in that fund. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

As of January 1, 2024, all Safe Harbor Contributions are vested 100%. Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in the Company’s contributions in participants’ accounts is based on years of service. Prior to the Plan amendment, effective 1/1/2024, a participant becomes 0% vested after one year of service, 40% after two years of service, 60% after three years of service, 80% after four years of service and 100% vested after five years of service; however, if an active participant dies prior to attaining the normal retirement age, the participant’s account becomes 100% vested.

***Benefit Payments***

Participants may take withdrawals prior to termination of employment under a hardship withdrawal, or an age 59½ withdrawal, whereby a participant may withdraw all or any portion of his or her account. Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the vested portion of his or her account, a distribution in the form of an annuity or installment payments. Required minimum distributions begin when participants reach age 73.

***Notes Receivable from Participants***

Participants may borrow up to a maximum of \$50,000 or 50% of the vested portion of their account balances, whichever is less. Loans are calculated on a fully amortized basis. A loan is collateralized by the balance in the participant's vested account and bears interest at one percent over the Prime Rate published in the Wall Street Journal on the first business day of the month the loan is originated. Principal and interest are paid ratably through payroll deductions. Participants can have two loans outstanding at a time as long as the loan repayments are submitted via payroll deduction and the plan allows for multiple loans. Loan maturities range from one to five years; however, the maturity may exceed five years if the loan is issued for the purchase of a primary residence. Interest rates ranged from 4.25% - 9.50% as of December 31, 2024 and 2023, respectively.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The Plan's financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value, except for the Group Annuity Contract, which is stated at contract value (see Note C). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan agreement. If a participant ceases to make loan repayments and the Plan Administrator deems the participant's loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded.

***Benefit Payments***

Benefit payments are recorded when paid.

***Forfeited Accounts***

At December 31, 2024 and 2023, unallocated Plan assets resulting from forfeited nonvested accounts totaled \$56,076 and \$36,477, respectively. These accounts are used to reduce future Company contributions or pay the Plan's administrative expenses. The Company used \$36,479 to reduce Company contributions during 2024.

***Administrative Expenses***

Reasonable expenses relating to the administration of the Plan are paid using Plan assets. Such expenses include, but are not limited to, management, loan, distribution and consulting fees. Unless otherwise paid by the Plan, certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net depreciation in fair value of investments.

**NOTE C - GROUP ANNUITY CONTRACT**

The Plan has a group annuity contract with the Trustee that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long-term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following:

- Amendments to the Plan document (including complete or partial Plan termination or merger with another plan);
- Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions;
- Bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan; or

- The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

**NOTE D - FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The valuation inputs for the three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

However, the determination of what constitutes observable, requires judgment by the Plan's management. Plan management considers observable data to be market data that is readily available, regularly distributed or updated, reliable and verifiable, not proprietary, and provided by multiple independent sources that are actively involved in the relevant market. The categorization of an investment within the fair value hierarchy is based on the transparency of the investment and does not necessarily correspond to Plan management's perceived risk of that investment.

The following is a description of the valuation methodologies used to measure assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* - Valued at the quoted net asset value ("NAV") of shares held by the Plan at year end.

**NOTE E - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by the Trustee of the Plan. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA. Fees paid during the year for investment advisory and other professional services rendered by parties-in-interest were based on customary and reasonable rates for such services.

**NOTE F - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE G - TAX STATUS**

The plan is a non-standardized pre-approved profit sharing plan sponsored by the Trustee. The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the Plan, as then designed, was in compliance with the applicable requirements of IRC. The Plan has not requested its own determination letter from the IRS. Although the Plan has been amended since the opinion letter was issued, the Plan Administrator believes that the Plan is currently designed and being operated in compliance in all material respects with the applicable requirements of the IRC; therefore, the Plan Administrator believes that the Plan was qualified and that the related trust was tax-exempt as of the financial statement dates.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. federal, state and local taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial

statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE H - INFORMATION PROVIDED BY THE TRUSTEE**

The Plan Administrator has elected the method of annual reporting compliance permitted with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan Administrator determined that the certification received from the Trustee meets the requirements of ERISA Section 103(a)(3)(C). The Trustee certified that the following data included in the accompanying financial statements are complete and accurate:

- Total investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

**NOTE I - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE J - SUBSEQUENT EVENTS**

The Plan evaluated the December 31, 2024 financial statements for subsequent events through October 8, 2025, the date the financial statements were available to be issued.
