Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the G.A. Braun, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or Federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Notes to Financial Statements

Note 1 - Description of Plan

The following description of the G.A. Braun, Inc. (the "Company") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan is a qualified defined contribution plan under Section 401(a) of the Internal Revenue Code, with a Section 401(k) salary deferral provision. The Plan covers all employees of G.A. Braun, Inc. and CNY Fabrication, LLC. All assets acquired under the Plan are the result of employee and employer contributions thereto and all income and other additions thereto are administered, distributed, forfeited or otherwise governed by the provisions of the Plan and the Employee Retirement Income Security Act of 1974 (ERISA).

Plan provisions - The Plan has implemented certain required provisions of the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act) and the SECURE Act 2.0, a law which, among others, extends the age for required minimum distributions. Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and Internal Revenue Service guidance.

Contributions - Participants are allowed to make elective 401(k) salary deferrals, up to 90% of compensation, to the Plan. The Plan also contains a provision for Roth 401(k) contributions, which allows a participant to elect that a portion or all of their elective salary deferral contributions be taxed at the time of deferral. Participants who meet certain age requirements are allowed to make catch-up elective deferrals. Participant deferrals are subject to the maximum amounts allowable under the Internal Revenue Code. Rollover and transfer contributions from other plans are permitted.

The Plan automatically enrolls certain participants for salary deferral under its automatic enrollment feature, unless the participant elects otherwise. Under automatic enrollment, 3% of a participant's gross pay will be contributed to the Plan as pre-tax contributions, unless the participant chooses either not to participate or to increase or decrease their elective salary deferral contribution percentage. The percentage of elective deferral contributions will automatically increase each year by 1% until reaching 15% of gross pay.

The Company may make discretionary matching contributions to the Plan as a percentage of participant elective salary deferral contributions, as determined by the Board of Directors of the Company. Discretionary matching contributions were \$352,971 and \$305,657 for the years ended December 31, 2024 and 2023, respectively.

Participant accounts - Each participant's account is credited with the participant's elective deferral contribution, the Company's contributions and plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined by the plan agreement. The benefit to which a participant is entitled

is the benefit that can be provided from the participant's vested account. Participants can access their account information via Fidelity's website where they have the ability to change their elective deferrals and investment options, as well as apply for participant notes receivable and request distributions.

Vesting - Participants are always 100% vested in their elective salary deferral and rollover contributions. Vesting in the remainder of their account is based on years of continuous service. A participant in the Plan becomes 100% vested in any company discretionary matching contributions after three years of credited service.

Forfeitures - Forfeited non-vested accounts may be used to pay future administrative expenses or reduce future employer contributions. The Company used \$14,992 and \$11,245 of forfeited non-vested funds to pay administrative expenses for the years ended December 31, 2024 and 2023, respectively. Forfeited non-vested accounts as of December 31, 2024 and 2023, totaled \$17,446 and \$4,252, respectively.

Investment options - Upon enrollment in the Plan, a participant may direct contributions in any of the investment options offered by the Plan. Participants may change their investment options online daily through Fidelity's website.

Payment of benefits - Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the vested value of his or her account or annual instalments over a period selected by the participant, which may not exceed the participant's life expectancy. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Notes receivable from participants - Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance from their accounts. The notes bear interest at a rate based on prevailing interest rates charged by financial institutions under similar terms at the date of issuance; however, the rate can be changed at the discretion of the plan administrator. The interest rate for loans ranged from 4.25% to 9.50%. Principal and interest are paid ratably through monthly payroll deductions. The term of the repayment period cannot exceed five years, except if the loan is used to acquire a residence, then the repayment period may be extended to up to ten years. The notes are secured by the vested balance in the participant's account. According to requirements of the participant note program, the plan administrator will treat a note in default if any scheduled payment remains unpaid beyond ninety days.

Deemed distributions - Deemed distributions represent the amount of unpaid principal on notes receivable from participants who are actively participating in the Plan and have not continued to make payments on their outstanding notes as required under the plan document. There were no deemed distributions for the years ended December 31, 2024 and 2023.

Hardship withdrawals - A participant may apply for a hardship withdrawal to assist in the payment of several types of personal hardships, as defined by the plan document. Any hardship withdrawals are limited to the amount necessary to meet the financial need and must be approved by the plan administrator.

Plan termination - Although it has not expressed any intent to do so, the Company has the right, under the plan document, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 2 - Summary of accounting policies

Method of accounting - The Plan maintains its accounting records and financial statements on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of plan income and expenses during the reporting period. Actual results could differ from those estimates.

Risks and uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit and overall market risk. Market risks include domestic and global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Investment valuation and income recognition - Investments are stated at fair market value (see Note 5), with the exception of a common collective trust fund, which is valued at net asset value (NAV) as a practical expedient as reported by the sponsor of the fund; see below. All investment values have been determined and certified by Fidelity Management Trust Company, the Trustee of the Plan (see Note 4). Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Fidelity Managed Income Portfolio Class 1 is a common collective trust fund that is made up of various investment and security-backed contracts. Common collective trust funds are valued at NAV per share, which serves as a practical expedient to estimate fair value. The NAV of common collective trust funds is not publicly quoted in the active markets and is based on the fair value of the underlying investments held by the funds less its liabilities. This practical

expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no redemption restrictions or unfunded commitments as of December 31, 2024 or 2023. Investments measured at NAV per share used as a practical expedient are not required to be classified in the fair value hierarchy.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Management individually reviews all notes receivable balances that exceed ninety days from the date of the most recent payment and based on the assessment of credit worthiness, estimates the portion, if any, of the balances that will not be collected. Currently, there is no valuation allowance recorded; however, management will record an allowance if and when potentially uncollectible notes receivable from participants becomes material. If a participant defaults on a note receivable and distribution from the participant's account has been made during the plan year because the participant has left the Plan, the defaulted note receivable will be reported as benefits paid to participants on the statements of changes in net assets available for benefits and deducted from the receivable balance.

Economic dependency and concentration of credit risk - Approximately 84% and 85% of the Plan's investments are invested with T. Rowe Price as of December 31, 2024 and 2023, respectively. Accordingly, the Plan is dependent upon the financial condition of this company.

Administrative costs - Administrative costs, including maintaining participants' accounts, legal costs, and accounting costs, are the obligation of the Plan; however, the Company may pay for such expenses or reimburse the Plan for any payment of these expenses. Costs of managing the investments are paid directly out of the Plan's assets (see Note 6).

Payment of benefits - Benefits are recorded when paid.

Excess contributions payable/corrective distributions - Excess contributions payable represent excess employee salary deferral contributions and excess employer matching contributions owed to certain participants in order to satisfy the relevant nondiscrimination provisions of the Plan. The excess contributions payable ("corrective distributions") are returned to the affected participants, including any investment earnings thereon. There were no excess contributions payable or corrective distributions as of and for the year ended December 31, 2024. Excess contributions payable and corrective distributions were \$13,426 as of and for the year ended December 31, 2023, and were returned to the affected participants in 2024 (see Note 7).

Subsequent events - Management has evaluated subsequent events through September 30, 2025, the date that the financial statements were available for issue.

Note 3 - Tax status of the Plan

The Plan has adopted a Fidelity Volume Submitter Plan, adoption agreement No. 001 with Fidelity Basic Plan Document No. 17. The Internal Revenue Service has ruled that the standardized prototype plan of Fidelity is acceptable under Section 401(a) of the Internal Revenue Code, and a separate determination letter has not been obtained for the Plan. The Plan has been amended since receiving the determination letter; however, the management of the Company and plan administrator are not aware of any matters that would disqualify the Plan. Accordingly, the Plan has been accounted for as a tax-exempt plan.

The Plan has reviewed its operations for uncertain tax positions and believes there are no significant exposures. The Plan will include penalties and interest on income tax liabilities in administrative expenses if such amounts arise. The Plan did not incur any penalties and/or interest for the years ended December 31, 2024 and 2023. The Plan is no longer subject to regulatory examinations by tax authorities for the closed tax years before 2021.

Note 4 - Information certified by the Plan's Trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in investments, interest and dividend income, and interest received on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the Trustee of the Plan. Furthermore, the Plan's independent accountants did not perform auditing procedures with respect to the information except to compare such information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 5 - Fair value measurement

The Financial Accounting Standards Board has published authoritative guidance on fair value measurement, which establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for the Plan's assets measured at fair value.

Registered Investment Companies (i.e., Mutual Funds) - The investment portfolios consist of mutual funds, which are valued at the closing price reported on the active market on which the individual security is traded (Level 1).

Money Market Funds - Managed portfolios, which consist of U.S. Government obligations valued at the closing price reported on the active market on which the individual security is traded (Level 2).

The preceding methodology may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 31, 2024 or 2023.

Note 6 - Related party transactions

Plan investments are managed by Fidelity Management Trust Company, the Trustee of the Plan's assets and therefore, these transactions qualify as party-in-interest transactions. Certain investment fees paid for these services are included in the net appreciation of investments in the accompanying statements of changes in net assets available for benefits. In addition, Fidelity Investments Institutional provides recordkeeping and third-party administrative services, Dannible & McKee, LLP provides plan auditing services and Resource Investment Advisors provides investment advisory services for the Plan that qualify as party-in-interest transactions. Administrative fees paid out of plan assets to Fidelity Investments Institutional were \$25,959 for the year ended December 31, 2024, and were reduced with revenue sharing credits of \$25,435. Administrative fees paid out of plan assets to Fidelity Investments Institutional were \$23,054 for the year ended December 31, 2023, and were reduced with revenue sharing credits of \$22,448. Investment advisory fees of \$15,000 and \$11,250 were paid out of plan assets for the years ended December 31, 2024 and 2023, respectively. Fees for plan auditing services were paid by the plan sponsor for the years ended December 31, 2024 and 2023.

Note 7 - Reconciliation of the financial statements to Form 5500

As explained in Note 2, the Fidelity Managed Income Portfolio is a common collective trust and is reported at NAV in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023; however, Form 5500 is prepared using the fair value of this investment. Corrective distributions are recorded in the financial statements in the plan year that the excess contributions are received. Corrective distributions are recorded on Form 5500 in the plan year that they are paid, including investment earnings or losses. Accordingly, there are reconciling items between amounts reported in the financial statements and Form 5500 for these items.
