1. Description of the Plan

The FactSet Research Systems Inc. Plan (the “Plan”) was established January 1, 1993. The Plan is a defined contribution plan covering all eligible employees of FactSet Research Systems Inc. (the “Company” or “Employer”). The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for more complete information. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Administration

The Plan is administered by the management and overseen by the Board of Directors of FactSet Research Systems Inc. (the “Board”) which is responsible for the administrative and investment decisions of the Plan. The Board has appointed Fidelity Management Trust Company (“Fidelity” or the “trustee”) to assist the administration of the Plan. Fidelity safeguards the Plan’s assets and directs and records employee contributions to the fund options available through the Plan.

Eligibility and Enrollment

There is no minimum length of service or minimum age requirement to participate in the Plan. All newly hired eligible employees are automatically enrolled in the Plan at a 4% pre-tax contribution rate upon employment with the Company. Employees’ contributions will be directed to the age appropriate Fidelity Freedom Fund unless a different allocation is chosen by the new employee. Employees are eligible to receive Employer discretionary matching contributions immediately upon enrollment in the Plan.

Contributions

Each year, participants may elect to contribute a percentage of their annual compensation, as defined in the Plan, on a pre-tax or after-tax (Roth) basis. Participant contributions are subject to annual limitations established by the Internal Revenue Code (“IRC”). These limitations were \$23,000 for the year ended December 31, 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, increasing their contribution limit to \$30,500 for 2024. Participants may also contribute amounts representing contributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company matches 100% of a participant’s contributions up to 4% of their eligible compensation. The matching contributions are subject to change, as determined by the Board.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) Employer contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. Description of the Plan (*continued*)

Vesting

Participants are vested in their contributions immediately, plus actual earnings thereon. Employer discretionary matching contributions vest over a five-year period with 20% vesting after one year and an additional 20% vesting at the end of each year thereafter. Upon reaching age 59½, participants in the Plan automatically become fully vested in the Employer discretionary contributions.

Payment of Benefits and Withdrawals

The Plan is designed to provide benefits at the time of retirement. However, if employment with the Company is terminated because of death, disability, or any other reason, a request for distribution of a participant's account balance is also allowed. If a participant dies while classified as an active member of the Plan, the participant's beneficiary or beneficiaries are entitled to receive the entire participant's vested account balance. Should a participant become totally and permanently disabled while employed by the Company, the full value of the participant's account balance may be distributed upon request.

Upon termination of employment, the vested amount of the participant's account will be distributed to the participant in a lump-sum cash payment if the participant's vested account balance is less than \$1,000. If the account balance is greater than \$1,000, the participant's written consent will be required for any distribution including the election of a rollover distribution to a new qualified plan or installment payments. Otherwise, the Plan administrator will direct the Trustee to begin distribution no later than April 1 of the calendar year after the participant attains the age of 70½. Upon reaching age 59½, participants may elect distributions from their accounts without any tax penalty in accordance with the IRC.

Subject to certain limitations prescribed by the Plan and the IRC, participants may elect hardship withdrawals. In accordance with the IRC, a 10% premature distribution penalty tax may also be imposed on such withdrawals from a participant's account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. The loans bear interest at the prime interest rate as of the date of the loan application and are secured by the balance in the participant's account.

Loans are repaid through payroll deductions in equal payments over the term of the loan (up to ten years). A participant may have no more than one outstanding loan from the Plan at any time. Loans are collateralized by the participant's account balance. Upon termination of service, the principal and accrued interest shall be immediately due and payable.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Administrative fees incurred in connection with loans and participant activity charges are borne by the individual and deducted from their respective Plan assets. Investment related expenses are included in net appreciation in fair value of investments.

Revenue Credit Account

The Plan and Fidelity have entered into a revenue sharing arrangement whereby a portion of the revenue earned by the trustee from certain funds is passed through to the Plan for payment of permitted plan expenses or allocation to Plan participants. In order for the Plan to receive credits as a result of this revenue sharing arrangement, the Company created a Revenue Credit Account under the Plan. The Revenue Credit Account is an account within the Plan that is used to record the redistribution of Plan-generated fund revenue that exceeds the costs associated with Plan administration. The Revenue Credits received by the Plan were netted against administrative expenses on the statement of changes in net assets available for benefits. The Revenue Credit Account balance was \$117,650 and \$83,777 at December 31, 2024 and 2023. During 2024, the Plan received \$209,459 of revenue credits and \$180,538 was used to reduce administrative expenses. During 2024, no revenue credits were allocated to Plan participants.

Forfeitures

Forfeited accounts are amounts forfeited by participants who have terminated their employment and who have withdrawn from the Plan. At December 31, 2024 and 2023 forfeited non-vested amounts totaled \$512,283 and \$47,618. These amounts will be used to reduce future Employer contributions and/or administrative expenses. During 2024, Employer contributions were reduced by \$1,096,749 and \$43,000 of forfeitures were used to reduce administrative expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Fair Value Measurements (continued)

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value (“NAV”) per share as a practical expedient is not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

The Plan’s investments are stated at fair value. The mutual funds and money market fund are valued at the daily closing price as reported by the fund. These funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The common/collective trust is valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a deemed distribution based upon the terms of the Plan document.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 30, 2025.

5. Common/Collective Trust

The Managed Income Portfolio II ("MIP") is a common/collective trust. Fidelity Management Trust Company is the trustee of the MIP. The MIP invests in assets (typically fixed income securities or bond funds and may include derivative instruments such as futures contracts and swap agreements), enters into wrap contracts issued with third parties, and invests in cash equivalents represented by shares in money market funds. Wrap contracts are purchased from issuers rated in the top three long-term rating categories (A- or the equivalent and above). It is the policy of the MIP to use its best efforts to maintain a stable net asset value of \$1 per unit, although there is no guarantee that the MIP will be able to maintain this value. Net asset value per unit is determined each business day. Issues and redemptions of units are recorded, upon receipt of unit holder's instructions in good order, based on the next determined net asset value per unit normally each day. In unusual market conditions, the trustee may impose restrictions on issues and redemptions of units. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment in the MIP at NAV.

6. Related Party Transactions

Certain investments are managed by Fidelity Management Trust Company, the trustee of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Fidelity Workplace Services LLC is the record-keeper for the Plan.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statement of net assets available for benefits.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their Employer contributions.

8. Non-Exempt Party-in-Interest Transaction

For the 2024 plan year, the Company failed to transmit to the Plan contributions and loan repayments for participants totaling \$6,343 within the period prescribed by Department of Labor regulations. In 2024, pursuant to the guidance issued by the Department of Labor, lost earnings were calculated and allocated to the affected participants by the Company.

9. Tax Status

The Internal Revenue Service ("IRS") issued an opinion letter to the prototype plan document preparer, Fidelity Management & Research Co., dated June 30, 2020, which states that the form of the prototype plan qualifies under the applicable provisions of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. When considering funds for inclusion in the Plan, the Company and its Board look at a variety of factors, including performance over 3, 5 and 10 year investment horizons, as well as investment cost. The Company also reviews the current lineup of active and passive investment options across each asset class to evaluate potential additions to the Plan.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
