Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Donson Machine Co., Inc. Employees' 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America; and
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Notes to Financial Statements

December 31, 2024 and 2023

Note 1. Description of the Plan

On October 1, 1978, Donson Machine Co., Inc. (the Company) established Donson Machine Co., Inc. Employees' 401(k) Profit Sharing Plan (the Plan), under Section 401(a) of the Internal Revenue Code to provide savings and retirement benefits for eligible employees of the Company. The Plan is a defined contribution retirement plan covering all eligible employees of Donson Machine Co., Inc. and Bett's Precision Inc., (companies related through common ownership, collectively, the "Company") immediately upon their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Benefits under the Plan are not insured by the Pension Benefit Guaranty Corporation.

Participants may elect to defer all or a portion of their compensation and have that amount contributed to the Plan on a pre-tax basis or on an after-tax basis as a Roth deferral. Elective salary deferrals are subject to Internal Revenue Service Code limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions (rollover contributions) from other qualified retirement plans. The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation.

Contributions to the Plan are invested as directed by the participants in various investment options. In the absence of participant direction, contributions are invested in a qualified default investment alternative account until changed by the participant. Participants must evaluate their own investment goals and objectives and choose the investments best suited to achieve those goals and objectives. Poor investment performance by the investment options selected by the participants may cause their account balance to be lower than contributions made to the Plan.

The Company may make discretionary matching and profit sharing contributions as determined and authorized by the Board of Directors of the Company. In order to receive a discretionary profit sharing contribution, an employee must have had 500 hours of service during the Plan year. For the years ended December 31, 2024 and 2023, the Company elected to make discretionary profit sharing contribution of \$40,035 and \$56,000 respectively. For the years ended December 31, 2024 and 2023, the Company elected to make discretionary matching contributions of \$79,038 and \$61,760 respectively.

Note 1. Description of the Plan (continued)

Individual accounts are maintained for each participant to reflect the participant’s contributions and the Company’s matching contributions, as well as allocations of investment earnings or losses and administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants are immediately fully vested in their elected deferrals, rollovers and actual earnings thereon. Employer discretionary matching and profit sharing contributions are fully vested after six years of vesting service. In the event that an eligible participant passes away or becomes disabled while still employed, a participant will become 100% vested. The portion of the employer discretionary matching contribution that is vested is as follows:

Upon termination of service due to death, disability or retirement age as defined in the Plan document, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in the account, partial account distributions or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in the account as a lump-sum distribution. Vested account balances of terminated participants that are less than \$5,000 are automatically distributed subject to automatic rollover requirements, as defined in the Plan document.

Participants in service may make hardship withdrawals from their vested contributions upon demonstrating an immediate and heavy financial need, as allowed under federal rules.

Included in net assets available for benefits are forfeited nonvested accounts of \$9,906 and \$6,496 as of December 31, 2024 and 2023, respectively. Forfeited nonvested accounts may be used to reduce employer contributions or to offset Plan administrative expenses. During the years ended December 31, 2024 and 2023, forfeited non-vested accounts totaling \$6,461 and \$10,271 respectively, were used to reduce Company matching contributions. During the year ended December 31, 2024, forfeited non-vested accounts totaling \$1,940 was used to pay plan expenses.

Participants should refer to the summary plan description for more complete information.

Note 2. Summary of Significant Accounting Policies

Method of Accounting - The accompanying financial statements have been prepared using the accrual basis of accounting.

Investments - Investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset (or paid to transfer a liability) in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Purchases and sales of the investments are reflected on a trade-date basis.

Payment of Benefits - Benefits paid to participants are recorded upon distribution. There were no participants who elected to withdraw from the Plan but were not yet paid at either December 31, 2024 or 2023.

Expenses - Certain management and administrative services are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included net appreciation in fair value of investments.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Subsequent Events - Subsequent events have been evaluated through October 2, 2025, which is the date the financial statements were available to be issued.

Note 3. Priorities upon Termination

Although it has not expressed an intention to do so, the Plan sponsor has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become fully vested in the employer contribution portion of their account.

Note 4. Tax Status

The Company adopted a non-standardized prototype plan. The Plan is not required to receive a determination letter directly from the Internal Revenue Service, and therefore, the Plan has not received a determination letter specific to the Plan itself. The prototype plan determination letter has been relied upon by the Plan. The Company and Plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believes that the Plan is qualified and the related trust is tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Fair Value Measurements

The *Fair Value Measurements and Disclosures* Topic of the FASB Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The following provides a description of the three levels of the fair value hierarchy:

Basis of Fair Value Measurement

Level 1	Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities
Level 2	Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly
Level 3	Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

In accordance with generally accepted accounting principles, certain investments that are measured at fair value using the net asset value per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy.

The Plan's investments in pooled separate accounts are valued at the net asset value per share, used as a practical expedient to estimate fair value. The net asset value is based on the fair values of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value.

Note 5. Fair Value Measurements (continued)

Basis of Fair Value Measurement (continued)

The pooled separate accounts are direct filing entities (DFEs) and file Form 5500 annual reports with the U.S. Department of Labor. The Plan is not required to disclose the significant investment strategies of DFE investments. Redemptions are available on a daily basis without notice.

Note 6. Certified Information

Note 7. Risks and Uncertainties

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.

The Plan has a significant portion of its assets in one pooled separate accounts, John Hancock Multimanager Balanced Lifestyle Fund, which represented approximately 53% and 55% of the Plan's net assets available for benefits as of December 31, 2024 and 2023, respectively.

Note 8. Party-in-Interest and Related Party Transactions

The Plan holds units of participation in pooled separate accounts managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is the Trustee and Custodian of the Plan's investment assets, and therefore, these transactions qualify as exempt party-in-interest transactions.

Certain employees of the Company are performing services for the Plan and are not compensated by the Plan. Certain other expenses of the Plan are paid by the Company.

Note 9. Participant Contributions

U.S. Department of Labor (DOL) regulations provide that participant contributions to retirement plans must be made on the earliest date that they can reasonably be segregated from the employer's general assets, but in no event later than 15 business days following the month in which the participant contributions were withheld. An employer can be held liable for investment losses and interest incurred during the period of any delay in remitting the contributions to the Plan, and the late deferrals would be considered prohibited transactions that must be reported on the Plan's Form 5500 until corrected. During the years ended December 31, 2024 and 2023, the Company remitted contributions totaling \$20,829 and \$38,540 respectively, in a timeframe that did not comply with the timeliness requirements prescribed by DOL regulations. As of the date the financial statements were available to be issued, the Plan had corrected the 2023 and 2024 delinquent contributions by making a contribution for lost earnings to the Plan. The corrections and any excise taxes, if applicable, will be made from the Company's assets and not from assets of the Plan.
