We have performed an audit of the financial statements of VNS Health Retirement Savings Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the 2024 financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **Note 1. Description of the Plan**

The following description of the VNS Health Retirement Savings Plan (the Plan) only provides limited general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

***General***

Visiting Nurse Service of New York (d/b/a VNS Health), sponsors a defined -contribution savings plan available to its employees, and employees of other affiliated companies, which, with the consent of VNS Health, have adopted the Plan. Participating employers include VNS Health, VNS Health Home Care, VNS Health Plans, VNS Health Hospice Care, VNS CHOICE Community Care, VNS Health Behavior Health, New Partners, Inc. (d/b/a VNS Health Personal Care), and VNS Health Management Services Organization, LLC., collectively the Employers. VNS Health is the Plan Sponsor. The Plan was amended and restated effective September 25, 2021. The Board of Directors is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Directors.

***Eligibility***

Management, administrative and professionals (i.e. nonunion) (MAP) employees, as well as employees who are represented by Federation of Nurses/United Federation of Teachers (UFT), Federation of Nurses and Health Professionals/American Federation of Teachers (FNHP/AFT), and American Federation of Labor Congress of Industrial Organizations (AFLCIO) (UFT represented), who have completed one year of service for VNS Health or any of the other participating employers mentioned above, are eligible to participate in the Plan.

There is no waiting period and employees can participate as soon as they become eligible employees per the criteria below:

Eligible employees mean any employee, other than:

- a) a per diem employee, except to the extent provided otherwise under the collective bargaining agreements between Home Care, and the UFT;
- b) an employee whose employment is covered by the collective bargaining agreement between VNS Health, Home Care, and 1199 National Health and Services Employees Union;
- c) an individual who is a leased employee of the Employers (within the meaning of Section 414(n) of the Internal Revenue Code); and
- d) an individual who is classified by the Employers as an independent contractor.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan offers a range of investments in various asset classes, which allows participants to build portfolios consistent with their needs.

***Contributions***

***(i) Employee Contributions***

Participants may contribute from 1% to 50% of their eligible compensation. Each participant may elect to contribute as before-tax contribution, Roth contribution or after-tax contribution. After-tax contributions for highly compensated MAP employees remain capped at 6%.

In addition, the Plan includes an auto--enrollment provision whereby all newly hired eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their contribution rate set at 6% of eligible compensation on a pre-tax basis and their contributions and any contributions made by the Plan Sponsor invested in a designated balanced fund until changed by the participant.

*(ii) Employers Matching Contribution*

MAP employees are immediately eligible for the employer's matching contribution.

The Employers contribute 25% of the first 6% of compensation contributed by a participant to the Plan (employers matching contribution) except for per diem and other part-time UFT represented employees. Effective April 1, 2016, UFT -represented registered nurses are no longer eligible for the matching contribution. Employees who are hired, rehired or transferred into a full-time or regular part-time UFT represented registered nurse position on or after June 1, 2020 are eligible for employers matching contributions after one year of service.

*(iii) Company Basic Contribution*

MAP employees who were participants in the Visiting Nurse Service of New York CARE Pension Plan (CARE Pension Plan) as of December 31, 2014 are eligible for a 5% company basic contribution. All MAP employees who were not participants in the CARE Pension Plan as of December 31, 2014, are eligible for a 4% company basic contribution. There is a one--year eligibility waiting period for company basic contributions.

UFT -represented registered nurses who are hired, rehired or transferred into a full--time or regular part--time registered nurse position on or after June 1, 2020, are eligible for a 4% company basic contribution.

The company basic contributions for MAP employees are treated as a safe -harbor contribution and are immediately vested. The company basic contributions for all participants are contributed each payroll period. Contributions are subject to certain applicable IRS limitations.

Upon enrollment in the Plan, a participant may make direct contributions in any of the available investment options. Participants may change their investment options to the extent permitted by the individual agreements.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Sponsor's contributions and plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their contributions, rollovers, and safe harbor contributions plus actual earnings thereon. Vesting in the Sponsor's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after three years of continuous service. A participant is also vested upon death prior to termination of employment, termination after attaining age 60, termination of employment due to permanent disability, entitlement to receive either an early or disability pension benefit under the provision of the CARE Pension Plan, or plan termination.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined on the first business day of the month the loan is originated, is set at 1% above the prime rate, as defined. Principal and interest is paid by an Automated Clearing House directly from the individual participant's account.

***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, annual installments, or may elect to directly rollover the balance into another qualified plan.

A participant may request a withdrawal from the Plan to meet an immediate and heavy financial need, as defined in the plan document.

***Forfeitures***

At December 31, 2024 and 2023, in the event a participant terminates employment, the unvested employer basic and employer matching contribution account balances are forfeited at that time. Forfeited contributions are used by the Employers to reduce their future contributions to the Plan. Forfeited nonvested accounts used to reduce employer contributions during 2024 was \$159,001. There were \$422,824 and \$187,959 of forfeited nonvested accounts yet to be allocated as of December 31, 2024 and 2023, respectively.

***Administrative Expenses***

All administrative expenses are paid by the Employers for active Employees. Effective January 1, 2022, terminated Employees pay an annual fee of \$50 from their account balance

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Contributions***

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

***Administrative Expenses***

Administrative expenses may be paid by the Sponsor or the Plan, at the Sponsor's discretion.

**Note 3. Certification of the Plan Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC (Empower), a qualified institution representing products and services for Great West Trust Company, LLC, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Related-Party and Party-in-Interest Transactions**

Great West Trust Company, LLC. is the trustee and recordkeeper for the Plan and, therefore, any investment managed by Great West Investment qualifiers as a party-in-interest transaction. Fees for the investment management services are paid by the Plan Sponsor.

## **Note 5. Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Prices are determined using other significant observable inputs. Observable inputs are inputs that other market participants may use in pricing a security. These may include quoted prices for similar securities, interest rates, prepayment speeds, credit risk, yield curves, loss severities, default rates, discount rates, volatilities, and others.
- Level 3** Prices are determined using significant unobservable inputs. In situations where quoted prices or observable inputs are unavailable (for example, when there is little or no market activity for an investment at the end of the year), unobservable inputs may be used. Unobservable inputs reflect the Trust's own assumptions about the factors market participants would use in determining fair value of the securities or instruments and would be based on the best available information.

### ***Recurring Measurements***

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 or 2023.

The Plan's money market funds are valued based on the net asset value (NAV) of the respective fund on a daily basis. The funds comprise -short term and highly liquid underlying investments and are considered Level 1 measurements within the fair value hierarchy as of December 31, 2024 and 2023.

The Plan's commingled funds are valued daily based on the NAV of the respective fund. The NAV of each commingled fund is based on the fair value of the underlying investments, which include actively traded domestic and international equity and debt securities that typically do not have liquidity restrictions and are considered Level 1 measurements within the fair value hierarchy as of December 31, 2024 and 2023.

The Plan's mutual funds are valued at quoted prices reported on the active market on which the securities are traded on the last business day of the year. The fair value of mutual funds are considered Level 1 measurements within the fair value hierarchy as of December 31, 2024 and 2023.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 7. Tax Status**

The IRS has determined and informed the Plan Sponsor by a letter dated February 23, 2018, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9. Reconciliation of Financial Statements to Form 5500**

From time to time, the Plan may have reconciling items between the Annual Return/Report of Employee Benefit Plan (Form 5500) as filed with the Department of Labor (DOL) prepared under reporting requirements and instructions for Form 5500, and the financial statements prepared under accounting principles generally accepted in the United States of America. Reconciling items as of December 31, 2024 comprised of \$469,552 of participant loans that are recognized on Form 5500 when deemed distributed, as indicated in the Form 5500 instructions, but under accounting principles generally accepted in the United States of America are not recognized until a distributable event occurs.

**Note 10. Subsequent Events**

Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.
