The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (a qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**1. Plan Description**

The following description of the Peckham Industries, Inc. Deferred Compensation Profit Sharing Thrift Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering all eligible employees of Peckham Industries, Inc. and participating employers (collectively the "Employer" or "Company"). The Plan excludes those employees who are: covered by a collective bargaining agreement (unless previously agreed); leased employees; residents of Puerto Rico; and employees of the Shaftsbury, Vermont location working under temporary visas. A participant must complete 2 months of service to make elective contributions to the Plan and to be eligible for Employer safe harbor matching contributions. There is no age requirement to participate in the Plan. Effective March 8, 2024, the Plan was amended to credit service for employees who were employed by: W.E. Dailey, Reclamation of Kingston LLC, Dutchess Quarry & Supply Co., Inc., T. Miozzi, Inc., John S. Lane & Sons, Inc. and E. Tetz & Sons, LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

***Contributions***

Each year, eligible employees may contribute up to 100% of their eligible compensation on a pre-tax, after-tax, or Roth basis, limited to annual dollar maximums as prescribed by the Internal Revenue Service ("IRS"). Upon meeting the eligibility requirements, an eligible employee will be automatically enrolled in the Plan at a rate of 6% of their eligible compensation on a pre-tax basis, unless they affirmatively opt out. There is an auto escalation feature in which a participant's contributions will increase by 1% each year until reaching 12% of their eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts from other eligible retirement plans, as defined in the Plan document.

The Employer makes safe harbor matching contributions in an amount equal to 100% of the first 2% plus 50% of the next 4% of eligible compensation not to exceed 4% of eligible compensation, subject to IRS limitations. The Employer may also make a discretionary non-elective contribution. A participant must work 1,000 hours of service and also be employed on the last day of the Plan year to be eligible for the Employer discretionary non-elective contribution. During 2024, no discretionary non-elective contributions were made by the Employer.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**1. Plan Description (*continued*)**

***Vesting***

Participants in the Plan are at all times fully vested in their contributions and safe harbor matching contributions plus actual earnings thereon. Participants vest in Employer discretionary non-elective contributions by 20% per year of vested service and is fully vested after 5 years of credited service.

Different vesting schedules may apply to certain participants' of participating employers, as defined in the Plan document.

***Forfeitures***

Forfeitures of employer contributions may be used to pay Plan expenses as determined by the plan administrator. Any remaining forfeitures will be used to reduce the Employer's contributions. During 2024 and 2023, forfeitures totaled \$42,815 and \$69,465, respectively. During 2024, \$111,697 of forfeitures were used to reduce Employer contributions.

***Payment of Benefits***

Upon termination of service due to death, disability, retirement (age 65) or separation from service, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in their account or installment payments under a systematic withdrawal plan. Withdrawals from the Plan may also be granted based upon circumstances of financial hardship, in accordance with provisions specified in the Plan document. The Plan also allows in-service withdrawals from vested accounts at age 59 1/2.

***Revenue Credit Account***

The Plan entered into an agreement with Fidelity Management Trust Company whereby the Plan receives participant revenue credits from Fidelity quarterly equal to the average quarterly balance in the Plan multiplied by an agreed upon rate. These participant revenue credits are allocated to eligible participant accounts as soon as administratively feasible after each quarter. Allocations for the participant revenue credit is made to eligible participants pro rata based on the ratio of each participant's average daily balance in a fund to the total average daily balances for all eligible participants in such fund during a quarter. Amounts allocated to eligible participant accounts are invested in the fund to which the participant revenue credit relates, and allocated proportionately to the source associated within such fund for each participant. The Revenue Credit Account balance was \$20,460 and \$21,757 at December 31, 2024 and 2023. During 2024, revenue credits amounting to \$160,355 that were netted against administrative expenses on the statement of changes in net assets available for benefits.

***Notes Receivable from Participants***

The Plan offers a loan feature whereby a participant (borrower) enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum amount of 50% of his or her vested account balance or \$50,000 (whichever is less). Loans are collateralized by the balance in the participant's account and bear interest as determined at the time of loan origination. Principal and interest are paid ratably through payroll deductions. The borrower also pays a loan origination and record-keeping fee. The loan must be repaid within a five-year period, unless the loan is used to acquire the principal residence of the borrower.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. The mutual funds and money market fund are valued at the daily closing price as reported by the fund. These funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. These funds are deemed to be actively traded.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan's investments were valued using level 1 inputs.

**2. Summary of Significant Accounting Policies *(continued)***

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment related expenses are included in the NAV of the respective funds and, consequently, those expenses are not separately reflected but are a component of net appreciation in fair value of investments.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is July 18, 2025.

**3. Information Certified (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

**4. Party-In-Interest Transactions**

Certain Plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants on the statements of net assets available for benefits.

**4. Party-In-Interest Transactions (*continued*)**

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would be 100% vested in their Employer contributions.

**6. Income Tax Status**

The Company has adopted the FMR LLC prototype plan, which received an IRS opinion letter dated June 30, 2020 which stated that the prototype plan is designed in accordance with the applicable provisions of the Internal Revenue Code ("IRC"). Although the Plan has been amended, the plan administrator believes that the Plan is designed and is currently being operated in accordance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
