Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Motion Picture Industry Pension Plan 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the Motion Picture Industry Pension Plan 401(k) Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document and amendments for more specific provisions.

A. General

The Plan is a defined contribution plan established in 1997 by Motion Picture Industry Pension Plan (the "Company") to provide retirement benefits for eligible employees of the Company and Motion Picture Industry Health Plan. The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the "Code") and provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

B. Eligibility

All employees of the Company and any participating affiliates, except those covered by a collective bargaining agreement, residents of Puerto Rico or leased employees, are eligible for the Plan. There are no age or service requirements.

C. Participant Contributions

Participants may elect to defer up to 60% of their eligible compensation subject to applicable Code limits. Participants of age 50 or older may make additional catch-up contributions of up to \$7,500 annually in 2024. The Company may also make a discretionary nonelective contribution for certain employees; no nonelective contributions were made for 2024.

Participants are allowed to make rollover contributions of amounts received from other tax-qualified retirement plans subject to approval of the plan administrator. Such contributions are deposited in the appropriate investment funds in accordance with the participant's investment directions.

D. Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, and an allocation of Plan earnings or losses and expenses. Plan assets are invested based solely on instructions received from participants.

E. Vesting

Participants are immediately 100% vested in their accounts attributable to elective deferrals, rollover contributions, after-tax contributions and qualified nonelective contributions.

F. Payment of Benefits

Normal retirement age under the Plan is age 65. Upon termination of service, death, disability, retirement or attainment of age 59½, a participant or beneficiary may choose to maintain his or her account in the Plan or receive benefits in a lump sum payment equal to the value of the participant's account balance. If a terminated participant's account balance is greater than \$1,000 and no distribution election has been received from the participant or

beneficiary of the account, the account may be rolled over to an individual retirement account at the direction of the plan administrator. If such account does not exceed \$5,000, the balance may be paid in a lump sum distribution. Under limited circumstances, the plan administrator may approve hardship withdrawals. Benefits are recorded when paid.

G. Notes Receivable from Participants

The Plan allows a participant to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of his or her vested account balance. A loan is secured by a participant's vested account balance, bears interest at a fixed rate as determined by the plan administrator based on prevailing interest rates charged to persons in the business of lending money for loans which would be made under similar circumstances, and must be repaid to the Plan within a five-year period unless a loan is used for the purchase of a principal residence in which case the maximum repayment period may be extended up to ten years. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at December 31, 2024 carry interest rates of 4.25% to 9.50%.

H. Administrative Expenses

The Company pays most administrative expenses.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts and disclosures. Actual results may differ from those estimates.

C. Risks and Uncertainties

Plan investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

NOTE 3 - RELATED PARTY TRANSACTIONS

Certain investments held by the Plan are issued and managed by the trustee or its affiliates. Transactions related to these investments qualify as party-in-interest transactions under ERISA regulations, but such transactions are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 4 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

NOTE 5 - INCOME TAX STATUS

The Plan has adopted a prototype plan that received an opinion letter from the Internal Revenue Service dated March 31, 2014 stating that the form of the plan qualifies under applicable provisions of the Code for tax-exempt status. The Company believes that the Plan is operated in accordance with, and qualifies under, the applicable requirements of the Code and related state statutes, and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

NOTE 7 - FAIR VALUE MEASUREMENTS

Accounting guidance establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability. Level 1 investments are mutual funds valued at quoted market prices.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income.

NOTE 8 - STABLE VALUE FUND INVESTMENT CONTRACT

Fidelity Advisor Stable Value III invests in assets (typically fixed-income securities or bond funds and may include derivative instruments such as futures contracts and swap agreements), enters into “wrap” contracts issued by third-parties, and invests in cash equivalents represented by shares in money market funds. Units of the fund are valued at contract value of the units held. Contract value represents deposits, plus earnings at guaranteed credit rates, less withdrawals and fees. The 7-day yield was 2.19% as of December 31, 2024.

NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the Motion Picture Industry Pension Plan 401(k) Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document and amendments for more specific provisions.

A. General

The Plan is a defined contribution plan established in 1997 by Motion Picture Industry Pension Plan (the "Company") to provide retirement benefits for eligible employees of the Company and Motion Picture Industry Health Plan. The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the "Code") and provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

B. Eligibility

All employees of the Company and any participating affiliates, except those covered by a collective bargaining agreement, residents of Puerto Rico or leased employees, are eligible for the Plan. There are no age or service requirements.

C. Participant Contributions

Participants may elect to defer up to 60% of their eligible compensation subject to applicable Code limits. Participants of age 50 or older may make additional catch-up contributions of up to \$7,500 annually in 2024. The Company may also make a discretionary nonelective contribution for certain employees; no nonelective contributions were made for 2024.

Participants are allowed to make rollover contributions of amounts received from other tax-qualified retirement plans subject to approval of the plan administrator. Such contributions are deposited in the appropriate investment funds in accordance with the participant's investment directions.

D. Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, and an allocation of Plan earnings or losses and expenses. Plan assets are invested based solely on instructions received from participants.

E. Vesting

Participants are immediately 100% vested in their accounts attributable to elective deferrals, rollover contributions, after-tax contributions and qualified nonelective contributions.

F. Payment of Benefits

Normal retirement age under the Plan is age 65. Upon termination of service, death, disability, retirement or attainment of age 59½, a participant or beneficiary may choose to maintain his or her account in the Plan or receive benefits in a lump sum payment equal to the value of the participant's account balance. If a terminated participant's account balance is greater than \$1,000 and no distribution election has been received from the participant or

beneficiary of the account, the account may be rolled over to an individual retirement account at the direction of the plan administrator. If such account does not exceed \$5,000, the balance may be paid in a lump sum distribution. Under limited circumstances, the plan administrator may approve hardship withdrawals. Benefits are recorded when paid.

G. Notes Receivable from Participants

The Plan allows a participant to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of his or her vested account balance. A loan is secured by a participant's vested account balance, bears interest at a fixed rate as determined by the plan administrator based on prevailing interest rates charged to persons in the business of lending money for loans which would be made under similar circumstances, and must be repaid to the Plan within a five-year period unless a loan is used for the purchase of a principal residence in which case the maximum repayment period may be extended up to ten years. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at December 31, 2024 carry interest rates of 4.25% to 9.50%.

H. Administrative Expenses

The Company pays most administrative expenses.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts and disclosures. Actual results may differ from those estimates.

C. Risks and Uncertainties

Plan investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

NOTE 3 - RELATED PARTY TRANSACTIONS

Certain investments held by the Plan are issued and managed by the trustee or its affiliates. Transactions related to these investments qualify as party-in-interest transactions under ERISA regulations, but such transactions are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 4 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

NOTE 5 - INCOME TAX STATUS

The Plan has adopted a prototype plan that received an opinion letter from the Internal Revenue Service dated March 31, 2014 stating that the form of the plan qualifies under applicable provisions of the Code for tax-exempt status. The Company believes that the Plan is operated in accordance with, and qualifies under, the applicable requirements of the Code and related state statutes, and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

NOTE 7 - FAIR VALUE MEASUREMENTS

Accounting guidance establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability. The following tables summarize the Plan’s investments based on the inputs used to value them:

Level 1 investments are mutual funds valued at quoted market prices.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income.

NOTE 8 - STABLE VALUE FUND INVESTMENT CONTRACT

Fidelity Advisor Stable Value III invests in assets (typically fixed-income securities or bond funds and may include derivative instruments such as futures contracts and swap agreements), enters into “wrap” contracts issued by third-parties, and invests in cash equivalents represented by shares in money market funds. Units of the fund are valued at contract value of the units held. Contract value represents deposits, plus earnings at guaranteed credit rates, less withdrawals and fees. The 7-day yield was 2.19% as of December 31, 2024.





