### Opinion

We have audited the financial statements of Ankrom Moisan Associated Architects, Inc. Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves and other additional procedures in accordance with GAAS.

### **Notes to Financial Statements**

---

#### **1. Description of Plan**

The following description of the Ankrom Moisan Associated Architects, Inc. Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan is an employee stock ownership plan covering all employees of Ankrom Moisan Associated Architects, Inc. (the "Plan Sponsor" or the "Company"), who are age 18 or older and who are not employed outside the United States and not represented by a collective bargaining unit unless participation is negotiated for and included in a collective bargaining agreement. The Plan is designed to qualify as an employee stock ownership plan, as defined in Section 4975(e)(7) of the Internal Revenue Code ("IRC") and holds shares of common stock of the Plan Sponsor's sole shareholder, AMAA Enterprises, Inc. ("AMAA Enterprises"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Company's board of directors (the "Board") is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Company uses an independent third-party as the Plan's trustee and is responsible for holding and managing all assets in accordance with the Plan.

##### **Voting rights**

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Plan Sponsor prior to the time such rights are to be exercised. The Plan's trustee is permitted to vote any unallocated shares and any allocated shares for which a participant failed to give timely voting instructions.

##### **Contributions**

The Plan provides for discretionary employer contributions in amounts determined by the Board, subject to tax laws. The contributions may be paid in cash or shares of AMAA Enterprises common stock, as determined by the Board. AMAA Enterprises common stock is valued at its fair market value on the date of the contribution. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Participant contributions are not permitted.

##### **Participant accounts**

Eligible participants' accounts are credited with an allocation of the Company's contributions and forfeitures, as well as an allocation of Plan earnings and charged an allocation of the Plan's expenses, if paid by the Plan. Allocations for contributions and forfeitures are based proportionally upon each participant's portion of the total covered compensation of all participants for the Plan year. Allocation of Plan earnings and Plan expenses are based proportionally upon each participant's portion of the total account balances at the beginning of the Plan year. The benefit to which a participant is entitled to is the benefit that can be provided from the participant's vested account. There were no unallocated shares of stock at December 31, 2024 and 2023.

##### **Vesting**

Participants begin vesting in the Plan on the first day of the subsequent quarter after hire and become 100% vested in the contributions after five years of credited service. A participant becomes fully vested in the entire balance of his or her account upon attaining normal retirement age, permanent disability, death or termination of the Plan.

**1. Description of Plan (continued)**

**Payment of benefits**

On termination of service due to death, disability or retirement, participants may receive lump sum distributions of cash or AMAA Enterprises common stock equal to the value of the participants' vested interests in their accounts. Participants with vested interests greater than \$5,000 but less than the maximum threshold may receive, as directed by the Board, lump sums of cash or distributions in five substantially equal annual installments. Participants with vested interests in excess of this threshold, as indexed for inflation, may elect to receive distributions in five substantially equal annual installments, plus one year for each additional amount (or fraction thereof), by which the vested interests exceed the maximum threshold amount (as indexed). The time over which benefits may be paid out may not exceed the life expectancies of the participants. The maximum indexed amounts per IRC Section 415 for 2024 are \$1,380,000 for the maximum threshold and \$275,000 for the additional amount. No distributions of AMAA Enterprises common stock were made during the year ended December 31, 2024.

Under the provisions of the Plan, the Ankrom Moisan Associated Architects Employee Stock Ownership Trust (the "Trust") has the first priority to exercise the right to purchase available shares of AMAA Enterprises common stock. The Company is obligated to exercise a second priority to purchase shares not acquired by the Trust.

During 2024, the Trust repurchased 8,835 shares of previously allocated AMAA Enterprises common stock from terminated participants at \$126 a share, a price determined by the independent appraiser.

**Forfeited accounts**

At December 31, 2024 and 2023, there were no remaining forfeited nonvested accounts. Forfeitures are allocated in the same manner as the Company's contributions. In 2024, there were approximately \$23,000 of forfeitures allocated to active participants.

**Put option**

Under the provisions of the Plan and federal income tax regulations, if a distribution is made in the form of AMAA Enterprises common stock, the participant or beneficiary has the option to put the shares to the Company. The put is a right to demand that the Company buy any shares of AMAA Enterprises common stock distributed to participants for which there is no market.

The put price is representative of the fair value of the stock. The Company can pay for the purchase, with interest, over a period of up to five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

**Diversification**

Diversification is offered to participants close to retirement, so that they may have the opportunity to move part of the value of their investments in AMAA Enterprises common stock into investments which are more diversified. Participants who are at least age 55, with at least ten years of participation in the Plan and a stock account balance greater than \$500, may elect to diversify a portion of their accounts. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. The elected amount may be invested in any of at least three diversified funds offered with the Plan or with another plan maintained by the Company. During 2024, there were no diversifications to the Company's 401(k) Plan.

**2. Summary of significant accounting policies**

**Basis of accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

**Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board determines the Plan's valuation policies utilizing information provided by the asset custodian and independent appraiser. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

**Subsequent events**

The Plan has evaluated subsequent events through October 3, 2025, which is the date these financial statements were available to be issued. Events, if any, are disclosed within the notes to these financial statements.

#### **4. Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access at the measurement date.

**Level 2:** Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023:

*Interest-bearing cash:* Valued at the market value of cash held by the Plan at year end

*AMAA Enterprises, Inc. common stock:* Valued at fair value based upon an independent appraisal. This appraisal was based upon a combination of market and income valuation techniques. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity and estimated fair value of Company assets and liabilities. In addition, other factors that the appraiser considered were the nature and history of the Company, marketability and control factors relating to the AMAA Enterprises common stock, the economic outlook and condition of the Company's industry, transaction prices of comparable companies and the dividend-paying capacity of the Company.

The valuation methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

**5. Party-in-interest transactions**

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under DOL regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator, investment managers, investment advisors, legal counsel, the appraiser and Plan auditor.

The Plan invests in common stock of AMAA Enterprises. These investment transactions are considered related party transactions under ERISA. The Plan Sponsor performs certain administrative duties for the Plan. The Plan does not compensate the Plan Sponsor for administrative duties performed.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**6. Plan termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in the contributions and the interest of each participant in the Plan will be distributed to such participant at the time prescribed by the Plan agreement and the IRC.

**7. Tax status**

The Internal Revenue Service (“IRS”) has determined and informed the Company by a letter, dated March 10, 2016, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

**7. Tax status (continued)**

Plan management evaluates tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain tax position that, more likely than not, would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. Risks and uncertainties**

The Plan's investments are exposed to various risks such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with the investment in AMAA Enterprises common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
