Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of **Hyman Bros. of Midlothian 401(k) Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Hyman Bros. of Midlothian 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Hyman Bros. of Midlothian 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. NOTES TO FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Hyman Bros. of Midlothian 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

a. General

The Plan is a defined contribution plan covering all employees of Hyman Bros. of Midlothian, Inc.; Saturn of Richmond, Inc.; Hyman Bros. of Newport News, Inc.; and Haywood B. Hyman, Jr., Inc. (the Company) who have two consecutive months of service and have attained the age of 21. The Board of Directors controls and manages the operation and administration of the Plan. Ascensus Trust Company serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Contributions

The Plan permits the following types of contributions:

Elective Deferrals. Participants may contribute a maximum of 75% of annual compensation, defined in the Plan document, subject to Internal Revenue Code (IRC) limitations (\$23,000 in 2024). Participant salary deferrals may be traditional 401(k) (pre-tax) or Roth 401(k) (after-tax). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they elect not to participate. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions are invested in a designated fund until changed by the participant. Contributions are subject to certain limitations.

Catch-up Contributions. Participants who have attained age 50 before the end of the plan year may make additional elective deferrals, called catch-up contributions (\$7,500 in 2024), in excess of the elective deferral limits as determined by Internal Revenue Service regulations.

Matching Contributions. Employer discretionary matching contributions are determined annually by the Company. For 2024, the Company made discretionary matching contributions equal to 25% of the first 4% of the individual participant's compensation contributed to the plan.

Nonelective Contributions. The Plan permits the Company to make additional discretionary nonelective contributions to the Plan. However, these contributions are at the Company's sole discretion and not guaranteed from year to year. No nonelective contributions were made for the year ended December 31, 2024.

Rollover and Transfer Contributions. The Plan allows participants to roll over and transfer certain amounts held under other qualified retirement plans or individual retirement accounts to this Plan.

c. Investment Options

Each participant is entitled to direct the investment of his/her account into various options offered by the Plan. The plan administrator has selected a number of different funds in which a participant may invest his/her account. The plan administrator may add to or reduce the number and type of investment funds that will be available for investment.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF PLAN (Continued)

d. Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's contributions and allocations of the Plan earnings (losses), and charged with benefit payments, transaction fees related to notes receivable from participants and distributions, investment advisory fees, and allocations of administrative expenses. Allocations are based on participant earnings, participant contributions, or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

e. Vesting

Participants are always 100% vested in their elective deferrals, rollover contributions, transfer contributions, and catch-up contributions.

Company matching and nonelective contributions will become vested in accordance with the following schedule:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 1 year	0%
1 year	25%
2 years	50%
3 years	75%
4 years	100%

If a participant reaches age 59 1/2, becomes permanently disabled or dies while still employed by the Company, he/she will automatically become fully vested in all contributions, regardless of his/her years of service.

f. Participant Notes Receivable

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of a participant's vested account balance. Loans are secured by the balance in the participant's account and bear interest at rates commensurate with the local prevailing rates as determined by the plan administrator. At December 31, 2024, outstanding loans were subject to interest ranging from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

g. Payment of Benefits

A participant's vested account will be paid to them or their beneficiary in a single lump sum payment as soon as administratively possible after the date on which the participant retires, dies, becomes disabled or otherwise terminates employment, subject to any requirement that they consent to a distribution of their account. While still employed, distributions of pre-tax deferrals may be withdrawn upon demonstration of financial hardship, qualified reservist, or after the participant reaches the age of 59 1/2.

h. Forfeited Accounts

The non-vested portion of terminated participant account balances are retained by the Plan. The Plan will use forfeitures for the payment of administration expenses or to reduce the Company's matching contributions. During 2024, \$2,520 of forfeitures were used to reduce employer matching contributions.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

a. Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

b. Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the gains and losses on investments purchased and sold as well as those held during the year.

The Plan's investments, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. In addition, due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

c. Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

d. Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable from participants, distributions, and investment advisory fees) are charged directly to the participant's account.

e. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

f. Payment of Benefits

Benefits are recorded when paid.

g. Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

NOTE 4 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

Following is a description of the valuation methodologies used for assets measured at fair value:

- Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Common collective trust funds - Quoted prices are not available in active markets for identical instruments. The funds are valued at the NAV of units of a collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it were determined to be probable that the funds would sell the investment for an amount different from the reported NAV. There are no funds within the plan with unfunded commitments. Participant transactions (purchases and sales) may occur daily. Upon request, full redemption of the collective trusts requires 12 months' prior notification in order to ensure that securities liquidations will be carried out in an orderly business manner. The collective trust funds are not required to be classified within a level on the fair value hierarchy.

NOTE 5 – PLAN TERMINATION

Although it has not expressed intent to do so, the Company has the right to terminate the Plan at any time. In the event of Plan termination, participants will become 100% vested in their accounts. Should the Plan terminate at some future time, its net assets will be paid to the participants or their beneficiaries in a lump sum as soon as practicable after the termination.

NOTE 6 – TRANSACTIONS WITH PARTIES IN INTEREST

Certain legal, accounting, and administration fees are paid by the Company. Expenses paid to the trustee by the Plan for administrative services were \$39,452 for the year ended December 31, 2024. The Plan paid One Digital Investment Advisors \$16,667 for advisory services during 2024. Other than as described above or pursuant to certain trust agreements with Ascensus, the Plan has had no agreements or transactions with any parties in interest.

NOTE 7 – TAX STATUS

The Plan has not obtained a determination letter from the IRS stating that the Plan was in compliance with the applicable requirements of the IRC. The Plan is relying on the IRS approval of the standardized prototype plan document that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated June 30, 2020, that the prototype plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Plan management has determined that the Plan does not have any uncertain income tax positions and associated unrecognized benefits that materially impact the financial statements or related disclosures.

NOTE 8 – BENEFITS PAYABLE TO TERMINATED PARTICIPANTS

Net assets available for Plan benefits include no amounts due to terminated employees who elected to withdraw from the Plan before December 31, 2024.
