Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of Metropolitan Jewish Health System, Inc. 403(b) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedules listed in the table of contents are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section it is inappropriate to and we do not express an opinion on these supplemental schedules.

Note 1. Description of Plan

The following description of the Metropolitan Jewish Health System, Inc. 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan, which became effective January 1, 2006, is a contributory defined-contribution plan (the 403(b) Plan) sponsored by the Metropolitan Jewish Health System, Inc. (the Sponsor) for the benefit of its employees. Employees are immediately eligible to participate in the Plan as a contributing participant upon commencement of employment with the Sponsor.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Lincoln Financial Group Trust Company, Inc. (Lincoln) serves as the custodian of the Plan.

The Plan provides retirement benefits to all eligible employees for the following controlled group of employers:

- Metropolitan Jewish Health System, Inc.
- Metropolitan Jewish Health System Foundation
- Menorah Home and Hospital for the Aged and Infirm
- Elderplan, Inc.
- HomeFirst LHCSA, Inc.
- Isabella Geriatric Center
- Metropolitan Jewish Home Care, Inc.
- MJHS Hospice and Palliative Care, Inc.
- MJHS Medical Associates, PC
- Institute for Applied Gerontology, Inc.

In 2019, assets within the Isabella Employee Retirement Plan were transferred into the Metropolitan Jewish Health System, Inc. 403(b) Plan. Certain plan assets were not transferred at that time. These remaining assets in the Isabella Employee Retirement Plan were approved to be legally transferred to the Metropolitan Jewish Health System, Inc. 403(b) Plan effective December 31, 2024, which results in the full merger of the two Plans. As the certifications related to the investments of Isabella Employee Retirement Plan do not reflect the transfer in progress of the assets as of December 31, 2024, to the Metropolitan Jewish Health System, Inc. 403(b) Plan, this transfer is shown as a reconciling item between the financial statements and the Form 5500 for 2024. (See note 9)

Contributions

All employees are eligible to make elective salary deferrals into the Plan on their first day of employment. There are no employer contributions into the Plan. However, during 2024, employer made \$112 of contributions related to missed contributions by an employee.

The Plan accepts rollovers and transfers from other qualified plans, but only for those employees eligible to participate in the Plan. Contributions are subject to certain limitations.

Participant Investment Account Options

Participants direct the investment of their contributions into various investment options offered by the Plan.

Each participant's account is credited with the participant's contribution and the participant's share of plan earnings. Plan income and expenses are credited or debited to participant accounts based on the pro rata share of the participant's individual account balance to total plan assets. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

The total value of a participant's account balance is fully and immediately vested.

Notes Receivable from Participants

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need, subject to various requirements set forth in the Plan Document. Participants are permitted only one outstanding loan at a time. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is \$50,000. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through repayments made directly from the participants' savings or checking accounts. Interest on the loans charged ranged from 3.25% to 9.50% for 2024, maturing through December 31, 2029. No allowance for doubtful accounts was recorded as of December 31, 2024 and 2023.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of their account or installment payments. A participant may elect to receive a distribution of their rollover contributions at any time. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

Forfeitures

There are no forfeitures, as eligible participants are immediately vested in their contributions.

Plan Termination

Although it has not expressed an intention to do so, the Sponsor has the right under the Plan to terminate the Plan, subject to the provisions of ERISA.

Subsequent Events

In January 2025, the Plan was amended to adjust the automatic contribution arrangement. The amendment notes that upon becoming eligible to make Salary Deferrals under the Plan, a Participant will be deemed to have entered into a Salary Deferral Election for each payroll period, unless the Participant completes a Salary Deferral Election in accordance with procedures adopted by the Plan Administrator.

Subsequent events have been evaluated through October 1, 2025, which is the date the financial statements were available to be issued.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Excluded Contracts

These financial statements do not include certain annuity and custodial accounts or contracts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The amounts of these excluded annuity and custodial accounts are not determinable.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value of shares held by the Plan at year-end.

The Plan's investments in Lincoln NY Stable Value account is recorded at contract value. Contract value represents contributions made under the contract, plus a minimum rate of interest earned, at a rate determined by Lincoln Life & Annuity Company of New York, less withdrawals, and transfers to other accounts. This account does not have any liquidity restrictions is fully benefit-responsive and has been classified as a Stable Value Account (see Note 5 for a further discussion of the Stable Value Account).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. The income or loss of each investment option, including the change in market value of investments, is allocated to participant accounts based on each participant's proportionate interest in the investment option. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Outstanding loan balances in default will be treated as outstanding for purposes of determining any future loan amounts. In the event of default, the outstanding balance of the loan, including accrued interest, will be treated as a deemed distribution subject to federal income tax.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Sponsor. Administrative expenses including investment management and bookkeeping fees are paid for by the Plan. Investment advisory services are paid by the Plan as a reduction of the investment return (see Note 6).

Plan Tax Status

The Plan operates under a volume submitter agreement in connection with a volume submitter plan and custodial document sponsored by Lincoln Retirement Services Company LLC. This volume submitter Plan Document has obtained an advisory letter from the IRS stating that the volume submitter satisfies the requirements under Section 403(b) of the Internal Revenue Code. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 3. Certification of Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivables from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 5. Stable Value Account with Lincoln Life & Annuity Company of New York

The Plan entered into a fully benefit-responsive guaranteed stable value contract with Lincoln Life & Annuity Company of New York totaling \$19,414,478 and \$20,439,945 at December 31, 2024 and 2023, respectively. Lincoln Life & Annuity Company of New York maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%.

The stable value separate account is fully benefit-responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or

transfer of all or a portion of their investment at contract value. The crediting rate is determined on a pooled basis and stated as an effective annual rate. Credited rates, net of plan level fees and expenses, are reset quarterly.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligation. The issuer's ability to meet its contractual obligation may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the contract issuers. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Code or the failure of the trust to be tax-exempt under Section 501(a) of the Code
- Premature termination of the contracts
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

In addition, certain events allow the issuers to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

The Plan believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

The stable value account does not permit the insurance company to terminate the agreements prior to the scheduled maturity date.

Note 6. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan has fully benefit-responsive contracts with Lincoln Life & Annuity Company of New York, an affiliate of Lincoln.

The Plan paid administration fees of \$274,701 to Lincoln during the year ended December 31, 2024. Lincoln is the custodian of the Plan as of December 31, 2024 and 2023 and, therefore, these transactions qualify as party-in-interest transactions, which are deemed to be "exempt" from Prohibited Transaction Rules as defined by Department of Labor regulations.

The Plan paid administration fees of \$123,484 to Hanys Benefit Services (HBS) during the year ended December 31, 2024. HBS is the advisory of the Plan as of December 31, 2024 and 2023. Fees incurred by the Plan for the investment management services are included through revenue sharing, rather than a direct payment.

Therefore, these transactions qualify as party-in-interest transactions, which are deemed to be “exempt” from Prohibited Transaction Rules as defined by Department of Labor regulations.

Plan servicing credit is an account held under the term of the Plan and funded with excess revenues generated by fees charged to the Plan by the asset custodians. These fees may be used to pay reasonable and necessary expenses for the Plan. In 2024, the Plan servicing credit was \$150,612 that was recorded as an offset to administrative plan expenses.

The Sponsor provides certain administrative services at no cost to the Plan.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term, based upon the markets’ fluctuations, and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer’s general assets. The Sponsor failed to timely remit participants’ contributions for certain payroll periods during 2023. In accordance to the DOL Regulations 2510.3-102, the Plan is reporting delinquent participant contributions of \$1,711,324 as of December 31, 2023. On July 17, 2024, lost earnings in the amount of \$3,893 have been remitted to the Plan.
