We have conducted an ERISA Section 103(a)(3)(C) audit of the financial statements of Pregis LLC Retirement and Savings Plan (the Plan) as of and for the year ended December 31, 2024, and have issued our report thereon dated August 15, 2025. Professional standards require that we advise you of the following matters relating to our audit.

**Our Responsibility in Relation to the Financial Statement Audit**

As communicated in our engagement letter, our responsibility, as described by professional standards, is to conduct our audit in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, as permitted by ERISA Section 103(a)(3)(C), the audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution). For an ERISA Section 103(a)(3)(C) audit, the audit will not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirement of accounting principles generally accepted in the United States of America (GAAP). Accordingly, as part of our ERISA Section 103(a)(3)(C) audit and except that we will not include a consideration of internal control relating to the information prepared and certified to by a qualified institution, we considered the internal controls of the Plan solely for the purpose of determining our audit procedures and not to provide any assurance concerning such internal controls.

We are also responsible for communicating significant matters related to the audit that are, in our professional judgment, relevant to your responsibilities in overseeing the financial reporting process. However, we are not required to design procedures for the purpose of identifying other matters to communicate to you.

Our responsibility for the ERISA-required supplemental schedule accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, are presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditors' report, in order to identify any material inconsistencies between the draft Form 5500 and the financial statements. We identified no material inconsistencies in performing and completing our audit. A reconciliation between the Form 5500 and the financial statements is provided in Note 10 to the financial statements.

### **Planned Scope and Timing of the Audit**

We conducted our audit consistent with the planned scope and timing we previously communicated to you.

### **Compliance with All Ethics Requirements Regarding Independence**

The engagement team, others in our firm, as appropriate, and our firm have complied with all relevant ethical requirements regarding independence.

## **Compliance with All Ethics Requirements Regarding Independence (continued)**

As communicated in our engagement letter, our performance of nonattest services does not include assuming management responsibilities or making management decisions. In relation to such nonattest services, you have agreed to assume all management responsibilities for the nonattest services we provide; oversee the services by designating an individual, preferably from senior management, with suitable skill, knowledge, or experience; evaluate the adequacy and results of the services; and accept responsibility for them. However, the performance of nonattest services creates the potential for circumstances that may impair independence (“threats”). We have identified and evaluated the self-review and management participation threats created by our performance of nonattest services. In order to reduce such threats to an acceptable level, we have taken certain measures or actions (“safeguards”), including the following:

- Policies and procedures that are designed to implement and monitor engagement quality control;
- The involvement of another professional accountant who (a) reviews the work that is done for a client or (b) otherwise advises the engagement team. This individual is someone from within the firm who is not otherwise associated with the engagement; and
- Policies and procedures that are designed to ensure that members of the engagement team do not make or assume responsibility for management decisions for the client.

## **Qualitative Aspects of the Plan’s Significant Accounting Practices**

### *Significant Accounting Policies*

Management has the responsibility to select and use appropriate accounting policies. A summary of the significant accounting policies adopted by the Plan is included in Note 1 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during the year ended December 31, 2024. No matters have come to our attention that would require us, under professional standards, to inform you about (1) the methods used to account for significant unusual transactions and (2) the effect of significant accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus.

### *Significant Accounting Estimates*

Accounting estimates are an integral part of the financial statements prepared by management and are based on management’s current judgments. Those judgments are normally based on knowledge and experience about past and current events and assumptions about future events. We evaluated the key factors and assumptions used to develop the information used in the financial statements and determined that they are reasonable in relation to the basic financial statements taken as a whole.

## **Qualitative Aspects of the Plan's Significant Accounting Practices (continued)**

### *Financial Statement Disclosures*

Certain financial statement disclosures involve significant judgment and are particularly sensitive because of their significance to financial statement users. There are no financial statement disclosures that are particularly sensitive because of their significance to financial statement users.

### **Significant Difficulties Encountered during the Audit**

We encountered no significant difficulties in dealing with management relating to the performance of the audit.

### **Uncorrected and Corrected Misstatements**

For purposes of this communication, professional standards also require us to accumulate all known and likely misstatements identified during the audit, other than those that we believe are trivial, and communicate them to the appropriate level of management. Management has corrected all such misstatements. Misstatements corrected by management represent those adjustments proposed by us as directed by management, and were not detected as a result of audit procedures. In addition, none of these misstatements were material, either individually or in the aggregate, to the financial statements taken as a whole.

### **Disagreements with Management**

For purposes of this letter, professional standards define a disagreement with management as a matter, whether or not resolved to our satisfaction, concerning a financial accounting, reporting, or auditing matter, which could be significant to the Plan's financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of the audit.

### **Representations Requested from Management**

We have requested certain written representations from management that are included in the management representation letter dated August 15, 2025.

### **Management's Consultations with Other Accountants**

In some cases, management may decide to consult with other accountants about auditing and accounting matters. Management informed us that, and to our knowledge, there were no consultations with other accountants regarding auditing and accounting matters.

## **Other Significant Matters or Issues**

In the normal course of our professional association with the Plan, we generally discuss a variety of matters, including the application of accounting principles and auditing standards, significant events or transactions that occurred during the year, business conditions affecting the Plan, and business plans and strategies that may affect the risks of material misstatement. None of the matters discussed resulted in a condition to our retention as the Plan's auditors.

## **Reportable Findings**

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulation, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit the attention of management and governance. We identified the following reportable finding.

### *Noncompliance with Laws and Regulations*

During the year ended December 31, 2024, we noted an instance of noncompliance where the Plan improperly paid \$24,401 in legal fees that should have been paid by Pregis LLC and not the Plan.

## **Other Matter**

The ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, was subjected to the audit procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. In addition, we made certain inquiries of management and evaluated the form, content and methods of preparing the information in the ERISA-required supplemental schedule to determine that the information complies with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

## **Report of Independent Auditors**

To the Administrator and Participants of  
Pregis LLC Retirement and Savings Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Pregis LLC Retirement and Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America; and
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

## Notes to Financial Statements

December 31, 2024 and 2023

### Note 1. Summary of Significant Accounting Policies

**Method of Accounting** - The accompanying financial statements of Pregis LLC Retirement and Savings Plan (the Plan) have been prepared using the accrual basis of accounting.

**Investments** - Investments are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Purchases and sales of the investments are reflected on a trade-date basis.

Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are recorded when incurred. No allowance for credit losses has been recorded as of either December 31, 2024 or 2023. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

**Payment of Benefits** - Distributions to participants are recorded when paid. There were no participants who elected to withdraw from the Plan but were not yet paid at either December 31, 2024 or 2023.

**Expenses** - Certain management and administrative services are provided to the Plan by Pregis LLC (the Company) without charge. Certain investment related expenses are included in net appreciation in fair value of investments.

## **Note 1. Summary of Significant Accounting Policies (continued)**

**Administrative Fee Reimbursements** - The Plan receives an administrative fee reimbursement from Fidelity Management Trust Company on a quarterly basis. The amount reimbursed is the excess of the quarterly recordkeeping revenue earned by Fidelity Management Trust Company over the quarterly recordkeeping fee due from the Plan. The Plan charges participants a quarterly fee of 14 basis points on their account balance. The administrative fee reimbursements and the fees charged to participants are deposited into an unallocated account held by the Trustee of the Plan, which is available to be used to pay Plan expenses. During the years ended December 31, 2024 and 2023, a total of \$212,094 and \$261,222 respectively, was used to pay administrative expenses. Included in net assets available for benefits are unallocated accounts totaling \$199,982 and \$134,608 at December 31, 2024 and 2023, respectively. A total of \$209,466 and \$172,839 in revenue credits were allocated back to participants for the years ended December 31, 2024 and 2023, respectively.

**Estimates** - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**Subsequent Events** - Subsequent events have been evaluated through August 15, 2025, which is the date the financial statements were available to be issued.

## **Note 2. Description of the Plan**

The following description of the Plan provides only general information.

The Plan is a defined contribution retirement plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Benefits under the Plan are not insured by the Pension Benefit Guaranty Corporation. Pregis LLC (the Company) is the sponsor of the Plan and established the Plan in October 2005 for the benefit of its U.S.-based salaried employees. Fidelity Management Trust Company is the Trustee of the Plan's assets. Fidelity Workplace Services, LLC is the recordkeeper for the Plan.

Employees become eligible to participate in the Plan with respect to employee deferrals and employer matching contributions immediately after two months of service with the Company. Employees become eligible to receive the Company's annual profit sharing contribution, if applicable, on the first day of the month after they attain one year of service, comprising at least 1,000 hours. Employees must also be employed on the last day of the year in order to receive a profit sharing contribution for that year.

## **Note 2. Description of the Plan (continued)**

Participants may contribute from 1% to 75% of pre-tax eligible compensation (salary reduction contributions), as defined by the Plan. Participants may also make ROTH contributions to the Plan. All contributions to the Plan are subject to an annual limit as set forth by the Internal Revenue Code. Participants may also roll over amounts representing distributions from other qualified retirement plans. Generally, participants who are at least age 50 were eligible to make catch-up contributions limited to \$7,500 in 2024 and 2023. Newly hired employees who do not make an affirmative election to defer compensation to the Plan, including an election not to defer, are automatically enrolled at a deferral rate of 3% of compensation. This deferral percentage will increase 1% annually in successive years to a maximum of 10% of compensation.

The Company matches 100% of the first 1% of eligible compensation contributed by the participant, then 50% of the next 5% of eligible compensation contributed by the participant.

The terms of the Plan also permit the Company to make a discretionary Company profit sharing contribution to the Plan, contingent on the Company achieving certain annual earnings before interest, taxes, depreciation and amortization (EBITDA) performance objectives, as defined by the Plan, ranging from zero if EBITDA targets are not achieved, to 2% of eligible compensation if EBITDA targets are achieved at 100%, up to a maximum of 4% of eligible compensation if EBITDA is achieved at 110% or more of target. For the years ended December 31, 2024 and 2023, the Company did not make any profit sharing contributions.

Upon enrollment in the Plan, participants may direct contributions to any combination of investment options offered by the Plan. In the absence of participant direction, contributions are invested in a default target date fund. In addition, participants have the right to change their investment elections with respect to future contributions and transfer existing account balances between the various investment options at any time. Participants must evaluate their own investment goals and objectives and choose investments best suited to achieve those goals and objectives. Poor investment performance by the investment options selected by the participants may cause their vested balances to be lower than the amounts contributed to the Plan on their behalf.

Each participant's account is credited with the participant's salary reduction contribution, the Company's matching contributions, the Company's profit sharing contributions, if any, and earnings or losses thereon, net of administrative expenses. Individual accounts are charged with an allocation of any administrative expenses paid by the Plan in excess of administrative fee reimbursements and quarterly fees charged to participants. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Note 2. Description of the Plan (continued)**

Participants are immediately vested in their salary reduction contributions, the Company's matching contributions, and earnings thereon. Participants become vested in Company profit sharing contributions, if any, based on the participant's years of service as follows:

1	20%
2	40%
3	60%
4	80%
5	100%

Upon attainment of age 65, attainment of age 55 and completion of five years of service, or termination of employment with the Company due to death or total disability, participants become 100% vested in their entire account balance.

Forfeited non-vested account balances can be used to reduce future Company matching contributions or to pay Plan administrative expenses. For the years ended December 31, 2024 and 2023, the Plan used \$4,035 and \$19,359 respectively, in forfeitures to reduce Company matching contributions. Included in net assets available for benefits are forfeited non-vested accounts totaling \$12 and \$10 at December 31, 2024 and 2023, respectively.

Benefits may be paid to the participant or beneficiary upon death, disability, retirement or termination of employment, as defined by the Plan. The total vested portion of a participant's account balance is distributed in the form of a lump-sum payment. Upon termination of employment or retirement, if a participant has a vested account balance greater than \$1,000 but \$7,000 or less, the Company may roll it over in a lump-sum distribution to an Individual Retirement Account selected by the Company, unless the participant elects otherwise. In-service withdrawals are allowed for participants on all vested amounts upon attaining age 59½. Participants may also elect to take hardship withdrawals from their vested contributions upon demonstrating immediate and heavy financial need, as allowed under federal rules.

Active participants may obtain a loan with a repayment period no longer than five years. Participants may have only one loan outstanding at any time and may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 minus the highest outstanding loan balance during the previous 12 months, or 50% of their vested account balances. The interest rate on loan balances as of December 31, 2024 and 2023 ranged from 4.25% to 10.50%. Principal and interest are generally repaid ratably through payroll deductions.

Participants should refer to the summary plan description for more information.

### **Note 3. Priorities upon Termination**

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

### **Note 4. Fair Value Measurements**

The *Fair Value Measurements and Disclosures* Topic of the Financial Accounting Standards Board Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value are described below:

#### Basis of Fair Value Measurement

Level 1	Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities
Level 2	Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly
Level 3	Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

The following tables set forth, by level within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. As required, assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. In accordance with generally accepted accounting principles, certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the following tables are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

#### Level 1 Measurements

The fair values of the mutual funds are determined by reference to the funds' underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value as of the last business day of each period presented.

#### Measurements Using Net Asset Value as a Practical Expedient

The common collective trust is valued at the net asset value per share, used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value.

The common collective trust is a direct filing entities (DFE) and files a Form 5500 annual report with the U.S. Department of Labor. The Plan is not required to disclose the significant investment strategies of DFE investments. Redemptions are available on a daily basis without notice.

## Note 5. Risks and Uncertainties

Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.

## Note 6. Information Prepared and Certified by Trustee

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution. The following summary of information as of December 31, 2024 and 2023, and for the years then ended, included in the accompanying financial statements was obtained from information that has been prepared and certified as complete and accurate by Fidelity Management Trust Company, the Trustee of the Plan:

## Note 7. Party-in-Interest Transactions

Certain Plan investments are mutual funds managed by affiliates of Fidelity Management Trust Company, the Trustee of the Plan. These investments and fees paid to Fidelity Management Trust Company and their affiliates qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

**Note 7. Party-in-Interest Transactions (continued)**

During the year ended December 31, 2024, the Plan inadvertently paid \$16,882 in legal fees that should have been paid by a party-in-interest, Pregis LLC. It was also discovered that \$7,519 in legal fees was inadvertently paid by the Plan during the year ended December 31, 2022 that should have been paid by Pregis LLC. Subsequent to December 31, 2024, Pregis LLC reimbursed the Plan for these payments. A receivable has been recorded in the accompanying financial statements for these amounts. The Plan sponsor and the Plan's legal counsel believe that there was no effect on the Plan's financial or tax status as a result of the transactions and subsequent correction.

**Note 8. Tax Status**

The Plan Administrator adopted a prototype plan created by Fidelity Management Trust Company. The Plan is not required to receive a determination letter directly from the Internal Revenue Service. However, the prototype plan has received a determination letter from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan determination letter has been relied upon by the Plan. The Plan Administrator and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Transfers of Net Assets**

In November 2023, net assets of \$2,410,476 were transferred into the Plan pursuant to a merger with Pregis Collectively Bargained Employees 401(k) Plan.

**Note 10. Reconciliation of Financial Statements to Form 5500**
